Consider treating your ash trees for emerald ash borer this spring

MADISON -- Emerald ash borer is currently the most damaging threat to trees in Wisconsin, according to state forest health specialist who say spring is the best time of year to take actions to protect ash trees.

What you should know? Woodpecker damage.

Know where the pest has been found and look for the signs and symptoms of infestation. "Many people notice a thinning ash canopy, but not until it is too late to effectively treat trees, so it is very important to examine your ash trees early and often," says Bill McNee, forest health specialist with the Wisconsin Department of Natural Resources. Spring is a great time to start. Watch ash trees for the following: woodpecker damage that looks like strips of bark are removed from an ash tree; sprouts or "sucker" branches growing from low on the trunk; a thinning canopy (fewer or dying leaves in the top part of the tree); very small (1/8-inch), D-shaped exit holes in the bark; bark splits and cracks, that might show evidence of the pest's tunnels behind them; and the emerald ash borer beetle itself.

What you should do? Sprouting.

If you see the signs or symptoms above, get more information or advice and then consider treating your ash tree. Spring is the best time to treat, but the decision to use insecticides is an important one that should not be taken lightly. "Know the facts about your tree's health and the various treatment options before investing in any treatments," says Dr. Chris Williamson, UW-Extension Entomology Specialist.

Remember, this pest only attacks ash trees, and mountain ash is not a true ash.

More information, including UW-Extension emerald ash borer factsheets labs.russell.wisc.edu/eab/ about treatment considerations are available at emeraldashborer.wi.gov. To get more advice, you can find a certified arborist in your area at the Wisconsin Arborist Association's website: www.waa-isa.org or in your yellow pages.

Consider the following when deciding whether or not to treat your ash tree

Research shows ash trees can be successfully protected from damage and death due to EAB, but not in all cases. Careful planning is required.

Tree value

D-shaped exit hole

Determine whether the ash tree is worth treating. Some ash trees are already heavily infested with EAB, too sick to effectively treat, or have major structural problems. Ash trees suffer from many health threats, so knowing as much as you can about the overall health of the tree is an important first step.

If your tree is healthy it may offer benefits such as increased property value, shade and cooling, and it may contribute to the quality of life in a neighborhood. Consider these benefits along with the cost of treatment. EAB threat to the tree

Currently, experts recommend that property owners consider treatment if their ash tree is within 15 miles of a known infestation. You can look up communities where EAB has been found at emeraldashborer.wi.gov.

Emerald ash borer. The cost of options

If EAB is a threat to your tree you can do nothing and take the risk that your tree will eventually die, you can treat your tree if it is still healthy enough, or you can take the tree down and remove it.

The cost of an insecticide treatment can depend on tree size and health condition.

The options for treatment require ongoing commitment. Almost all insecticide options require you to repeat treatment annually. One option called "Treeage" offers three years of protection but can only be applied by a licensed professional.

The cost of removing or replacing trees should also be weighed. You may be able to treat your tree for many years and spend less money than it would cost to remove that tree

Memorial Day History

Three years after the Civil War ended, on May 5, 1868, the head of an organization of Union veterans — the Grand Army of the Republic (GAR) — established Decoration Day as a time for the nation to decorate the graves of the war dead with flowers. Maj. Gen. John A. Logan declared that Decoration Day should be observed on May 30. It is believed that date was chosen because flowers would be in bloom all over the country.

The first large observance was held that year at Arlington National Cemetery, across the Potomac River from Washington, D.C.

The ceremonies centered around the mourning-draped veranda of the Arlington mansion, once the home of Gen. Robert E. Lee. Various Washington officials, including Gen. and Mrs. Ulysses S. Grant, presided over the ceremonies. After speeches, children from the Soldiers' and Sailors' Orphan Home and members of the GAR made their way through the cemetery, strewing flowers on both Union and Confederate graves, reciting prayers and singing hymns.

Local Observances Claim To Be First Local springtime tributes to the Civil War dead already had been held in various places. One of the first occurred in Columbus, Miss., April 25, 1866, when a group of women visited a cemetery to decorate the graves of Confederate soldiers who had fallen in battle at Shiloh. Nearby were the graves of Union soldiers, neglected because they were the enemy. Disturbed at the sight of the bare graves, the women placed some of their flowers on those graves, as well.

Today, cities in the North and the South claim to be the birthplace of Memorial Day in 1866. Both Macon and Columbus, Ga., claim the title, as well as Richmond, Va. The village of Boalsburg, Pa., claims it began there two years earlier. A stone in a Carbondale, Ill., cemetery carries the statement that the first Decoration Day ceremony took place there on April 29, 1866. Carbondale was the wartime home of Gen. Logan. Approximately 25 places have been named in connection with the origin of Memorial Day, many of them in the South where most of the war dead were buried.

Official Birthplace Declared In 1966, Congress and President Lyndon Johnson declared Waterloo, N.Y., the "birthplace" of Memorial Day. There, a ceremony on May 5, 1866, honored local veterans who had fought in the Civil War. Businesses closed and residents flew flags at half-staff. Supporters of Waterloo's claim say earlier observances in other places were either informal, not community-wide or one-time events.

By the end of the 19th century, Memorial Day ceremonies were being held on May 30 throughout the nation. State legislatures passed proclamations designating the day, and the Army and Navy adopted regulations for proper observance at their facilities.

It was not until after World War I, however, that the day was expanded to honor those who have died in all American wars. In 1971, Memorial Day was declared a national holiday by an act of Congress, though it is still often called Decoration Day. It was then also placed on the last Monday in May, as were some other federal holidays.

Some States Have Confederate Observances Many Southern states also have their own days for honoring the Confederate dead. Mississippi celebrates Confederate Memorial Day on the last Monday of April, Alabama on the fourth Monday of April, and Georgia on April 26. North and South Carolina observe it on May 10, Louisiana on June 3 and Tennessee calls that date Confederate Decoration Day. Texas celebrates Confederate Heroes Day January 19 and Virginia calls the last Monday in May Confederate Memorial Day.

Gen. Logan's order for his posts to decorate graves in 1868 "with the choicest flowers of springtime" urged: "We should guard their graves with sacred vigilance. ... Let pleasant paths invite the coming and going of reverent visitors and fond mourners. Let no neglect, no ravages of time, testify to the present or to the coming generations that we have forgotten as a people the cost of a free and undivided republic."

The crowd attending the first Memorial Day ceremony at Arlington National Cemetery was approximately the same size as those that attend today's observance, about 5,000 people. Then, as now, small American flags were placed on each grave — a tradition followed at many national cemeteries today. In recent years, the custom has grown in many families to decorate the graves of all departed loved ones.

The origins of special services to honor those who die in war can be found in antiquity. The Athenian leader Pericles offered a tribute to the fallen heroes of the Peloponnesian War over 24 centuries ago that could be applied today to the 1.1 million Americans who have died in the nation's wars: "Not only are they commemorated by columns and inscriptions, but there dwells also an unwritten memorial of them, graven not on stone but in the hearts of men."

To ensure the sacrifices of America's fallen heroes are never forgotten, in December 2000, the U.S. Congress passed and the president signed into law "The National Moment of Remembrance Act," P.L. 106-579, creating the White House Commission on the National Moment of Remembrance. The commission's charter is to "encourage the people of the United States to give something back to their country, which provides them so much freedom and opportunity" by encouraging and coordinating commemorations in the United States of Memorial Day and the National Moment of Remembrance.

The National Moment of Remembrance encourages all Americans to pause wherever they are at 3 p.m. local time on Memorial Day for a minute of silence to remember and honor those who have died in service to the nation. As Moment of Remembrance founder Carmella LaSpada states: "It's a way we can all help put the memorial back in Memorial Day."

EDUCATIONAL INFORMATION

The sources of drinking water, both tap water and bottled water includes rivers, lakes, streams, ponds, reservoirs, springs and wells. As water travels over the surface of the land or through the ground, it dissolves naturally occurring minerals and, in some cases, radioactive material, and can pick up substances resulting from the presence of animals or from human activity.

Contaminants that may be present in source water include:

- Microbial contaminants, such as viruses and bacteria, which may come from sewage treatment plants, septic systems, agricultural livestock operations and wildlife.
- Inorganic contaminants, such as salts and metals, which can be naturally occurring or result from urban storm water runoff, industrial or domestic wastewater discharges, oil and gas production, mining or farming.
- Pesticides and herbicides, which may come from a variety of sources such as agriculture, urban storm water runoff and residential uses.
- Organic chemical contaminants, including synthetic and volatile organic chemicals, which are by-products of industrial processes and petroleum production, and can also come from gas stations, urban storm water runoff and septic systems.

In order to ensure that tap water is safe to drink, EPA prescribes regulations that limit the amount of certain contaminants in water provided by public water systems. FDA regulations establish limits for contaminants in bottled water, which shall provide the same protection for public health.

Avoiding winterkill Keeping fish alive during the harshest season.

On a clear, cold mid-winter morning Brian Spangler, DNR fisheries technician and a crew of DNR workers and Chetek Lakes Protection Association volunteers trudge across frozen Prairie Lake on the 20th annual rescue mission to install aerators and create open water before oxygen levels plummet to the point that fish suffocate under the ice.

"Some lakes, well, you just know are going to winterkill," said Spangler as augers and chainsaws cut into six inches of ice and ATVs pulled three, 3-horsepower, 230-volt surface aspirating aerators into place.

"Smaller, shallow, fertile lakes create the perfect storm for winter fish kills," Spangler said.

Prairie Lake, which has been aerated since 1992, is one of them. It is part of the Chetek Lakes Chain, a 3,764-acre impoundment fed by a large, mostly agricultural watershed, which forms the headwaters of the Chetek River in northwest Wisconsin. The 1,619-acre lake is the largest in the chain, whose depths range from 12 to 22 feet.

"What we are doing here today will add oxygen to the water all winter and help prevent winterkill of fish and other organisms," Spangler said.

Winterkill is a natural process occurring when fish don't have enough oxygen. In ice capped winters, most of this oxygen comes from aquatic plants. However, when the ice and snow cover is thick, plants cannot get the sunlight needed, and instead of producing oxygen, die and decompose.

Fish kills follow. How many and how fast depends on the depth of the lake and the types of fish it contains.

Trout require the most oxygen, followed by bluegill, largemouth bass and walleye, according to DNR fisheries managers. Crappies, carp, northern pike and yellow perch can tolerate less oxygen. Bullheads and fathead minnows require the least amount of oxygen to survive.

Statewide, the Department of Natural Resources works with, and grants permits annually to cities, lake associations, park districts and similar groups to install and maintain aerators on some lakes.

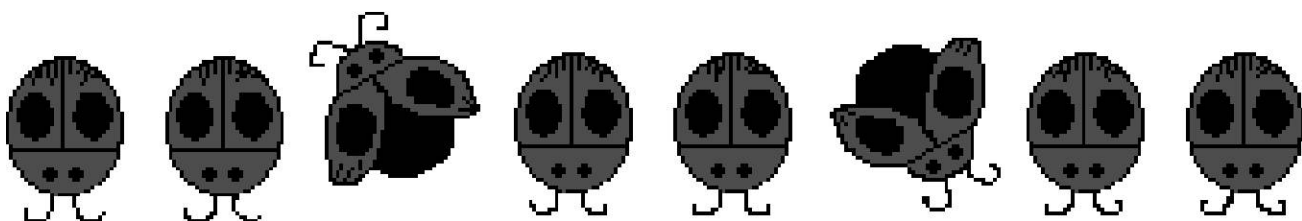
Increased pressure on large, recreational lakes has also had a domino effect, Spangler said. Because of it, more people have looked to "marginal" lakes for their cabin and fishing pleasure.

Aeration improves the quality of life on and around those lakes. Since it began in the northwest region in 1977, aeration has successfully been done on 19 lakes in Barron and Polk counties, totaling more than 3,000 acres.

"It's a big thing we do to increase angling opportunities and improve recreational opportunities," Spangler said. "Aeration has greatly reduced or eliminated winterkill and improved the sport fishing opportunities."

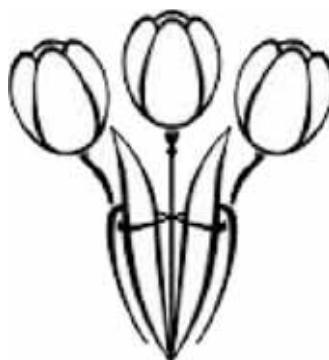

Salt-Free Herb Blends

Enhance the flavor of food with salt-free herb and spice combinations. To make 1/2 cup, combine the ingredients in a jar. Cover tightly and shake. Keep in a dark, cool, dry place. Then rub and sprinkle them on food for flavor. (Tip: they make great hospitality gifts!)

Chinese five-spice...for chicken, fish or pork: Blend 1/4 cup of ground ginger, 2 tablespoons of ground cinnamon, 1 tablespoon each of ground allspice and anise seeds, and 2 teaspoons of ground cloves.

Mixed herb blend...for salads, pasta salads, steamed vegetables, vegetable soup or fish: Blend 1/4 cup of dried parsley flakes, 2 tablespoons of dried tarragon, and 1 tablespoon of each dried oregano, dill weed, and celery seeds.

Curry blend...for rice, lentil, and vegetable dishes and chicken: Blend 2 tablespoons each of turmeric and ground coriander, 1 tablespoon of ground cumin, 2 teaspoons each of ground cardamom, ground ginger, and black pepper, and 1 teaspoon each of powdered cloves, cinnamon and ground nutmeg.

Italian blend...for tomato-based soups and pasta dishes, chicken, pizza, focaccia, and herbed bread: Blend 2 tablespoons each of dried basil and dried marjoram, 1 tablespoon each of garlic powder and dried oregano, and 2 teaspoons each of thyme, crushed dried rosemary and crushed red pepper.

Mexican chili blend...for chili with beans, enchiladas, tacos, fajitas, chicken, pork and beef: Blend 1/4 cup of chili powder, 1 tablespoon each of ground cumin and onion powder, 1 teaspoon each of dried oregano, garlic powder, and ground red pepper, and 1/2 teaspoon of cinnamon.

Greek blend...for seafood, poultry, and herbed bread: Blend 3 tablespoons each of garlic powder and dried lemon peel, 2 tablespoons of dried oregano, and 1 teaspoon of black pepper.

Easy dip blend...for mixing with cottage cheese, or low-fat sour cream, also nice on chicken and fish: Blend 1/4 cup of dried dill weed and 1 tablespoon each of dried chives, garlic powder, dried lemon peel, and dried parsley.

Homemade salt substitute...: Blend 1 tablespoon each of garlic powder, paprika, and dry mustard, 5 teaspoons of onion powder, 1 teaspoon of thyme, and 1/2 teaspoon each of white pepper and celery seed.

This holiday, remember to get your firewood where you burn it

MADISON - State forest health specialists remind campers and travelers that firewood can carry harmful forest insects and diseases. "Insect pests such as emerald ash borer and gypsy moth, and diseases like oak wilt and Dutch elm disease spread to new areas easily while hidden in firewood," said Colleen Robinson Klug, DNR forest health educator. "These invasive species have already killed millions of trees in Wisconsin."

All travelers should follow quarantine rules to help protect Wisconsin's trees and avoid fines.

Second homeowners are advised not to move firewood long distances between their properties, to reduce the risk to their trees.

The only exception is firewood Certified by the Wisconsin Department of Agriculture, Trade and Consumer Protection (exit DNR). Certified wood is free to move around the state because it is also free of invasive pests and diseases that harm our trees. Certified wood will either have a label like the one in the photo, or will just have the DATCP certified vendor number. A list of certified dealers and their ID numbers is available online at emeraldashborer.wi.gov under "Firewood Regulations".

Firewood regulations tighten as of June 1, 2014

The invasive species threat to public land we all share in Wisconsin is increasing. To help protect these areas better, after June 1 firewood will only be allowed on state managed properties if it is:

from within 10 miles of the property, AND

from outside an area quarantined for emerald ash borer, (unless the property is also in the same or a connected quarantined area) OR

certified by the Wisconsin Department of Agriculture, Trade and Consumer Protection (see link above) or certified by the USDA as treated to emerald ash borer standards.

Most state parks and forests have certified firewood or firewood from the property for sale on site. To check availability, contact the property by searching the DNR website dnr.wi.gov for "parks." Many federal, county and private campgrounds also restrict firewood on their properties. Call for details before you travel.

For more details about firewood in Wisconsin search the DNR website dnr.wi.gov for keyword "firewood" or call 1-877-303-WOOD (9663).

May is Lyme Disease Awareness Month

Lyme disease is a bacterial disease transmitted to humans by an infected tick commonly known as the black-legged or deer tick. According to the Wisconsin Department of Health Services, the disease was first recognized in the United States in 1975 in Lyme, Connecticut.

Signs and symptoms generally set in after 3-30 days and commonly include a fever, headache, fatigue, and a circular skin rash called erythema migrans ("EM"). If left untreated, the infection may spread to other parts of the body producing symptoms that include: additional EM lesions, facial or Bell's palsy, severe headaches and neck stiffness, pain and swelling in large joints, fatigue, cognitive decline, shooting pains, and heart palpitations.

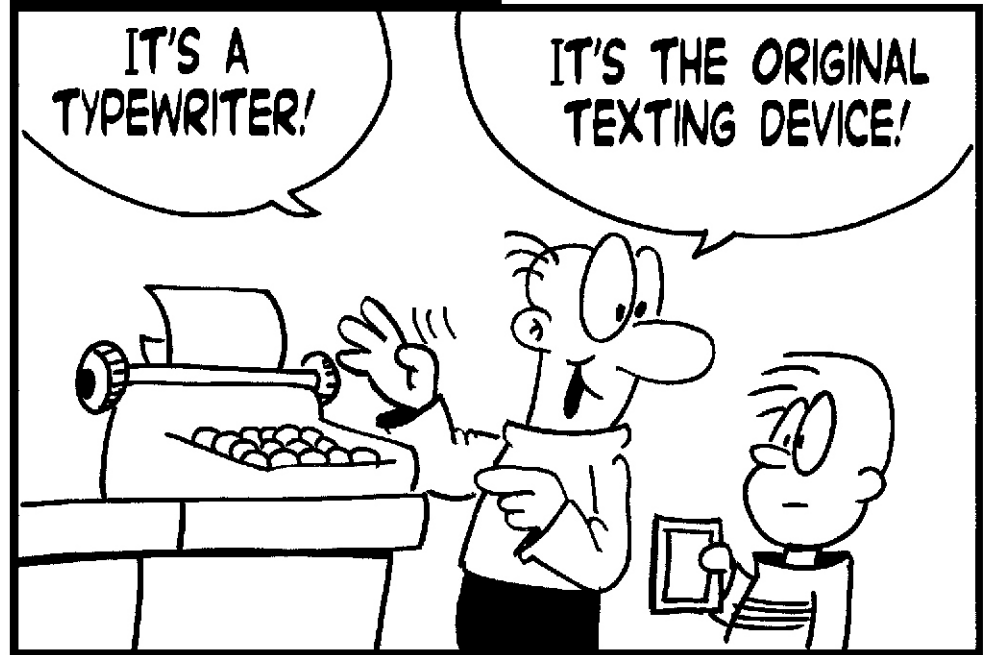
Although Lyme disease is often difficult to diagnose the disease can be treated successfully with antibiotics if it is detected early. The best ways to prevent Lyme disease are to avoid wooded and bushy areas with high grass, use repellants with 20 to 30 percent DEET, wear light-colored clothing to cover exposed skin, and check skin thoroughly after being in areas where ticks may be present.

According to the Centers for Disease Control and Prevention, in 2012 nearly 95 percent of the over 30,000 Lyme disease cases in the United States were reported from only 13 states with over 1,700 of them reported from the state of Wisconsin. It is important to raise public awareness of Lyme disease causes, effects, and treatments; and to emphasize important education and research efforts surrounding Lyme disease and other tick-borne diseases. 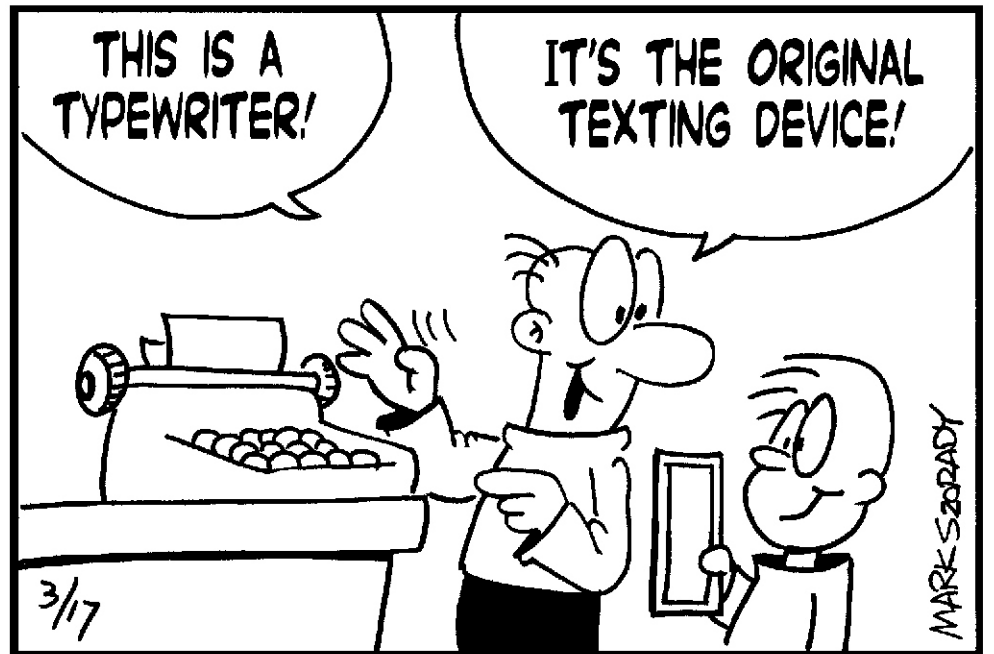

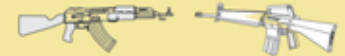
