Public Informational Meeting on ORV park on June 2nd

The latest step in the ongoing saga of the proposed off-road vehicle park (ORV) in Forest County will take place on Tuesday, June 2, 2015, from 6:00 p.m. until 7:00 p.m. in the county board room of the Forest County courthouse. This will be a public informational meeting held by the Forest County Forestry and Recreation Committee to accept public comment on the proposed changes to the County Forest 15-year comprehensive land use plan. The accepted modification of the plan is designed to allow a motorized recreation area on county forest land.

The next step in changing the land-use plan is to bring it before the full county board at the June 16th meeting. If the full county board approves the plan, it will then be sent to the DNR for review and will either be accepted or not accepted. If the DNR does not accept any or all of the changes, the document will be sent back to Forest County. Then, the county can decide to continue with the modifications or not.

What if the DNR accepts the changes? Then, if the county decides to go ahead with the ORV, the DNR will decide if the proposed construction and use of the land is consistent with current state law governing county forests.

Will such a project pass muster with the DNR? It would appear that existing law for county forest use would not allow such an activity. After listening to Joe Schwantes, the DNR employee who works with land use, no, it would not. Charging the public to use land they own wouldn't be an option. Then again, the law could be changed at the state level.

The last few years, there have been efforts to pass a bill through the state legislature that would allow for some use by ORV's on county forest land, and charge a registration fee that would be used for trail maintenance, much like snowmobile trails. In a call to Rep. Jeff Mursau, he said the bill was being reintroduced, but wasn't sure of the wording of the bill, and didn't think that it would allow a for-pay park on county forest lands, but wasn't sure.

What would be the ramifications if a bill like this would pass the legislature and make it through the governor's office?

It could mean that 4x4 vehicles and ATV and UTV vehicles could have a trail system that could pass through county land. It is also likely that the users of such a trail would have to comply with the same rules that loggers have to live by, namely rutting of the ground. It could also mean that land might not have to be purchased for the proposed park, if allowed, but could operate on existing county lands, of which about 92% are in the Town of Lincoln.

Whatever the outcome of possible future legislation, the public should take part in the June 2nd hearing. Standing up and giving your opinion, whichever side of this issue you are on, is important. To be sure, the off-road crowd, non-residents or otherwise, will be there to push for a place to recreate on our county lands.

Ruffed Grouse Society petitions U.S. Forest Service to sustain young forest habitat

RGS has filed a legal challenge to compel the Forest Service to follow the law.

Coraopolis, PA – The Ruffed Grouse Society (RGS) has filed a Petition for Rulemaking with the U.S. Department of Agriculture and the U.S. Forest Service (Forest Service) due to the agency's consistent failure to provide the young forest habitats required by the ruffed grouse, American woodcock, golden-winged warbler and other game and nongame wildlife on national forests throughout the eastern United States.

"The failure of national forests in Regions 8 and 9 to meet even their own minimum goals for young forest habitats has contributed to substantial declines in the populations of game and nongame wildlife that depend upon these habitats," said RGS President and CEO John Eichinger. According to Ryan Woody, an attorney representing RGS on the Petition from the firm of Matthiesen, Wickert and Lehrer, S.C., "The failure of the U.S. Forest Service to sustain young forest habitats sufficient to support viable populations of ruffed grouse and other wildlife that require these habitats on the Chattahoochee (GA), Hoosier (IN) and Sumter (SC) National Forests is a clear violation of regulations

**Volunteers needed to protect
Crandon from Garlic Mustard**

Join the Wild Rivers Invasive Species Coalition (WRISC) as we battle the invasive plant Garlic Mustard. Garlic Mustard is a dangerous invasive species that can severely impact forested areas. Plants can produce thousands of seeds, spread rapidly, shade out understory plants, and prevent tree seedlings from growing. With only a few garlic mustard infestations in Forest County, controlling known locations helps to prevent it from spreading throughout our forests.

This volunteer workday will take place on Friday May 22 from 1:00pm to 4:00pm at the Crandon Rifle Range. To get there, take Hwy 8 east and turn north onto Bear Rd, the road dead ends at the rifle range where volunteers will meet. Volunteers will spend the afternoon hand pulling plants before they can spread seed. Sturdy shoes and long pants are recommended, as well as work gloves and a water bottle. WRISC will have extra gloves, water, and snacks available.

WRISC Coordinator Emily Anderson is hoping to see continued community support for the project, which began last year. The group in 2014 included citizens, high school students, and representatives from the Forest Service, DNR, County, Potawatomi Community, and Lumberjack RC&D, with help from the Town to dispose of pulled plants. "Last year was a huge show of support," said Anderson. "It was great to so many different individuals and organizations working to keep this invasive from spreading."

NOTICE IS HEREBY GIVEN that the Board of Review for the Town of Laona of Forest County Shall hold its meeting on Tuesday the 9th day of June 2015, from 6:00p.m. to 8:00p.m at the Laona Town Hall 5146 Linden Street, Laona WI.

Please be advised of the following requirements to appear before the Board of Review and procedural requirements of appearing before the Board:

No person shall be allowed to appear before the Board of Review, to testify to the Board by telephone or to contest the amount of any assessment of real or personal property if the person has refused a reasonable written request by certified mail of the Assessor to view such property.

After the first meeting of the Board of Review and before the Board's final adjournment, no person who is scheduled to appear before the Board of Review may contact, or provide information to, a member of the Board about the person's objection except at a session of the Board.

No person may appear before the Board of Review, testify to the Board by telephone or contest the amount of assessment unless, at least 48 hours before the first meeting of the Board or at least 48 hours before the objection is heard if the objection is allowed because the person has been granted a waiver of the 48-hour notice of an intent to file a written objection by appearing before the Board during the first two hours of the meeting and showing good cause for failure to meet the 48-hour notice requirement and files a written objection, that the person provides to the Clerk of the Board of Review notice as to where the person will ask for removal of any Board members and, if so, which member will be removed and the person's reasonable estimate of the length of time the hearing will take.

When appearing before the Board, the person shall specify, in writing, the person's estimate of value of the land and of the improvements that are the subject of the person's objection and specify the information that the person used to arrive at the estimate.

No person may appear before the Board of Review, testify to the Board by telephone of subject or object to a valuation; if the valuation was made by the Assessor or the Objector using the income method; unless the person supplies the Assessor all of the information about income and expenses, as specified in the manual under Sec. 73.03(2a) that the Assessor requests. The Town of Laona has an ordinance for the confidentiality of information about income and expenses that is provided to the Assessor under this paragraph which provided exemptions for persons using information in the discharge of duties imposed by law or of the duties of their office or by order of a court. The information that is provided under this paragraph, unless a court determined that is inaccurate is not subject to the right of inspection and copying under Section 19.35(1) of Wis. Statutes.

Farmland Preservation Advisory Committee meets

On Thursday April 30th the Farmland Preservation Advisory Committee Consisting of John Harter, Janet Dykowski, Karl Tauer, Bob Nelson, Ed McKeage, Gerald Meadow and Tanis Bocek held its second meeting in conjunction with the Forest County Land Conservation Committee. The Forest County Farmland Preservation Advisory Committee is facilitating with the North Central Wisconsin Regional Planning Commission (NCWRPC) to complete the Farmland Preservation Plan.

The Advisory Committee has begun to shape and create the Farmland Preservation Plan to fit our county profile. The Goals, Objectives and Policies discussed during the meeting are listed below.

Goals:

- ** • Preserve forest and open crop farmland for the widest possible range of uses as appropriate for Forest County soils and landscape.
- ** • Protect the economic viability of forest and open croup farmland.
- ** • Promote positive soil health.
- ** • Promote agro-tourism in its many forms.

Objectives:

- ** • Curtail the conversions of open farmland to forested farmland.
- ** • Educate forested farmland owners to agroforestry and multiple use forestlands.
- ** • Promote value added forest product occupations or employment.
- ** • Educate the public on agro-tourism.

Policies:

- ** • Support policies in the 2016 Forest County land and water resources plan that compliment and support this updated farmland preservation plan.
- ** • Promote agroforestry as a value added land use
- ** • Promote non-animal micro farming operations as a complimentary or supplementary use in rural residential areas.

** • Identify funding opportunities for agricultural related uses.

** • Work with local governments to encourage value added agricultural/Forestry resources.

We will continue to take any recommendations concerning goals, objectives and policies until the final draft. As the development of the farmland preservation plan is still underway and these are not finalized yet. Please visit North Central Wisconsin Regional Planning Commission website at <http://www.ncwrpc.org/> for a draft of the Forest County Farmland Preservation Plan. We will continue to update the public as progress is made.

Ruffed Grouse Society Cont. from pg. 1 promulgated under the National Forest Management Act."

On other national forests in the east, wildlife populations that thrive only in young forests continue to decline. For example, the Wayne National Forest in Ohio has established only 2 percent of the young forest acreage identified as a minimum goal in its forest plan. The Jefferson National Forest in Virginia has established only 12 percent of the young forest acreage identified as a minimum goal, while the Cherokee National Forest in Tennessee has established only 13 percent.

"From the heart of ruffed grouse country in the Great Lakes region, to the historic covers of New England and the hills of the Appalachians, ruffed grouse and other wildlife of young forests have been poorly served by the Forest Service. RGS takes this step reluctantly, but has little alternative due to the Forest Service's lack of response to our repeated efforts to work collaboratively," continued Eichinger. "These deficiencies indicate a systemic problem that demands the attention of our most senior officials within the Forest Service."

"Wisconsin Flying Trees in World War II" & Keynote Speaker at WSDAR State Conference

Women gathered from around Wisconsin in Madison to celebrate the accomplishments and yearly projects of the Wisconsin Society Daughters of the American Revolution. As Keynote Speaker for the WSDAR State Conference Banquet, Sara Witter Connor, author of "Wisconsin Flying Trees in World War II: A Victory for American Forest Products and Allied Aviation," spoke of Wisconsin's unique story of the Greatest Generation.

Ms. Connor opened her remarks with a question, "Why would Sir Geoffrey DeHavilland, Henry Kaiser, and Howard Hughes come to the small communities in Central and Northern Wisconsin? Wisconsin and the Great Lakes States contribution through the forest products industry is an unheralded story. The civilian side is largely unknown. Without Central and Northern communities, the famous DeHavilland "Mosquito" and Troop Carrier Gliders made of Wisconsin wood would not have flown. Even Henry Kaiser's Liberty Ships and Victory Ships had Wisconsin forest products. Howard Hughes' "Spruce Goose," which he began to build during WWII in 1942 and finally flew in 1947 is not spruce. It is Wisconsin yellow birch. Howard Hughes fired anyone who called the Flying Boat, the "Spruce Goose."

Many WSDAR women had families that worked in the forest products industry during WWII. One said to Ms. Connor, "My father worked for Penokee Veneer Co. in Mellen and in the Upper Peninsula of Michigan. He said that he worked for 37 cents an hour and supported 11 of my brothers and sisters." In today's value, that is \$4.99 per hour. The wages were based on 1932 Great Depression prices because of the Office of Price Administration restrictions.

In telling the story of the two WWII Glider Pilot Training Schools in Wisconsin, another WSDAR said, "I remember the glider training in Antigo. Planes were flying all of the time and I would see them up in the sky." The planes that were used were small single engine aircraft. Flying the CG-4A Troop Carrier Gliders did not come until after the initial training in Wisconsin.

The U.S. Forest Products Laboratory in Madison is also part of the story of government and industry shared partnership during WWII. Ms. Connor said, "War brings technological innovation. Product development and shared technology resulted in what we call today the beginning of the Modern Logging Era."
