WOHVA trail system in cooperation with the Sokaogon Chippewa

Wisconsin Off-Highway Vehicle Association (WOHVA) and the Sokaogon Chippewa Tribal Council have worked together to allow us to have access to their forestry land for our trail system to accommodate off highway vehicles like Jeeps and trucks. The trails are built and maintained explicitly by volunteers under the direction of John Lewins, who is the trails coordinator and liaison to the tribal community/ forester - WOHVA relationship chair person. John has extensive training in trail building, maintenance, and land sustainability from the National Off-Highway Vehicle Conservation Organization, and also has training in recreational leadership training, and volunteer leadership and land use from the Blue Ribbon Coalition.

This training helps John train and lead volunteers to build and maintain trails to keep them sustainably structured. Also, as Local Area Coordinator for Jeep Jamboree USA, John oversees and trains 16 trail guides for the Great Northern Trail Ride for WOHVA.

John says, "We spend nine weeks every summer to work on building and maintaining trails to accommodate the two events each summer of family off-road adventures, such as Jeep Jamboree USA, which is the 3rd weekend of July and Great Northern Trail Ride, which is the 3rd weekend of August."

Jeep Jamboree USA is a family oriented off road adventure guided trail ride in a rustic forest setting. The trail rides promote responsible tread-lightly operation on the six levels of difficulty along with sustainability to environment.

The trails are as follows, for beginners the 101 course, which trains participants to traverse over various obstacles such as rocks, logs and off-camber traversing. After completing the course the participants take on the trails appropriate to stock Jeeps.

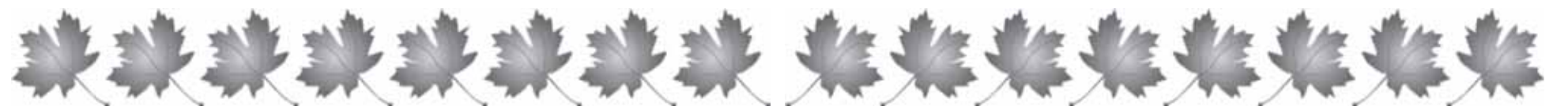

Baladino to bring Mediterranean folk music to Nicolet College Oct. 2



It's not every day – or even every decade – that one gets to experience live in the Northwoods the rich sound of modern Mediterranean folk music with roots that go back centuries.

Just such an opportunity will present itself at Nicolet College Friday, October 2, when the Israeli ensemble Baladino takes to the stage for a special performance at 7:30 p.m.

The five-member band plays a style of music known as a Ladino, which was created in the late 15th century when Jews were expelled from Spain and dispersed throughout the Mediterranean region.

"Ladino music is an immigrant music," said Yonnie Dror, one of the group's founding members. "Its story is one of Jewish people who were expelled from Spain and spread throughout the Mediterranean. With them they carried their language, which is basically medieval Spanish. As Ladino Jews moved and founded new communities from North Africa to Greece and Turkey, their songs took on local color."

With roots to the past, Baladino is noted internationally for its ability to bring a fresh and innovative take on this traditional style of music, incorporating a Gypsy groove while embracing rock and electronic influences, said Nicolet College Theatre Director Jim Nuttall.

"They bring this modern twist to a style of music that has been popular in the Mediterranean region for generations," Nuttall noted. "Their level of musicianship, from exquisite vocals to the mastery they have of their many instruments, is nothing short of stunning."

Tickets are \$15 and can be purchased online at nicoletlive.com or by calling (715) 365-4646.

The performance at Nicolet is made possible through a partnership with Arts Midwest World Fest, which arranges week-long residencies for international music ensembles in small Midwest communities.

Along with the public performance at Nicolet, Baladino will also hold 11 workshops and performances at numerous K-12 schools throughout the Nicolet District. More than 4,200 students are anticipated to participate in these events.

"It's not often smaller communities like ours have the chance to host international ensembles like Baladino, let alone for a full week," Nuttall added. "The music and culture Baladino shares will be absolutely fascinating and different from what we typically hear. We expect this residency will be a delightful experience for everyone."

Baladino is one of four international ensembles that will visit the Northwoods under Nicolet's two-year partnership with Arts Midwest. In January, the progressive French folk group Le Vent du Nord will be in the area for a similar number of performances and workshops. The 2016-17 line-up will be announced at a later date.

Finding a Deal Instead of a Steal

Discount prescription drug cards - you have probably received them in the mail before and felt happy at the thought of a little savings at the prescription counter. Although discount prescription drug cards that offer real savings do exist, use caution before using any discount card. Reading fine print and asking a few questions can go a long way in determining whether the discount card you received is a potential scam. If a card requires you to pay a fee prior to using the card, it may be a scam as discount cards are generally free. Inspect what the card is offering. If it says it will replace your insurance or Medicare, then it is probably a scam. In addition to looking for fees and offers, review who is requesting these fees and making these offers. Figuring out who is behind the card can provide great insight to whether the card is safe to use. For example, some Wisconsin counties such as Brown, Rock, Kenosha, and Sauk, now offer a discount prescription drug card through the National Association of Counties (NACo).

After you determine whether a discount card is safe to use, keep reading the small print. Look for information about who is eligible to use the card, or where the card may be used. A card may only be used by individuals under 65, associated with a specific pharmacy, or limited to purchases of prescription drugs not covered by insurance.

One note about prescription drug discount cards generally: you may face some difficulty shopping for the best deal on your prescriptions using discount cards. Some pharmacies may require you to go into the pharmacy with the discount card and won't give you pricing over the phone. Other pharmacies may require you to fill the prescription prior to receiving the price of the prescription with the discount. Like researching discount cards to find out if they are safe to use, you may also have to do some leg-work to determine where you can receive the best deal on your prescriptions with discount cards.

Stepping back from the discount prescription drug cards you receive in the mail, other options exist. Stores like Walgreens, Target, Wal-Mart, and ShopKo offer discount cards, though each store varies in whether it charges for the discount card. These store cards may offer you a lower price on generics or 90-day prescriptions. In addition to store pharmacy discount cards, you can also search for discounts on specific brands of prescription drugs. There are a variety of ways you may be able to save money on your prescription drugs. To ensure that your personal information is safe, research discount cards and coupons and do not hesitate to contact a trusted pharmacist or health professional if you have questions.

Medicare and Marketplace Insurance FAQ

What is Medicare?

Medicare is a federal health insurance program for individuals 65 and older. There are four parts to Medicare: A, B, C and D. Medicare Part A covers hospital inpatient care, and people obtain Medicare Part A for free. However, if individuals have not worked 40 work quarters or contributed to Medicare for at least ten years, they will have to pay a premium for Medicare Part A. Medicare can also be obtained if the individual is under 65 years of age. This may happen for a few reasons, but mainly if the individual has received Society Security Disability Income for 24 months, or has end-stage renal disease, they can enroll in Medicare.

What is Marketplace Health Insurance?

The term "Marketplace Health Insurance" is used to describe the assortment of plans that are offered on the health insurance exchange. To help visualize the concept, think of the Marketplace as an actual marketplace where vendors - insurance agencies - go to set up shop and sell their wares - Qualified Health Plans.

Qualified Health Plans are plans that comply with the standards set out in the Affordable Care Act and have the Marketplace's permission to be sold in conjunction with a subsidy for low-income individuals. Subsidies are federal dollars that are paid to decrease the costs of a consumer's monthly premium and out-of-pocket costs (deductible, coinsurance, copays, etc.).

Should I have both Marketplace Health Insurance and Medicare at the same time?

No. Marketplace plans, employer plans and other regular health insurance plans are not meant to supplement Medicare plans. There are separate Medigap plans that act as wrap-around support that can be purchased by Medicare enrollees if more coverage is needed. In addition, the Marketplace subsidies must be paid back if the individual is enrolled in Medicare concurrently with a Marketplace plan.

What happens if I age into Medicare while I have Marketplace plan?

Adults that age into Medicare, upon turning 65, may run into problems if they still have a Marketplace plan when their Medicare Part A coverage begins. The Marketplace will not automatically disenroll someone who gains coverage under Medicare Part A.

Individuals who are losing their Marketplace subsidies, as a result of gaining Medicare Part A coverage, should call the Marketplace and request to be disenrolled from their plan. Early disenrollment requests must be made at least fourteen days in advance of

the requested date of disenrollment. If this is not done, an individual will lose their subsidies, and must pay the full cost of their plan premium for the months that they were covered by both Medicare and the Marketplace.

Can I choose a Marketplace plan over Medicare?

Individuals eligible for Medicare will typically receive comprehensive coverage at a lower cost than those with Marketplace insurance. However, if an individual does not have enough work quarters to receive Medicare Part A without a premium, then he/she may choose to have a subsidized Marketplace plan over Medicare. If the individual is not required to pay a Part A premium, then he/she will not qualify for subsidies on the Marketplace.

If an individual is required to pay a premium for Medicare Part A and wants a Marketplace plan instead of Medicare, there are major concerns they must first consider. Medicare Part B and D both have penalties for individuals that do not enroll when they are first eligible. The penalties are below:

- Medicare Part B Penalty: There is no penalty if Medicare Part B is delayed through enrollment in either the enrollee's or a spouse's, active employer health insurance plan. Enrollment delays other than through an employer's health insurance will be assessed a 10% penalty for each 12 month period that the enrollee is not enrolled in Medicare Part B.

- Medicare Part D Penalty: If Medicare Part D is delayed, and the individual does not have creditable drug coverage, there is a 1% penalty for each uncovered month, multiplied by \$33.13 a month (in 2015). This applies for every continuous 63 day period that the enrollee is not enrolled in Medicare Part D.

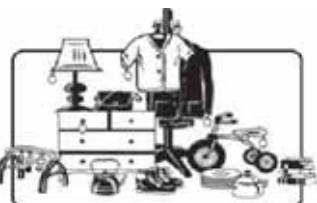
If I have Medicare, can I keep my dental coverage that came with my Marketplace plan?

No. Dental plans are typically only available on the Marketplace with enrollment into a health insurance plan. If the dental plan is separate from the Marketplace plan, it is a stand-alone dental plan that can be obtained either on or off of the Marketplace. Marketplace rules, and subsidies, do not apply to dental plans.

Some Medicare Advantage plans may cover services not covered by original Medicare. These services may include: routine dental, routine vision, and prescription drug coverage. A stand-alone dental plan may also be purchased if a Medicare Advantage Plan does not provide the needed coverage.

If I am eligible to enroll in Medicare prior to age 65, should I enroll in the Marketplace instead?

The same rules apply when obtaining Medicare early. Medicare coverage is the wiser choice, and the Marketplace will typically not allow subsidies if an individual is also eligible for Medicare.

There were students from each school in each group, so they got acquainted with each other throughout the day. The weather was perfect and everyone had a great educational experience.

level Jeeps with stock tires and no modifications to traverse over low level land obstacles. The third level is the Blue trail which has more up-graded levels of difficulty on trails, including off-camber hill traversing with tighter turning radiuses to challenge participants.

The fourth level is the Red trail which requires larger than stock tires, suspension lift up grades for more articulation, and rear differential lockers to help climb various rock areas.

The fifth level is the Orange trail which requires 33" tires or bigger, lockers front and rear and a winch recommended for traversing through the various tight areas and off camber through hills and rock garden areas.

The last level is Orange 2 trail, which is the highest level of difficulty, requires 33"-37" tires, lockers front and rear, and a winch. The trails consist of large rock garden areas, steep off-camber traversing with the tightest turning radiuses between trees without damaging the trees.

Maintenance includes providing water bars on hill sides in order to prevent water erosion. All other traveled areas that are exposed are seeded with grass seed to keep land sustainable with minimal change to forest land. Sustainability and keeping area open to the logging practices of forestry land is the goal.

Sustainability is a major factor in keeping land use relationship with the Sokaogon Chippewa tribal community council and WOHVA.

In closing, all this training and participation in all my positions help me in providing the best family oriented off-road experience for all of our participants, volunteers and community, with low impact on the forest lands.

Dead crow found in the area with West Nile Virus

The Forest County Health Department reports a dead crow found in Forest County on 08/28/15 has tested positive for West Nile Virus. This is the first bird that tested positive for West Nile virus in Forest County since surveillance for the mosquito-transmitted virus began May 1, 2015.

Jill Krueger, Forest County Health Officer stated, "The positive bird means that residents of Forest County need to be more vigilant in their personal protective measures to prevent mosquito bites. Forest County residents should be aware of West Nile virus and take some simple steps to protect themselves against mosquito bites. The virus seems to be here to stay, so the best way to avoid the disease is to reduce exposure to and eliminate breeding grounds for mosquitoes."

West Nile virus is spread to humans through the bite of an infected mosquito. Mosquitoes acquire the virus by feeding on infected birds.

The Forest County Health Department recommends the following:

- ** Limit time spent outside at dawn and dusk, when mosquitoes are most active.
- ** Apply insect repellent to clothing as well as exposed skin since mosquitoes may bite through clothing.
- ** Make sure window and door screens are in good repair to prevent mosquito entry.
- ** Properly dispose of items that hold water, such as tin cans, plastic containers, ceramic pots, or discarded tires.
- ** Clean roof gutters and downspouts for proper drainage.
- ** Turn over wheelbarrows, wading pools, boats, and canoes when not in use.
- ** Change the water in birdbaths and pet dishes at least every three days.
- ** Clean and chlorinate swimming pools, outdoor saunas, and hot tubs; drain water from pool covers.

- ** Trim tall grass, weeds, and vines since mosquitoes use these areas to rest during hot daylight hours.
- ** Landscape to prevent water from pooling in low-lying areas.

The majority of people (80%) who are infected with West Nile virus do not get sick. Those who become ill usually experience mild symptoms such as fever, headache, muscle ache, rash, and fatigue. Less than 1% of people infected with the virus get seriously ill with symptoms that include high fever, muscle weakness, stiff neck, disorientation, mental confusion, tremors, confusion, paralysis, and coma. Older adults and those with compromised immune systems are at greater risk of developing central nervous system illness that can be fatal.

The Department of Health Services has monitored the spread of West Nile virus since 2001 among wild birds, horses, mosquitoes, and people. During 2002, the state documented its first human infection and 52 cases were reported that year. During 2014, 6 cases of West Nile virus infection were reported among Wisconsin residents. Human West Nile Virus infections have been reported from June through October; with most becoming ill during August and September.

The Wisconsin Division of Public Health will continue surveillance for West Nile virus until the end of the mosquito season. To report a sick or dead crow, blue jay, or raven, please call the Dead Bird Reporting Hotline at 1-800-433-1610.

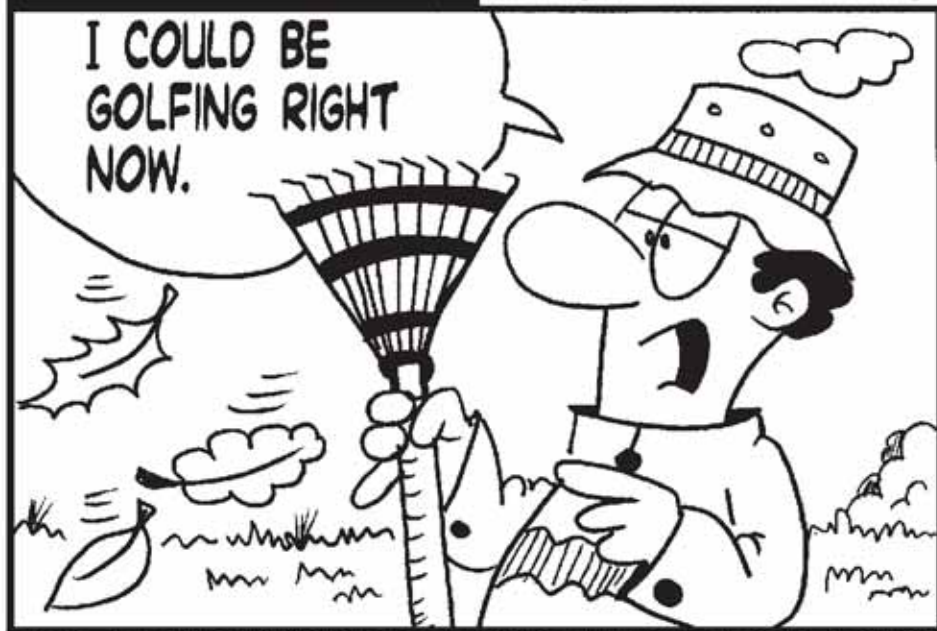

Changes proposed to hospice benefits

The Medicare Payment Advisory Commission believes that Medicare is double-paying for beneficiaries' care.

In the Kaiser Health News article "Officials Weigh Options to Hold Down Medicare Costs for Hospice," the author explains that "Medicare pays a set amount to the hospice provider for all treatment and services related to the terminal illness. ... If a patient needs treatment that hospice doesn't provide because it is not related to the terminal illness -- or the patient seeks care outside of hospice -- Medicare pays the non-hospice providers. The problem is that sometimes Medicare pays for care outside the hospice benefit that it already paid hospice to cover." For example, the Department of Health and Human Services' Office of the Inspector General believes that, in 2009, prescription drug plan received more than \$33 million that probably should have been covered by hospice benefits.

To avoid duplicate spending, it is proposed that Medicare's hospice benefit cover "virtually all" of the care that hospice patients will receive (instead of paying separate hospice and a non-hospice costs).

However, patient advocates worry that this change may create additional obstacles for patients. Terry Berthelot, a senior attorney at the Center for Medicare Advocacy, urged the government to protect hospice patients' access to non-hospice care. It is argued that beneficiaries may be afraid to sign up for hospice because they believe that once they sign up for hospice, no other services will be covered. At this time, no official changes have been made.

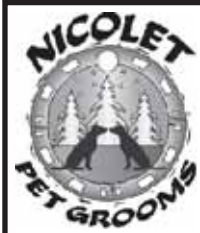

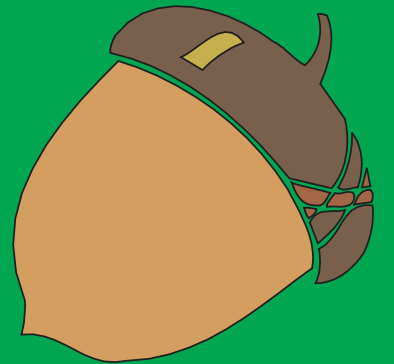
