Forest County Deer Advisory Council meeting August 21 7:00 p.m.

If you like deer hunting, you will want to be at the Forest County Deer Advisory Council (CDAC) meeting on August 21, from 7:00 p.m. until 9:00 p.m. in the lower level of the Crandon Public Library.

CDAC will review deer management unit boundaries and recommend deer population objectives to increase, decrease or maintain the herd in the county's deer management units. These population objectives and deer management units affect antlerless carcass tag availability and deer season options for the next three years, and your feedback is asked for.

The new chairman of Forest County's CDAC is Mike Kauts, a hunter and sportsman from Hiles, and you are encouraged to attend and meet Mike.

Nicolet Wolf River Scenic Byway Dedication August 22nd In Hiles



The official dedication of the new Nicolet Wolf River Scenic Byway will take place Tuesday, August 22nd at 4:00 p.m. in the Town of Hiles. The festivities will take place at the Hiles Town Hall. The public is invited and encouraged to attend with a large turn-out expected. Among the many dignitaries expected to attend, Deputy Secretary of Tourism Sarah Klavas will be on hand to represent the state of Wisconsin at the ceremony. The Hiles Service Club will be serving refreshments as well as making artifacts and photos available for view from the Hiles Historical Museum.

The newest state byway is the only byway in the state with a 'loop' design. The byway begins in Langlade County on Hwy. 55 at Hwy. 64 going north on Hwy. 55 to Hwy. 52 as it goes through Wabeno. It then connects with Hwy. 32, north to Laona, then west on Hwy. 8/32 through Crandon. From Crandon, the byway goes north on 32 through Hiles to Military Rd. where it then goes north to Hwy. 70. It then goes east on Hwy. 70 to Hwy. 55 where it turns south and then goes through Argonne, Mole Lake and back to Langlade. In total, the new Nicolet Wolf River Scenic Byway covers 147 miles.

For those traveling through or from Crandon to the dedication, Hometown Trolley will be providing transportation from the Crandon City Hall parking lot. Don't miss an opportunity to experience a ride on a Hometown Trolley for the dedication of this historic event. Hometown Trolley is providing one trolley with a seating capacity of 24. The trolley will leave Crandon at 3:25 p.m. and return to the city lot at approximately 5:15. Seating is available on a first come, first served basis. On Monday, August 21, 2017, all of North America will be treated to an eclipse of the sun. Anyone within the path of totality can see one of nature's most awe-inspiring sights - a total solar eclipse. This path, where the moon will completely cover the sun and the sun's tenuous atmosphere - the corona - can be seen, will stretch from Lincoln Beach, Oregon to Charleston, South Carolina. Observers outside this path will still see a partial solar eclipse where the moon covers part of the sun's disk.

Crandon Library to host Solar Eclipse Viewing Party



Join the library at the Crandon High School Football Field Bleachers on Monday, August 21 at 12:30 p.m. for a Solar Eclipse Viewing Party! The eclipse will peak at 1:13 p.m. Participants will also have the opportunity to decorate their very own eclipse cookie to eat while viewing the partial eclipse. Bottled water will also be available for sale.

This will be the first total solar eclipse to touch the United States since the 1990s (when one occurred on Hawaii), and the first to cover it coast-to-coast since 1918! In Wisconsin, the total phase of this solar eclipse is not visible in Northern Wisconsin, but a partial solar eclipse can be observed as the Moon covers a large portion of the Sun.

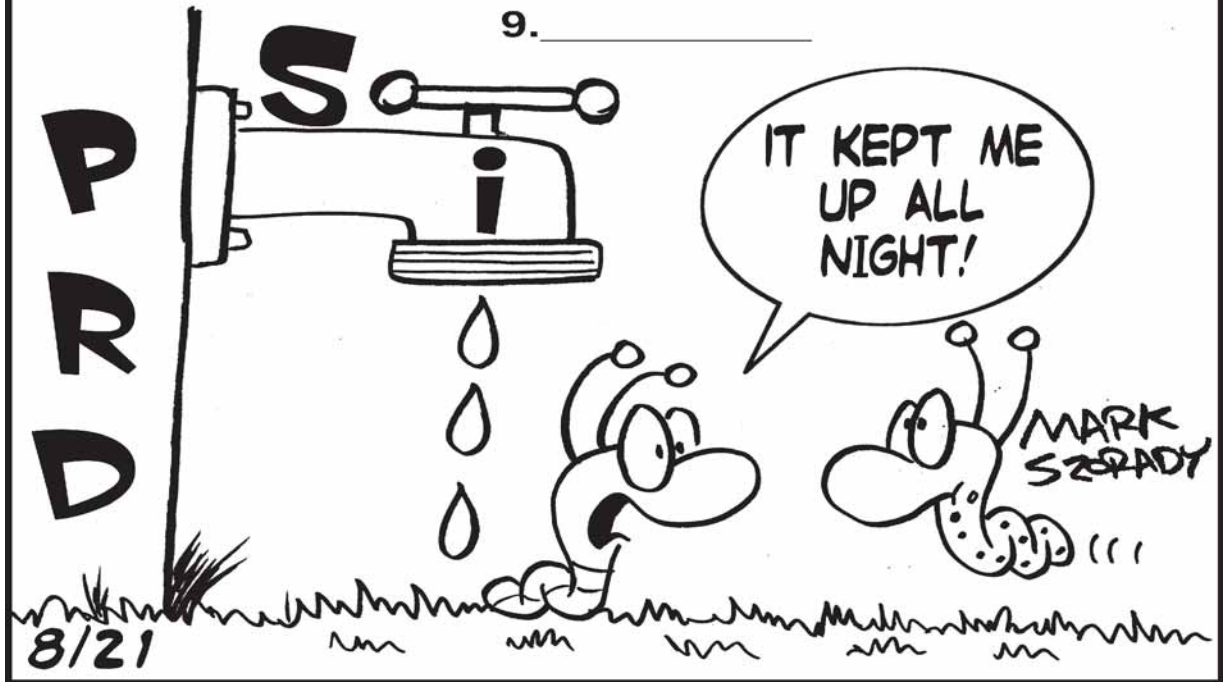



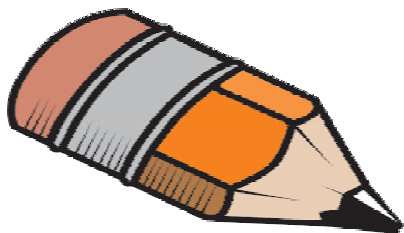

In fact, everyone in North America plus parts of South America, Africa, and Europe will see at least a partial solar eclipse, while the thin path of totality will pass through portions of 14 states.

What is it? This celestial event is a solar eclipse in which the moon passes between the sun and Earth and blocks all or part of the sun for up to about three hours, from beginning to end, as viewed from a given location. For this eclipse, the longest period when the moon completely blocks the sun from any given location along the path will be about two minutes and 40 seconds. The last time the contiguous U.S. saw a total eclipse was in 1979.

Where can you see it? You can see a partial eclipse, where the moon covers only a part of the sun, anywhere in North America. To see a total eclipse, where the moon fully covers the sun for a short few minutes, you must be in the path of totality. The path of totality is a relatively thin ribbon, around 70 miles wide, that will cross the U.S. from West to East. The first point of contact will be at Lincoln Beach, Oregon at 9:05 a.m. PDT. Totality begins there at 10:16 a.m. PDT. Over the next hour and a half, it will cross through Oregon, Idaho, Wyoming, Montana, Nebraska, Iowa, Kansas, Missouri, Illinois, Kentucky, Tennessee, Georgia, and North and South Carolina. The total eclipse will end near Charleston, South Carolina at 2:48 p.m. EDT. From there the lunar shadow leaves the United States at 4:09 EDT. Its longest duration will be near Carbondale, Illinois, where the sun will be completely covered for two minutes and 40 seconds.

How can you see it? You never want to look directly at the sun without appropriate protection except during totality. That could severely hurt your eyes. However, there are many ways to safely view an eclipse of the sun including direct viewing - which requires some type of filtering device and indirect viewing where you project an image of the sun onto a screen. Both methods should produce clear images of the partial phase of an eclipse.

Dear Editor:

On Monday night I was able to experience the tenacious and passion that small town politics has to offer. Having always lived in a large city and having politicians make choices for me with very little input from the ordinary citizen, I felt compelled for the first time to involve myself in politics for a cause I feel very strongly about, that topic would be the continuation of Lake Lucerne as a fully recreational lake, more specifically the ability to be able to ski, fish, and paddle board the lake in its full capacity.

A bit of history for those of you perhaps not familiar with the situation currently on the lake would start with a rollback of time to approximately 2006, when the Lake Lucerne association (a paid membership association that only encompasses the opinions of its members) decided that they would like to restrict an area of the lake to a no wake zone, naming it specifically "behind the islands". A multitude of reasons for that action are given depending on who you talk to ranging from fishing to calm water, but in taking the easiest path to get approval, most site fishing. Keep in mind that Lake Lucerne started and has always ben considered a recreational lake do to the topography of the lake (depth, rocky shoreline, etc). The lake association members, using association and grant money had a study conducted by a local firm, not going to an unassociated and a guaranteed unbiased out of area firm. The study in its summery recommended that a no wake be enforced, but in addition to that recommendation said that no wake would be acceptable in just the bays of that area.

The findings of the study along with the desires of the voting Lake lucerne association members results were sent to the DNR in 2008, as a proposal and have sat as a proposal to this date. Officially the DNR never approved the proposal.

In an overzealous (in my opinion) action the town of Lincoln decided to create an ordinance stating that behind the islands would now be a no wake zone, with no DNR approval and armed with only the desires of some members of the Lake Lucerne Association. Post cards were mailed to "all" members, however many members never received them and had no say in the vote.

The Town of Lincoln for approximately ten years have said that their ordinance (2008-1) is enforceable by the sheriffs department, however the flow of politics requires the county board to approve this ordinance, which it has not approved.

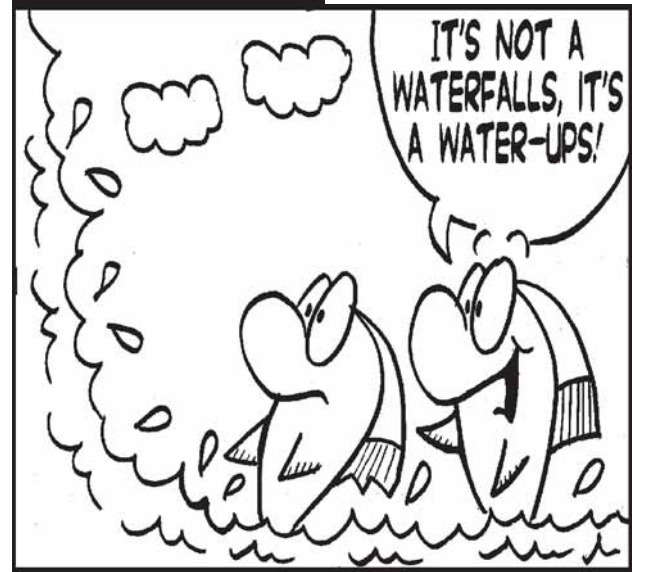
If you were to take a ride to the boat landing on the lake, you would find yourself face to face with a sign stating that the DNR, The Lake association and the Town of Lincoln can enforce a no-wake zone on the lake per the sheriffs department, this is false and deceptive information. If you were to take a ride on the lake behind the islands you would find boys which state "No-wake Zone", which again false.

So why does this matter to you? perhaps you don't live in on the lake or even in the area. This should matter! You have rights as a recreational user of the lakes in your area, and since 2008, the Town of Lincoln and the Lake Lucerne Association have been lying to you about what you can and cannot do on Lake Lucerne. Coming from a larger area where your opinions don't matter, sounds like politics as usual to me. If the threat of enforcement of laws and ordinances that don't exist are frightening to you, be concerned. These are your politicians, your lakes and your rights, protect what is yours, and if you don't, no on else will.

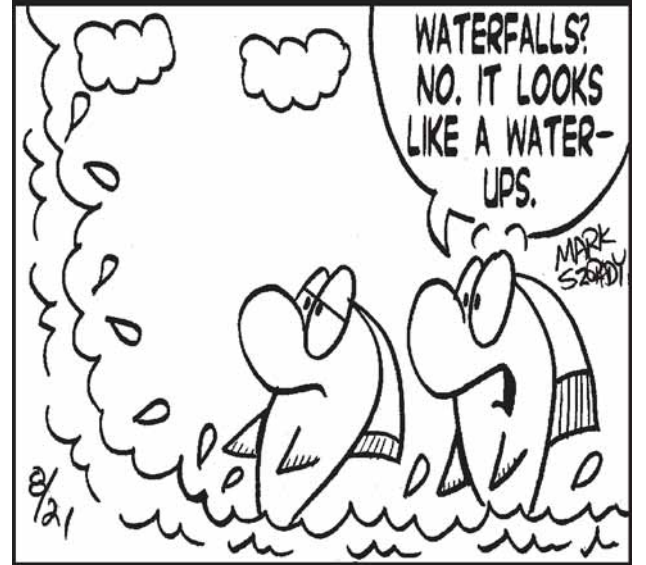

Still time to enter Friends of Wisconsin State Parks Calendar photo contest

People have until August 31, 2017 to enter their favorite photographs from a Wisconsin state park, forest, trail or recreation areas in a contest with winning photos to be included in the 2018 Friends of Wisconsin State Parks Calendar. Photos are needed from all four seasons in state parks, forests, trails and recreation areas.

Again in 2018, in addition to being available for purchase, the calendar will be distributed to more than 85,000 subscribers of Wisconsin Natural Resources magazine in the December 2017 issue.

Submissions are only accepted from amateur photographers ages 14 and over. Professional photographers who earn more than half of their income taking pictures are not eligible. Employees of the DNR and board members of the Friends of Wisconsin State Parks and their immediate family members are not eligible to win. Photographs must have been shot within the past three years (since Jan. 1, 2015) and no more than four photos may be entered.

Sept. 1 marks opener for mourning dove, early teal and early goose hunting seasons

MADISON - Migratory game bird hunters are reminded that Friday, Sept. 1 marks the opener for Wisconsin's mourning dove, early teal and early goose hunting seasons.

Wisconsin will again be offering an early teal hunting season in 2017.

To view a full list of waterfowl hunting seasons and the 2017 Migratory Game Bird Regulations, search keyword "waterfowl."

Canada Goose hunting begins with an early season Sept. 1-15, with a daily bag limit of five geese. Goose hunters are required to complete registration within 48 hours of harvest; however, in-field validation of harvest permits is no longer required. During the early goose season, regulations apply statewide, with no zone-specific regulations.

An additional year of the experimental early teal-only duck hunting season will run Sept. 1-7, with a daily bag limit of six teal. Wisconsin is required to have an additional year of this experimental season due to a change in the U.S. Fish and Wildlife Service regulatory timeline. Opening day shooting hours for the teal season will be 9 a.m. to 7 p.m., followed by sunrise to 7 p.m. for the remainder of the season. Early teal hunters are not required to purchase any licenses or permits in addition to those required for hunting ducks during regular waterfowl seasons.

While the early teal season is offered statewide, some state-owned properties have special waterfowl hunting limitations. For example, Mead Wildlife Area does not allow waterfowl hunting prior to the regular duck season, and Lake Mills Wildlife Area (Zeloski Marsh) has unique shooting hour restrictions. Contact a local wildlife biologist or consult the 2017 Migratory Bird Regulations for a list of areas with special requirements or limitations.

The 2017 mourning dove hunting season will run from Sept. 1 to Nov. 29. This season structure is identical to 2016. The daily bag limit is 15 doves, and the

possession limit for doves is three times the daily bag limit.

With the transition to Go Wild in 2016, the Canada goose harvest registration phone number is now consistent with all other species registered in Wisconsin - this system also provides for online registration. Hunters can register online at gamereg.wi.gov or via phone at 844-426-3734 (844 GAME-REG).

In addition, Early, Exterior and Horicon zone goose permits are printed on regular white paper, rather than green thermal paper. While afield, hunters must carry their Canada goose harvest permit - acceptable methods of proof include a paper copy, DNR-approved PDF displayed on a mobile device, Wisconsin driver's license, or Go Wild Conservation Card. In-field validation of a goose harvest permit is no longer required, but hunters are still required to register their geese within 48 hours of harvest.

Band Reporting

If you find or harvest a banded bird, please report it at www.reportband.gov. To report the bird, you will need the band number (or numbers), location, time, and method of recovery. Even if the band you recover is inscribed with a 1-800 telephone number, it must be reported at www.reportband.gov.

Fields and Forest Lands Interactive Gamebird Hunting Tool

Dove hunters are encouraged to check out the Fields and Forest Lands Interactive Gamebird Hunting Tool. FFLIGHT helps hunters of all types locate young aspen and alder habitat, pheasant-stocked public hunting grounds, and managed dove fields.

FFLIGHT also allows users to print maps and find GPS coordinates to assist in navigation and provides measuring tools to help estimate acreage and walking distance. Mobile users can use this tool on-the-go to find suitable habitat for hunting. For more information, search keyword "FFLIGHT."

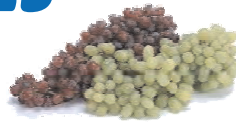

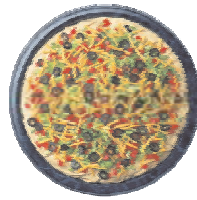

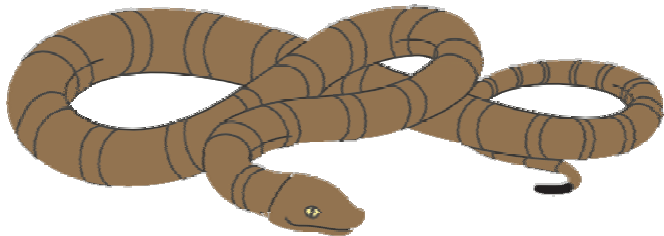

School District of Laona Special Education Screening & Referral Procedures

Any person aware of a child between the ages of birth and 21 who may be experiencing physical, mental, emotional or learning problems may contact the Special Education teachers at the School District of Laona, 5216 Forest Avenue, Suite A, Laona, WI 54541, phone (715) 674-2143 to initiate screening services that will determine if a referral for special education is appropriate.

Referral Procedure

The school district shall solicit and receive referrals of students with suspected educational needs from all persons who have responsible cause to believe that such needs exist. Specific state criteria shall be adhered to in determining eligibility for specific handicapping conditions. Referrals of suspected children with disability shall be referred to either of the people listed above.

IEP - Team Evaluation

Whenever a child is referred who is suspected of having an exceptional educational need, the school district shall establish an IEP Team. An appointment of this team shall be the responsibility of the Program Support Teacher. The Program Support Teacher shall approve the evaluation process and may request additional information.

Procedural safeguards for evaluation including the following:

The notice of intent to evaluate shall be sent to the parents that will include:

A full explanation of the due process/procedural safeguards;

A description of the evaluation proposed, an explanation of why the evaluation is proposed, any options that were considered, and the reasons why those options were rejected;

A description of each evaluation procedure used as a basis for the evaluation;

The type of professionals conducting the evaluation;

A description of any other relevant factors.

Written parental consent shall be obtained when a child is being evaluated for the first time within the district. This consent form shall include:

A statement documenting that the parent understands the content of the notice;

Information on the general areas to be evaluated;

Information on the general types of procedures to be used.

SCHOOL DISTRICT OF CRANDON ANNUAL NOTICE OF SPECIAL EDUCATION REFERRAL AND EVALUATION PROCEDURES

Upon request, the School District of Crandon is required to evaluate a child for eligibility for special education services. A request for evaluation is known as a referral. When the district receives a referral, the district will appoint an Individualized Education Program (IEP) team to determine if the child has a disability, and if the child needs special education services. The district locates, identifies, and evaluates all children with disabilities who are enrolled by their parents in private (including religious) schools, elementary schools and secondary schools located in the school district.

A physician, nurse, psychologist, social worker, or administrator of a social agency who reasonably believes a child brought to him or her for services is a child with a disability has a legal duty to refer the child, including a homeless child, to the school district in which the child resides. Before referring the child, the person making the referral must inform the child's parent that the referral will be made.

Others, including parents, who reasonably believe a child is a child with a disability may also refer the child, including a homeless child, to the school district in which the child resides.

Referrals must be in writing and include the reason why the person believes the child is a child with a disability. A referral may be made by contacting Heather Ostrowski, Director of Special Education, School District of Crandon, at 715-478-6181, or by writing her at 9750 US Highway 8 West, Crandon, Wisconsin, 54520.

Senior Chatter
 Agency Report Summarizes Seniors' Most Common Consumer Complaints

In May, the Consumer Financial Protection Bureau (CFPB) released a report analyzing complaints received from people over age 62 since the agency was created in 2011. Created after the 2008 financial crisis, the CFPB focuses on enforcing federal consumer financial laws, monitoring financial markets for new risks, and educating consumers about finances. Consumer complaints are a large portion of the agency's work. This report highlighted some of the most common financial issues facing seniors.

The CFPB first began taking consumer complaints on July 21, 2011. Between then and April 1, 2017, the agency received 1,163,200 total complaints. Approximately nine percent of these were submitted by consumers over the age of 62. The most common complaints, based on monthly averages, were about reporting. Wisconsin consumers over the age of 62 submitted a total of 13,285 complaints during that time, and the issues raised were similar to those raised in the rest of the country. The most common consumer complaints from Wisconsin seniors involved debt collection, mortgages, and credit cards.

In general, many issues raised nationwide by older consumers were similar to complaints received from younger consumers. However, some issues were unique to older consumers or were made more challenging because of age. For example, older consumers were more likely than younger consumers to submit complaints about mortgages, credit cards and bank accounts and services. In particular, they reported experiencing difficulties when policies or institutions changed, such as a shift to mobile banking or a change in a loan servicer. Moreover, representatives of older consumers described challenges using Power of Attorney paperwork at banks and other financial institutions and organizing finances after the death of a family member.

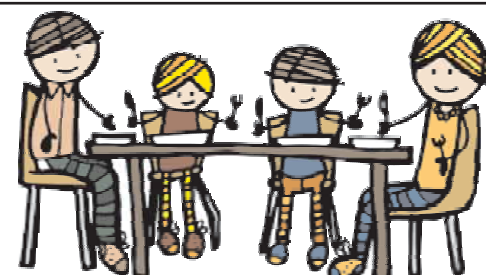
