#### **Our Changing World presentation** March 14 at Nicolet College to look at climate change, lake temperatures

The impact of climate change on lakes both small and large will be the topic of an Our Changing World presentation from 6:30 p.m. to 8 p.m. Wednesday, March 14, in the Nicolet College Theatre.

"Recent studies have shown rapid warming of inland water bodies around the world," said presenter John Lenters, honorary fellow at the University of Wisconsin-Madison Center for Limnology.

"Many lakes are warming more rapidly than air temperature, including small lakes in northern Wisconsin and quite a few large, deep lakes. This is contrary to what is usually expected."

Lenters will discuss the variety of reasons that have been proposed to explain rapid lake warming. Lake Superior will be used as a case study to illustrate the "perfect storm" of factors that has caused a large, deep lake to warm at a rate that is more than three times the global average.

Lenters has a Ph.D. in atmospheric science from Cornell University and conducts postdoctoral research in lake-climate studies at the Center for Limnology and Center for Climatic Research at the University of Wisconsin-Madison.

His research focuses on the physical interactions between lakes and climate, with a particular interest in lake evaporation, temperature, ice cover, and water levels. His field studies have included the North American Great Lakes, thermokarst lakes in northern Alaska, saline lakes in western Nebraska, and temperate lakes in Wisconsin and Michigan. He is currently the lead investigator of the Global Lake Temperature Collaboration and a founding member of the Great Lakes Evaporation Network.

The Our Changing World Series is sponsored by the Oneida and Vilas County Chapter of the Citizen's Climate Lobby and the Nicolet College Sustainability Professional Learning Community.

Other upcoming presentations in the series will include Projecting Climate Change Impacts on the Natural Resources of Wisconsin's Northern Highlands on Wednesday, April 11, and the Effects of Climate Change on Fish and Fisheries in the Northwoods on Wednesday, May

Over the years, I have witnessed numerous situations that in my opinion could have been, and should have been handled differently. I know that if I choose to NOT get involved, then I can't possibly make a difference. I've always lived by the saying, "Be the change that you want to see!" The new Courthouse Campus Facility is by far one of the biggest issues that is facing the County right now. It is a shame that our Courthouse has been so neglected for so many years. Maintenance that should have been accomplished as needed, was passed over and ignored by the committee, doing only the minimum necessary, with always the same excuse; Budget Restraints. Well now we are seeing the devastation that this "Snowballing Effect" has caused. And yes, I think that most everyone agrees that there are many issues and safety concerns that need to be addressed. But I feel that a 26 million dollar project is not the answer. There's a need to first investigate more opportunities, determine critical areas of urgency, establish priorities and then look for innovative ideas to proceed with repairs/construction more efficiently. We've always been told that we are a "Poor" County, and with the type of expenditure and tax burden that is currently being considered, we are destined to become even POORER! Without proper planning and the ability to look ahead, we'll be back in the same boat we're in now, within several years. So it is crucial to first and foremost establish a "Maintenance" fund, with some realistic guidelines, before proceeding blindly down a path of inevitable ruin.

Many years ago, In the Town of Lincoln, we (the town board) had the foresight to develop a strategy to address our growing need for a town hall. The Board formulated a budget that would allow for this required expansion, without the burden of borrowing, paying high interest or significantly raising taxes. This is where my business and organizational development skills along with my accounting, financial management and budgeting backgrounds were key ingredients and played a vital role. One of the things that I desire to accomplish is to build the necessary bridges between Town and County Government, with emphasis on reducing the gaps of adversity, and concentrating more on promoting collaboration, support, unity, cooperativeness, harmony and teamwork. Partnerships between governments are absolutely a must, and a joint effort only makes good ense. Many times throughout County Government, one hand doesn't seem to know what the other hand is doing. Committee members only know what is going on within the committees that they sit on and represent. So as a whole, there is much lost in "non-communication." 

#### WI Public Service Scam Warning

Please be aware of the following scam targeting residential and small business customers of WPS. How the scam works

- · A person calls a residential or small business customer and says he/she is from WPS.
- · The person calling may know your name and address and claim to have more information regarding your account.
- · The caller will claim you are behind on your utility bill payment and are subject to immediate disconnection.
- · Or, they may indicate you need upgrades to your utility equipment and immediate payment is due to avoid disconnection.
- · They will instruct you to go to a nearby store and purchase a pre-paid credit card, money order or money pack card.
- · The caller leaves you with a phone number and instructs you call them back and provide them with the numbers on the credit card you purchased. Once you give them the card numbers, the money is gone.

The scammers are very smart and can apply pressure if you start to ask questions. They may also use technology to make it look as if the call is coming from a local number or even the utility company. Be cautious if you receive a suspicious phone call of this nature.

What to do if you receive a suspicious call

- · Write down any information the caller provides to you. Take note of the call date and time, phone number to call back and/or caller ID, and any details revealed to you by the caller. DO NOT provide any private information, account or banking information.
- · Call WPS if you receive a suspicious call. We can verify if a call was made to you from the utility and/or verify your account status.



Other aspects students liked were that everything was electronic and easily accessible either as a file they could download to their computer or was posted online. The fact that they didn't have to lug around another 10-pound textbook was another big draw, which one student surveyed described as "awesome."

#### Other students also provided written comments.

"I never got the feeling that I was reading information I didn't need to know. The content was very direct and delivered very efficiently," wrote one student.

"Being able to download the material and have it on my laptop was great," wrote a student in a chemistry class who also greatly appreciated the fact that they didn't have to drop \$300 for the chemistry textbook.

"There were times when I found myself needing slightly more information or a clearer description of a topic, and it was nice for that to be only a click away from a Google tab and the endless cross-references," wrote another.

Some students, however, weren't that keen on the idea that everything was electronic and online.

"They wanted the paper version, and for these students we made sure they could always print out the material if they wanted," Domaika said.

Business Management Instructor Ellen Mathein was an early adopter of OER material at Nicolet. Currently, three of the five classes she teaches feature free instructional material for students.

Textbooks can be a tremendous financial burden for students, to the point where some students will try to take a class without purchasing the textbook because they simply can't afford it," Mathein said. "That puts them at a significant disadvantage in learning the content and OER material directly addresses this issue."

When she was first introduced to the concept, Mathein wondered if the quality of the material would be on par with traditional textbooks.

'The more I dug into it, the more I realized that the academic rigor of the material was equal to the textbook I was using," she said. "In some respects, it's even better." Domaika stressed that all of the material that makes it into a Nicolet OER class goes through a rigorous review process to

ensure it meets academic standards. "We make sure that all of the material is peer reviewed by faculty at other colleges and universities," said Domaika, who noted OER content is relatively new to higher education and that Nicolet is one of the first in the state to

adopt it as extensively as a free resource for students. Every Nicolet class has a list of course competencies that outline the subject matter to be learned in

To gather the educational material that covers all of the competencies, instructors and Domaika worked hand in hand to find course materials.

"What's nice is that I can customize the content to exactly what students need," Mathein explained. "I can take the chapters I want from an electronic textbook, delete the rest, and then add in other instructional material that teaches to the specific competencies in the course."

As for the future of free Open Educational Resource material in Nicolet classes?

"This is just in its infancy," Domaika said. "I think it's going to grow dramatically as more quality content becomes available. Our goal is to have a zero textbook cost for every student."

#### Nicolet College slashes textbook costs in many classes

For many college students, there's no way around it. Textbooks are expensive.

Students commonly shell out hundreds of dollars each and every semester for the required books.

To cut textbook costs, Nicolet College recently changed the way it provides educational materials for many classes so students can get everything they need for

"We piloted the program this past fall and we estimate that it saved students about \$30,000 that first semester," said Cindy Domaika, manager of Open Educational and Instructional Resources at Nicolet.

Now in its second semester, Domaika estimates the program is saving current students another \$39.000.

"Going forward we expect to significantly expand this program to more and more classes. We don't want the cost of textbooks to be a barrier for students to receive a college education."

To replace traditional textbooks, Domaika collaborated with a dozen Nicolet instructors across 16 classes to find open sourced educational materials available online for free.

The majority of the material came from oercommons.org, a vast, content-rich website where educators from across the globe openly share a wide variety of instructional material that is available at no cost.

"This is a major shift in how students access learning materials they need," Domaika explained. "Sources range from electronic textbooks to videos and PowerPoint presentations to a wide variety of other content that is available entirely in an electronic format."

Business Management student Gayle Shanks is taking two Nicolet classes this semester where all the learning material is available at no cost.

"I can't tell you how nice it is to get everything I need for class for free," she said. "The cost savings is significant and much appreciated."

Shanks noted that she has two sons enrolled at other colleges. One son just spent more than \$700 for his semester's textbooks. At Nicolet, the average full-time student spends about \$600 a semester on textbooks, depending on the program.

At the end of last semester, Domaika sent out a survey to the 156 students who took at least one class taught with Open Educational Resources (OER) material. "It was pretty clear students really liked it. We received

many positive responses, the most common of which was that the material was totally free," she said. "This freed up money so students could pay for other things like car insurance and child day care."

#### What a Trip to the Emergency Room Means for an Older Person

When we're young, a trip to the emergency room is usually for an unexpected illness or injury, and most of us take getting back to normal for granted. For older individuals, however, a trip to the ER can be a much different experience.

Consider these facts:

- Two-thirds of seniors who go to the emergency room are never admitted to the hospital -- they return home immediately after their visits.
- Six months after visiting the emergency room, seniors are 14 percent more likely to have acquired a disability (for example, no longer being able to bathe, dress, climb down a flight of stairs, shop, or manage finances by themselves).
- The extent to which an older person gets up and about and out of the house after an emergency room visit is reduced drastically for at least a year without a full recovery.
- $\bullet$  The leading cause of ER visits in an older person is a fall and injury.

Many wonder why emergency room visits become so critical for older patients. One theory is that many older adults may have been coping adequately, but the emergency room visit acted as a tipping point and now they need more help. Another theory is that seniors who fall and injure themselves may become afraid of falling again and limit their activities, which leads to deterioration. Finally, underlying vulnerabilities (depression, dementia or delirium) may go undetected, leaving older adults susceptible to the ongoing impact of these conditions.

Starting in February 2018, the American College of Emergency Physicians is starting a program to certify emergency rooms in geriatric competence to make sure seniors leave the ER safely. At the basic level, medical staff will be educated in the principles and practice of geriatric care; assessing seniors to determine their degree of risk; screening older adults deemed at risk for cognitive concerns, falls and functional limitations; performing a comprehensive medication review; making referrals to community resources such as Meals on Wheels; and supplying an easily understood discharge plan.

# RAISE Family Caregivers Act signed into law

Green Bay, WI., January 24, 2018 – The Alzheimer's Association and the Alzheimer's Impact Movement (AIM), the Association's advocacy arm, are celebrating the passage of the bipartisan Recognize, Assist, Include, Support, and Engage (RAISE) Family Caregivers Act. Signed into law on January 22, 2018 by the president, the RAISE Family Caregivers Act will address the needs of our nation's family caregivers through the development and implementation of a coordinated national strategy.

Introduced in Congress by Senators Susan Collins (R-Maine) and Tammy Baldwin (D-Wis.) and Representatives Gregg Harper (R-Miss.) and Kathy Castor (D-Fla.), the RAISE Family Caregivers Act will provide much needed support to family caregivers. The new law directs the Department of Health and Human Services (HHS) to develop a national strategy to provide education and training, long-term services and supports, and financial stability and security for caregivers.

Of the legislation, Greater Wisconsin Chapter Executive Director Laurie Schill said, "This Act will make a meaningful impact on the 193,000 family caregivers living in Wisconsin. Caring for someone with Alzheimer's is incredibly challenging, both physically and emotionally. Because of this, we are so grateful for our volunteer AIM members and members of Congress who worked to ensure that caregivers will have access to enhanced support services."

For the Wisconsinites caring for individuals with Alzheimer's and other dementias the emotional, physical and financial costs can be overwhelming. Caregivers of people with dementia report higher levels of stress, depression and worse health outcomes than those providing care to individuals without dementia. As a result, Alzheimer's caregivers in Wisconsin incurred \$140 million in additional health costs last year.

The RAISE Family Caregivers Act also directs HHS to create a Family Caregiving Advisory Council, similar to the National Plan to Address Alzheimer's Disease Advisory Council. Both the advisory council and The RAISE Family Caregivers Act was closely modeled after the National Alzheimer's Project Act. The Alzheimer's Association and AIM have been strong advocates for the RAISE Family Caregivers Act since it was introduced in Congress. Grassroots advocates and staff held thousands of congressional meetings to secure support for the legislation. The Association and AIM will continue to play an active role in the process as HHS works to develop and implement the national strategy.
