2nd Annual Forest County Festival

The 2nd Annual Forest County Festival was held June 29-July 1, 2018, at the Crandon International Off-Road Raceway. Despite challenges from the weather, the event was a success and enjoyed by many.

The festival offered much to do including free carnival rides, live music, kid's games, food, laughter and smiles. There was also an abundance of chatter about the oppressive heat that descended on the area throughout the weekend. As was heard through the grapevine, Friday evening was booming with families and children taking full advantage of all the activities. It was a good start for the weekend's celebration.

Saturday turned out to be an absolute scorcher with extremely high temps and humidity resulting in heat indexes above 100 degrees. Fortunately, the Legionnaire Mud Challenge took place at 8 a.m. before the heat became intolerable; it had a good turnout with around 100 participants competing. The Crandon Fire Department parade then followed at noon in downtown Crandon and included a number of interesting floats, group entries, the Crandon High School band, and some pretty impressive logging equipment all decked out in patriotic themes. Following this, people either went to cool off at the lake or stayed inside somewhere with AC. The brave ones decided to "meet the heat" and headed out to the carnival for the rides and food.

During the hour immediately following the parade, the Forest County Potawatomi (FCP) held check presentations at the festival grounds during which they donated \$10,000 grants across the board to Forest County townships. These included the City of Crandon and the towns of Hiles, Wabeno, Popple River, Nashville, Lincoln, Argonne and Alvin. Representatives from many of the townships expressed their gratitude to FCP and then spoke a bit on what they were planning to do with the monies. Many are planning to use these funds to make improvements to their communities. Planned projects

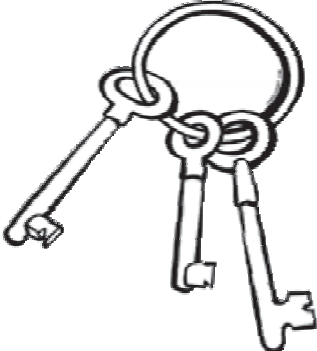

Baldwin calls on Trump to abandon effort to threaten health care for people with pre-existing conditions

WASHINGTON, D.C. – This week, U.S. Senator Tammy Baldwin led 47 Senators in calling on President Trump to abandon his Administration's latest effort to undo the Affordable Care Act and threaten health care for people with pre-existing conditions.

The letter to President Trump addresses his Administration's decision to support a lawsuit from 20 states including Wisconsin, Texas v. U.S. Department of Health and Human Services (HHS), that would take away the guarantee of health coverage for more than 133 million Americans with pre-existing conditions. If the lawsuit succeeds, insurance companies will once again be able to discriminate against people with pre-existing conditions by denying them coverage or charging higher premiums.


"Your Administration is not only supporting a lawsuit that is dangerous and destructive to the health care system, it is also turning its back on the 133 million Americans with pre-existing conditions, including 17 million children," the senators wrote in the letter to Trump. "If these states and the DOJ prevail, health insurers will once again be able to discriminate against people with pre-existing conditions, women, and seniors by denying them coverage or charging higher premiums simply because they have had a medical event ranging from acne to cancer to having a baby."

Senior Chatter

The call is not coming from inside the house

Are you getting calls from your own phone number? Or, maybe from a number that looks like it could be a neighbor, a local business, or even a government agency, but when you answer it's a telemarketer or collection agency?

Scammers know that when your phone rings and it looks like a local call or a government agency, you may be more likely to answer. They can easily fake the number that shows up on your caller ID, which is called "caller ID spoofing." This also lets them get around call-blocking services and the National Do Not Call Registry.

Even government agencies' phone numbers have been spoofed. Last year, a woman in Jacksonville, Florida, received a call that looked like it was coming from the Department of Health and Human Services Office of Inspector General (OIG). The caller told her that she had won a \$9,000 grant from the federal government and all she had to do was either wire \$250 to him through Western Union or give him the confirmation code for a \$250 iTunes gift card. The man also wanted her to confirm her name, address and some other personal facts. She became suspicious and eventually ended the call.

Although the woman didn't send money, she was scammed into confirming and giving out personal information that could be used to steal money from her bank account or for other fraudulent activity. She wasn't the only one who received a phone call like this. The OIG hotline phone number for reporting fraud —1-800-HHS-TIPS (1-800-447-8477) — had been spoofed. Thousands of calls using the spoofed number were made to people across the nation.

Just a reminder: The federal government will not call you unless you called them first. If the Internal Revenue Service, Social Security Administration, Centers for Medicare and Medicaid Services, or any other agency needs to reach you, they will contact you by mail.

If you see a number that you're not sure about on your caller ID, remember that it could be faked. Letting calls go to voicemail is one option. If you do pick up and don't recognize the caller — HANG UP. Don't be fooled by a caller's knowledge of your name or any other personal information. Never give out or confirm personal financial or other sensitive information like your bank account, credit card, or Social Security number unless you know the company or person with whom you are speaking. Scammers can use your information to commit identity theft.

You can report unwanted calls to the Federal Trade Commission at <https://complaints.donotcall.gov/complaint/complaintcheck.aspx>. Reporting these calls helps phone companies that are working on ways to block these calls. Your report will also help law enforcement identify scammers making these calls.

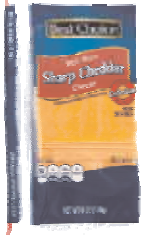

Coalition forms in Wisconsin to reverse decline of monarch butterflies

MADISON - Monarch butterfly populations have dropped more than 80 percent over the last 20 years in the eastern U.S., and a new statewide consortium has formed to work together to reverse the decline in Wisconsin.

A new statewide consortium has formed in Wisconsin to work together to reverse the decline in monarch butterfly populations.

The Wisconsin Monarch Collaborative includes more than 70 stakeholders representing agriculture, transportation, utilities, public and private land management, research, education and government.

With input from all sectors, the collaborative has drafted Wisconsin's portion of a regional strategy that covers 16 states and is in the beginning stages of creating a Wisconsin Monarch Conservation Strategy. The state strategy will serve as a roadmap for voluntary statewide monarch conservation efforts and will focus on increasing monarch habitat, namely through increasing native milkweed and nectar plants.

"This is an all hands-on-deck effort," says Owen Boyle, the Department of Natural Resources species management section chief and DNR's lead representative for the Wisconsin Monarch Collaborative.

"Many people and organizations are already doing great work for monarchs. This new coalition will build on those efforts and help leverage resources to accelerate efforts to restore monarchs in Wisconsin."

Craig Ficenecc, co-chair of the coalition's agriculture working group, says the effort can help proactively recover monarch populations before they might need to be listed as an endangered species, something that the U.S. Fish & Wildlife Service has been petitioned to do.

"Farmers and rural landowners are key to proactively and voluntarily recovering monarchs," says

Ficenecc, program director for the Sand County Foundation, a national non-profit based in Wisconsin that promotes voluntary conservation on private land. He works with farmers, rural electric cooperatives, and high school agriculture educators to plant monarch habitat.

Andrew Wallendal, co-owner and consultant of Wallendal Farms and a representative for the Wisconsin Potato and Vegetable Growers Association, says the coalition has great potential for producers to network about conservation actions on their farms.

"Farming and conservation can go hand in hand, such as maintaining high quality and high yields, while pollinator areas on non-tilled parts of the farm flourish," he says.

Karen Oberhauser, Director of the University of Wisconsin-Madison Arboretum, has been studying monarchs for over 30 years, and has witnessed a drastic decline in their numbers over this period. "We know that preserving this amazing species will require the engagement of all states in their migratory flyway, and all sectors of human society, from farmers, to urban residents, government agencies, to businesses. The Wisconsin Monarch Collaborative is part of a hopeful and important effort," she says.

Monarchs breed in Wisconsin and 15 other Midwestern states throughout the spring and summer and native milkweeds are the only plants on which monarchs will lay their eggs. In Wisconsin, as elsewhere, habitat loss is considered the main threat to pollinators including monarchs. Monarchs face special challenges as the distance increases between the remaining suitable habitat patches along their 2,000+ mile migration route between their breeding grounds in the Midwest and their wintering grounds in central Mexico.

Hello again, I would like to apologize to the readers for my lack of articles in the past month. As many of you may already know, our office here has seen the retirement of long time Land and Water Administrator- Pam Labine as well as many changes in the County Board and Committees. Changes in board members and staffing along with the busy building season for zoning with land use permits and sanitary permits has put our office behind. As a result I did not have the time to complete my weekly article. With that said, I am back, and hope to pick back up with the articles. I have had a lot of positive feedback about these articles from people all around the county and feel that these articles are making a great impact.

The Land Conservation Department (LCD) has been working on a good number of potential cost share projects with landowners on Lake Metonga, Roberts Lake, Revolver Lake, and Pine Lake. Most of the potential projects on Lake Metonga, Roberts Lake and Pine Lake are shoreline erosion related to ice shoves and erosion created by open soil from these shoves. The potential project on Revolver Lake is related to erosion from an access road that has potential to degrade water quality. LCD is working with the Department of Agriculture, Trade, and Consumer Protection (DATCP) and the Natural Resource Conservation Service (NRCS) to bring cost share programs to landowners who are willing and able to have the work completed to department specifications and plans. Cost share programs are available for many projects, however the landowners need to be aware that cost are paid by them up-front and then reimbursed by the government programs. Please e-mail the department if you think you have a potential project related to soil erosion or water quality and we will schedule a time to look at your property.

The LCD is working on assisting the Pine Lake District with their potential sample dredging project for this summer. The new DNR regulations now allow riparian landowners to complete some dredging in their lake if they meet the requirements of the general permit, if they apply for the general permit and are approved, and if they pay the fee which is around \$300. If these requirements are met, the riparian landowner may dredge up to 25 cubic yards of sediment from specific areas near their lakeshore. New regulations require the DNR to issue such permits within 30 days. The Pine Lake District hopes to carry out a project this summer to demonstrate how to complete a dredging project and to demonstrate the good things that can result. LCD is also working with the Forest County Health Department on a project called "The Quiet Waters of Forest County" which will promote the paddling sports such as canoeing and kayaking. So far 42 quiet water accesses have been mapped across the county including lakes and streams with limited development. When complete the project will provide mapping, directions, and photos from the sites. Mapping will be available for use on google maps so people can utilize their devices to locate and utilize our wonderful "quiet waters" for their enjoyment.

MADISON - Roadside ruffed grouse surveys completed this spring showed statewide drumming activity decreased 34 percent between 2017 and 2018; while this decline does not follow the generally predictable grouse population cycle, the 2018 drumming observations do fall within the normal range of variability of the grouse cycle.

The survey results showed a 34 percent decrease statewide over 2017 levels. The down turn was seen in both the central (-29 percent) and northern (-38 percent) forest regions of the state. These two areas comprise the primary grouse range in Wisconsin. While the decreases in the southwest (-14 percent) part of the state were smaller by percentage, and an increase in the southeast was observed, these areas are not within the primary range for grouse. The drumming activity in southwestern and southeastern Wisconsin are at or near historic lows, and likely would not significantly add to grouse abundance in the state.

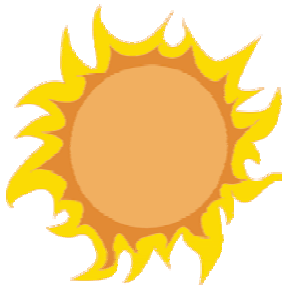
"Ruffed grouse populations are known to rise and fall over a nine to 11-year cycle, and the last peak in Wisconsin's cycle occurred in 2011. Based on the historical grouse cycle in Wisconsin, it was expected there would have been a significant drop in the population in the northern forest back around 2015; however, the population decline was only about half as low as anticipated," said Mark Witecha, Wisconsin Department of Natural Resources upland wildlife ecologist.

"With this somewhat abbreviated low point in the population cycle in 2015, an increasing phase lasting several years is expected, so a decline in 2018 is not consistent with a typical population cycle, but does confirm the reports we received from hunters last fall. As these survey results indicate, there is some variation from the historical pattern in the grouse population over the last several years, specifically in the primary northern range. In the more southern survey areas, a long-term decline in the population is consistent with a loss of quality young forest habitat." "Ruffed grouse rely on dense, young forest cover resulting from disturbances such as fire and logging - beyond actively managing state-owned lands, Wisconsin DNR is working to provide suitable grouse habitat through an extensive collaborative effort known as the Wisconsin Young Forest Partnership," said Witecha. "This partnership provides technical and financial assistance for young forest management on private lands, benefitting ruffed grouse and other wildlife species by helping maintain healthy and diverse forest communities."

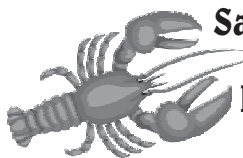

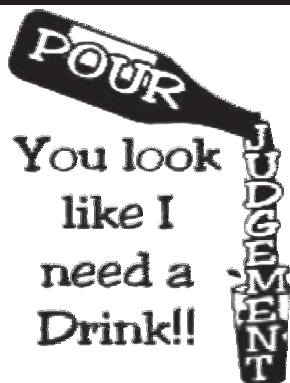

“Bettering Staff Effectiveness”

Having worked at the Forest County Sheriff’s Department for ten years, I can credibly say how important maintaining experienced employees is. This is why the high turnover rate at the Sheriff’s Department is especially alarming the past eight years. Many of the employees that have left under our current administration have been people with irreplaceable experience. This experience could easily be the determining factor of life or death in a number of various situations, so compromising that experience and hiring new officers with incomparable skills is counterproductive. When the turnover rate has been questioned in the past, people are lead to believe employees left for better wages and/or benefits. While that may have been the case for some, my conversations with previous employees indicated that administration differences were also a major cause. Many of these concerns stem from the lack of appreciation or recognition. Things as simple as handling a complaint to help an employee’s workload would show and encourage teamwork. Showing employees that you are not above the work they do is crucial and mutual respect is necessary, however, it is lacking.

I have always been a firm believer that a leader should lead by example and not from behind a desk. Many issues with staffing occur through e-mail memos rather than addressing the matter in person. The safety of many officers and citizens is being compromised because in many cases, deputies are being mandated (through these memos) to remain on duty six additional hours beyond their twelve hour shift, or to come in six hours earlier than their original scheduled shift. Not only is this an unreasonably long shift, but it only gives that officer six hours of rest before beginning another twelve hour workday. There have also been threats to staff of lowering the minimum staff requirement to one deputy on duty, which only further compromises the safety of the community. Administration relies on these e-mail memos to address important concerns and policies, when in reality, these manners need to be more efficiently and effectively addressed. A properly balanced schedule to avoid these types of scheduling conflicts would have been the best alternative for safety.

Another main scheduling concern is the fact that Tuesday through Thursday has more than double the amount of officers on duty when compared with the weekends. Being an employee who frequently works these weekend shifts, I can accurately discuss how inefficient this scheduling process is. There are some cases where it is beneficial to have more than one investigator, however, it is not justifiable to have multiple investigators on the same shift and only scheduled during the weekdays. Evening out the schedule for deputies, investigators and the sheriff would not only increase efficiency, but would also resolve the current issue of not having a supervisor scheduled during the day shift each weekend. Commonly, higher crime activity occurs during the weekend and having less law enforcement personnel scheduled during this time is a safety concern.

With the best interest of the community in mind, I feel these scheduling conflicts need to be actively addressed and if elected sheriff, it would be one of my first actions. It is my utmost priority to ensure the safety of this community and its citizens, which is why balancing the schedule to have more first-hand interaction would be beneficial in all respects.
