A trip through the Nature Center is unique, and to get in the mood for Halloween, visit the Haunted Slaughterhouse.

The corn maze is a great way to test your sense of direction. It is a challenge and a good time as well, and if you have a drone, it is a unique photo taking experience!

After all this, you will have built an appetite, and the Choo Choo Hut Restaurant will satisfy your hunger.

You will love the Lumberjack Steam Train and the Camp 5 Museum Complex in the autumn, and all are invited to experience the Fall Festival.

The Land Conservation Department has been working on some different projects to showcase our wonderful natural resources. Many of our residents take many things for granted, because we live here. We need to recognize that our forest is managed better than most forests in the world. Our water quality and wilderness areas that are unlike most of Wisconsin. Our hunting and fishing are unsurpassed. Our resources are a tribute to our past and present residents who actively managed our natural resources and do without many modern day luxuries to maintain our rural character and the beauty of our County.

Forest County is truly "The Forest of Wisconsin" with approximately 685,933 acres of forest lands, 850+ miles of streams, and 824 lakes for our enjoyment. If you are interested in the outdoors, Forest County is the place to be. Our wonderful natural resources provide thousands of acres of opportunity for sightseeing, hunting, fishing, hiking, biking, ATViing, and snowmobiling. Much of our land area is accessible by roads and water routes. Many roads are unpaved and somewhat unmarked.

If you haven't checked out the Forest County website lately, we invite you to check out some of the changes. In particular click on the "Visit the Forest of Wisconsin" tab on the left side. This site was created to provide visitors maps and resources to help them enjoy what we have to offer. Within that tab there are currently two options which include "Drive the Forest of Wisconsin" and "Paddle the Forest of Wisconsin." These two tabs include maps and google map links for people to utilize.

Just in time for the fall colors, within the "Drive the Forest of Wisconsin" tab there are 32 separate scenic drives with routes beginning at Crandon, Laona, Wabeno,

Over 95,000 Acres Targeted for Hunters

Rhineland, WI - The Wisconsin County Forests Association (WCFA) working with its individual member counties has expanded ruffed grouse hunting opportunities just in time for the September 15 opener of the 2018 ruffed grouse hunting season. WCFA's popular Grouse Management Area promotional program began in 2017 with the identification of 12 areas on county forests found in northern and western Wisconsin. In 2018, this program has expanded to include six additional management areas. New locations have been identified on five county forests (Burnett, Langlade, Oneida, Taylor

Crandon School Board reaches decision on District Administrator

The Crandon School District held their monthly school board meeting on Monday, September 10 at 6 p.m. in the high school auditorium, where they came to unanimous decision regarding the fate of District Administrator Dr. Kryder. However, this decision will not be made public until the board irons out some details.

Following their closed session discussion, the board released the following statement: "We appreciate the community being patient during this time and ask for a little more patience as the District does what is needed to be done for the best interest of the District. The Board has unanimously decided to move forward. The District has informed Dr. Kryder of its decision and the parties are currently working through the situation. Please understand that this process takes some time.

"Additionally, please understand that the District has been without a District Administrator for the better part of six months. The District is actively working to address this situation as well.

"In closing, due to the nature of the current situation, we cannot discuss exactly what is being done but, rest assured, the School Board is acting in the best interest of the District. We ask for your continued patience and will advise the community of the outcome when it is appropriate to do so."

Also decided at the meeting was that staff members Hollie Ackley and Sue Stamper will monitor social media for the district rather than pay an outside source to do the job.

The Crandon Area Booster Club informed the School Board that Darcy Bradley and Craig Deere will be taking over for RT Krueger and Andy McMillion. Darcy stated that she would like to improve outdoor facilities and wants to work with the public and the board. They both look forward to growing and learning.

The high school principal, Jewel Mucklin, announced that the AP Psychology results were excellent. Almost every child who took the course over the past few years earned college credits.

In other business, the CESA 8 representative will be decided at a later date. Bills totaling \$466,444.70 were approved for payment.

The annual meeting is set for October 29 at 6 p.m.

U.S. Senator Tammy Baldwin calls for reauthorizing the Land and Water Conservation Fund

With Wisconsin Hunters and Sportsmen in Wausau, Baldwin pushes for action to ensure that future generations will be able to carry on Wisconsin's traditions of hunting, fishing and enjoying the great outdoors
Funding for the Land and Water Conservation Fund will expire September 30 if Congress fails to act

WAUSAU, WI – U.S. Senator Tammy Baldwin met with hunters, fishermen and sportsmen in Wausau today to discuss the need to reauthorize the Land and Water Conservation Fund (LWCF) to protect and preserve public lands for recreation and hunting. Funding for the LWCF is set to expire on September 30 if Congress does not act.

"Wisconsin has long been a national leader for conservation and we have a proud tradition of hunting, fishing and enjoying the great outdoors. I'm proud to work across party lines to protect these traditions for future generations and safeguard the natural resources we enjoy in Wisconsin," said Senator Baldwin. "Wisconsinites understand that protecting public access to our natural resources is critical to our quality of life and to our economy, so Congress must act swiftly to reauthorize the Land and Water Conservation Fund."

Senator Baldwin was joined by representatives from the Wisconsin Wildlife Federation, Ducks Unlimited, Trout Unlimited, Ruffed Grouse Society/American Woodcock Society, Wild Turkey Federation, Gathering Waters, Pheasants Forever, Backcountry Hunters & Anglers and the Wisconsin League of Conservation Voters.

Wisconsin has received more than \$200 million in LWCF funding over the past five decades, protecting places like the Chequamegon-Nicolet National Forest, the Ice Age National Scenic Trail, the North Country Scenic Trail, the St. Croix National Scenic River and the Apostle Islands National Lakeshore.

Senator Baldwin has long advocated for investing in the LWCF. She also worked with a bipartisan group of Senators to introduce the Land and Water Conservation Authorization and Funding Act, which would permanently reauthorize and fully fund the Land and Water Conservation Fund.

Senator Baldwin's work to improve care for Wisconsin Vets passes Senate

Bipartisan legislation fully funds Jason's Law, invests in opioid treatment and prevention, and supports Gulf War and Homeless Vets

WASHINGTON, D.C. – U.S. Senator Tammy Baldwin, a member of the Senate Appropriations Committee, worked to include a number of measures in the bipartisan FY19 Military Construction-VA Appropriations Bill, which was included in the FY19 funding package that passed the full Senate this evening. The House and Senate will now reconcile their versions of this appropriations bill and send to the President for his signature.

"This bipartisan legislation that passed the full Senate includes many reforms that I worked for to improve services and care for our veterans. By working across party lines I was able to secure full funding for the opioid safety initiatives outlined in Jason's Law, a significant increase in opioid treatment and prevention funding, and improvements in care for our Gulf War and homeless veterans," said Senator Baldwin. "There is much more to do, and I am grateful that we are working together to fix problems at the VA and put in place bipartisan solutions that serve our veterans and their families. I am looking forward to the President signing this important legislation."

Jason's Law: Safer Care for Veterans

Senator Baldwin worked to include \$52 million for implementation of the Jason Simcakoski Memorial and Promise Act, or "Jason's Law." Signed into law in 2016, Senator Baldwin's bipartisan legislation earned the support of the Simcakoski family, Disabled American Veterans (DAV), Veterans of Foreign Wars (VFW), The American Legion, and other veterans service organizations. Jason's Law is holding the U.S. Department of Veterans Affairs (VA) accountable, strengthening oversight of the VA's opioid prescribing practices and providing safer care for our veterans.

Earlier this year, Senator Baldwin secured full funding for implementation of Jason's Law in the FY2018 omnibus spending bill signed by President Trump.

Jason's Law strengthened the VA's Opioid Safety Initiative, and in Wisconsin the bipartisan reform has helped the Tomah VA Medical Center achieve a 47 percent decrease in the number of veterans on chronic opioids. For veterans on opioids and benzodiazepines, there has been a 76 percent reduction.

Funding for Opioid Treatment and Prevention

Senator Baldwin secured a significant increase in opioid treatment and prevention funding to support veterans receiving care at the VA.

The bipartisan bill includes \$18 million to implement Opioid Treatment and Prevention programs Senator Baldwin got included in the VA MISSION Act that President Trump recently signed into law. The funds will be used to expand treatment options for veterans and develop programs aimed at ensuring non-VA providers treating veterans through Care in the Community programs are held to the same standards set by Jason's Law.

Improving Inspector General Operations

The FY19 MILCON/VA Appropriations bill includes \$192 million for the Office of the Inspector General (OIG), which is a \$28 million increase from the President's request. This funding will help ensure the OIG does not have to reduce its staff and will allow them to improve their oversight responsibilities over the VA's budget and initiatives.

The bipartisan legislation also includes an amendment cosponsored by Senator Baldwin to ensure that the VA OIG can investigate, audit and conduct oversight of the nation's largest health care system without being hindered by political delays, non-cooperation and stall tactics by the VA.

Increased Funding Opportunities to Help Homeless Veterans

In her role on the Appropriations Committee, Senator Baldwin has fought for funding to help reduce veteran homelessness in Wisconsin. This legislation includes \$1.8 billion for VA Homelessness programs and \$450 million for the Supportive Services for Veterans Families program.

In addition, Senator Baldwin helped secure \$40 million in the Transportation, Housing and Urban Development Appropriations bill for 5,100 new HUD-Veterans Affairs Supportive Housing (VASH) vouchers. These vouchers combine rental assistance for homeless veterans with clinical services provided by the VA and are critical to reducing veterans' homelessness.

Enhanced Research for Illnesses Affecting Gulf War Veterans

Gulf War Veterans claiming disability get denied at much higher rates than average. In fact, according to the U.S. Government Accountability Office, only 17 percent of claims get approved.

That is why Senator Baldwin worked to include language that directs the VA to improve approval rates, including through the streamlining of the claims process and better training of claims processing personnel. She also included report language recommending the VA continue Gulf War Illness research and make the findings public, along with improve training for providers on the illness.

Prioritizing Military Construction

The bipartisan MILCON/VA Appropriations legislation funds 169 military construction projects, totaling \$10.3 billion. This includes \$23 million for construction of a new barracks and \$6.2 million for the ongoing construction of new family housing units at Wisconsin's Fort McCoy.

Badger Army Ammunition Plant

Public health hazards and negative ecological impacts have occurred at former military sites like the Badger Army Ammunition Plant, which is why Senator Baldwin included report language to accelerate cleanup efforts at the plant. The legislation directs the Army to work with local stakeholders and to consider the construction of a municipal drinking water system to support the Town of Merrimac.

West Nile virus monitoring in ruffed grouse to begin

MADISON -- In collaboration with the Minnesota and Michigan Departments of Natural Resources, Ruffed Grouse Society, and Wisconsin Conservation Congress, the Wisconsin Department of Natural Resources will begin a multi-year monitoring program this fall looking at West Nile virus (WNV) in ruffed grouse.

The DNR is asking ruffed grouse hunters for their participation in this monitoring effort. Similar to past disease monitoring efforts, the department is asking that hunters submit samples from their harvested ruffed grouse using self-sampling kits. This effort will focus on the core ruffed grouse range in the central and northern forests.

The DNR has assembled 400 self-sampling kits for ruffed grouse hunters to use in 2018. The WNV sampling kits contain detailed instructions and all the supplies needed to collect and ship one sample. Hunters will be asked to collect a small amount of blood along with the heart from their harvested grouse.

If you hunt the central and northern forests and would like to participate in the West Nile virus monitoring effort, sampling kits can be requested through your county wildlife biologist and will be available in early September. The number of kits provided per individual may be limited to ensure samples come from a large geographic area.

Hunters will be provided test results via email. Be aware that testing of samples will not begin until after the grouse season has closed and final results will not be available for several months after the close of the season.

WNV is transmitted by the bite of an infected mosquito and there is no evidence that WNV can be spread by handling dead birds or by consuming properly cooked game. It is one of several bird diseases afflicting native bird species.

Sick and Dead Birds

In addition to collecting samples from harvested ruffed grouse, the DNR is asking the public to report any sick or dead grouse observed while out in the field.

If you see any ruffed grouse that appear sick or emaciated, or if you find a freshly dead grouse, take note of the location and promptly call your county wildlife biologist for possible submission of the dead grouse for further investigation and to help us keep track of such reports statewide.

If you are willing to collect the carcass testing, please keep the entire bird intact. Place it into a plastic bag and keep the bird cool, but not frozen. Bring the whole ruffed grouse carcass to your county wildlife biologist the same or next day. Prompt collection of ruffed grouse is necessary to prevent decomposition or scavenging. It is recommended you wear gloves whenever handling dead animals, even those that appear healthy.

If refrigeration and prompt delivery are not possible, carcasses should be frozen and submitted to county wildlife biologists as soon as possible.

Carcasses in poor condition (scavenged with openings into the body cavity, having an odor, more advanced decomposition) will not be usable for testing, but please take note of the location and report these sightings to your county wildlife biologist.

Be prepared!

September is National Emergency Preparedness Month. The Forest County Health Department would like to take this time to give our community members pointers in being prepared for emergencies that could happen.

We all like to think that we will never have to be faced with a weather related emergency such as storm related power outages, floods, tornados or a public health threat such as disease outbreaks or have to deal with the after effects of a hazardous material spill or a forest fire. But what if we do? The best things we as a community can do is be aware and be prepared.

Here is a list of things to do: Create an emergency plan for your family, include a checklist of what needs to be done and assign tasks to each member.

Keep an emergency phone list that includes numbers for a doctor, the emergency department, fire and police.

Note local TV channels and radio stations with frequent news broadcasts.

Check the Forest County Website for information on emergency situations.

Create a Three Day Emergency Kit. Go to <http://ready.wi.gov> for info on what to have in your three day emergency supply kit.

Have a Buddy system in place. A Buddy system can be set up with neighbors, friends or family. Plan ahead for how you will help each other in an emergency. Give your buddy a key to your home.

300 Wisconsin grouse to be moved to Missouri

Wisconsin Department of Natural Resources staff and the Missouri Department of Conservation will collaborate on ruffed grouse restoration efforts to translocate 300 ruffed grouse from northern Wisconsin to the River Hills region of east-central Missouri over a three-year period (2018-2020).

Ruffed grouse are a native species in Missouri, but their numbers have declined precipitously over the last several decades as forests have aged. Extensive habitat management has been conducted in the River Hills region of Missouri to maximize success. Missouri Department of Conservation has laid out a long-term plan to continue to create and maintain young forest habitat for grouse into the future.

Trapping will occur in Lincoln, Price, Sawyer, Taylor, and Rusk counties. Trapping pressure will be spread across county and state-managed properties to minimize any localized impacts. Trapping will occur from Aug. 15 to Sept.15, with an option to extend trapping activities if the annual capture goal (100 birds per year over three years) is not reached.

Translocation efforts involving 100 birds annually over a three-year period represent 0.05 percent of the 2017 estimated ruffed grouse harvest. Translocation efforts are not expected to have any impacts on the statewide ruffed grouse population.

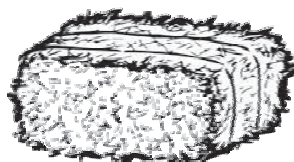

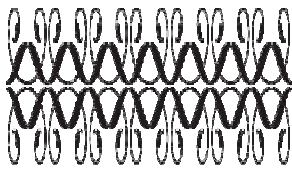

Play by the Rules Act Holds China Accountable for Ignoring Trade Rules and Harming American Workers and Businesses

WASHINGTON, D.C. - U.S. Senators Tammy Baldwin (D-WI) and Shelley Moore Capito (R-WV) today introduced the bipartisan Play by the Rules Act to crack down on unfair trade cheating from nonmarket economies like China.

"China has refused to play by the international trade rules they agreed to and they should be held accountable," said Senator Baldwin. "This bipartisan legislation will give the Commerce Department the flexibility it needs to take stronger actions that protect American workers and businesses against China cheating."

"Fair trade rules and policies help protect U.S. jobs and ensure economic growth in our country. Unfortunately, there are times that non-market economies refuse to adhere to those policies or manipulate the system to put the United States at a disadvantage. When that happens, it's important that we hold those countries accountable to ensure we are putting American jobs and the American economy first," Senator Capito said. "This bipartisan legislation will provide the Commerce Department the flexibility it needs to hold bad actors accountable and ensure that our trade policies are followed and respected."

Our anti-dumping (AD) and countervailing (CVD) duty laws are designed to stop trade partners from tipping the scales in their favor and forcing American workers to compete at a disadvantage. These laws allow U.S. customs officials to collect duties on foreign imported products that are sold below market value or produced with unfair government subsidies.

AD/CVD rules are widely used and mostly followed by WTO members. However, nonmarket economies—like China—are engaged in a sophisticated and government-backed effort to avoid paying the duties required by these rules at the expense of American workers and businesses.

The Play by the Rules Act provides the Commerce Department additional flexibility when reviewing anti-circumvention petitions filed against nonmarket economies like China. This flexibility will allow Commerce to better combat China's attempts to cheat our workers and businesses.

Last year, Columbia Forest Products filed a successful AD/CVD case against dumped hardwood plywood from China, allowing the company to rehire workers at its facilities in Mellen, Wisconsin and Craigsville, West Virginia. However, China is now circumventing the order by shipping a softwood plywood that mimics the characteristics of hardwood plywood, but is not included in the AD/CVD order Columbia Forest Products lost their petition at the Commerce Department to adjust the duties.

"The Chinese government has subsidized plywood dumped by Chinese companies in American markets. Last year, the U.S. took action and assessed anti-dumping duties, which allowed Columbia Forest Products

Free Security Freezes Coming Soon By the GWAAR Legal Services Team

Starting this fall, a new law will require the big three credit reporting agencies – Equifax, Experian and TransUnion – to let you freeze your credit report for free. Credit freezes, also known as security freezes, restrict access to your credit report. Security freezes are often recommended for individuals who have been the victim of identity theft or whose personal information was released in a security breach.

If your credit report has been frozen and you, or an identity theft, apply for a new loan or credit card in your name, the bank will not be able to check your credit report. Without access to your credit report, the bank will deny the application. If a security freeze is in place and you want to apply for a loan or credit cards or open a new bank account, you will have to ask each credit reporting agency to unfreeze your credit report.

In many states, the credit reporting agencies can charge a fee to freeze and unfreeze credit reports. Although credit reporting agencies may waive these fees for victims of identity theft who provide a copy of a police report, other individuals are required to pay anywhere from \$3 to \$10, depending on their state's laws. Because individuals must request a security freeze with each credit reporting agency, their total cost could be as much as \$30 each time they request a security freeze or ask for a freeze to be lifted.

The new limits security freezes to only impact businesses requesting consumer information for credit purposes. That means that parties requesting credit reports for employment background checks, tenant background checks, or insurance policies will still have access to credit information when a security freeze is in place. The law also does not apply to existing creditors or debt collection agencies who are reviewing accounts or collecting money that is owed to them.

The new law goes into effect on September 21, 2018. This will give the credit reporting agencies time to update their websites to make it easy for you to request a free credit freeze or ask to lift a freeze.

Keep in mind that, although security freezes can be useful, they do have some limitations. For example, a freeze should prevent an identity thief from opening a new credit card in your name, but it will not stop someone who has access to an existing account from using it. In addition, a security freeze will not prevent tax identity theft, which occurs when someone files a tax return in another person's name. You should check your bills regularly for mistakes and review your credit reports every year to make sure there are no errors.

Flu Season 2018-2019

Studies show Flu Vaccine Reduces Risk of Severe Illness: A new CDC-supported study conducted over multiple flu seasons and published in Vaccine shows that getting a flu shot lessened the risk of severe influenza among adults, including reducing the risk of hospitalization and admission to the intensive care unit (ICU), and also lessened the severity of illness. CDC recommends an annual flu vaccine for everyone 6 months and older. Annual flu vaccination varies in how well it works, but it is the best available way to prevent flu and its potentially serious consequences.

The study was conducted over four flu seasons from 2012 to 2015 and found that flu vaccination prevented severe disease:

- ** Flu vaccination among adults reduced the risk of being admitted to the hospital with flu and placed in a general ward bed by 32%.
- ** Flu vaccination was even more effective in preventing the most severe forms of flu and reduced the risk of being admitted to an ICU with flu by 82%.

And because some people who get vaccinated still get sick, the study also looked at the question of whether a flu vaccine reduces illness severity in those people and found that, yes, flu vaccination did reduce severity and duration of flu illness. Try these strategies to prevent getting the flu this year: Avoid close contact with people who are sick and stay home when you are sick. Cover your mouth and nose with a tissue or into your elbow when coughing or sneezing. Wash your hands often with soap and water or an alcohol-based sanitizer. Clean or disinfect surfaces that are touched often at home, work, or school. Get plenty of sleep, stay physically active, eat nutritious foods, drink plenty of fluids.

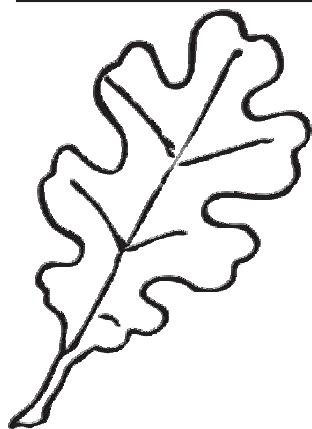

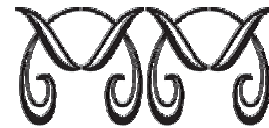

Ed Smith INSURANCE TIP From the Commissioner of Insurance

Most homeowner's policies do not cover flooding or seepage through the foundation. A separate flood insurance policy sold through the **National Flood Insurance Program** is necessary for this coverage.

Damages from sewer backup or sump pump overflow is not covered by standard homeowner's insurance or flood insurance. The purchase of a special endorsement for your homeowner's policy is required for this type of coverage. Most comprehensive auto policies provide coverage for vehicles damaged in a flood. But if you purchased a collision-only policy, you may not have coverage. Make a detailed list of all damaged or lost personal property.

1. Take photos of the damage. Your adjuster will need evidence of the damage as he investigates your claim.
2. Keep swatches of damaged material, such as carpeting, curtains, and furniture. For more information on completing a home inventory, visit oci.wi.gov/Pages/PressReleases/20120615HomeInventory.aspx
3. Do not throw out any damaged property without you claims adjuster's agreement. If local officials require you to dispose of damaged items for safety reasons before your claims adjuster's inspection, the photos you take of the damage will be extremely useful for your claim.

and Vilas Counties) with a second management area added in Price County. These 18 areas comprise over 95,000 acres of habitat managed to promote ruffed grouse and American woodcock populations and provide fall hunting as well as year-round wildlife viewing opportunities.

The 29 individual county forests in the state collectively make the county forest system the largest public land base in Wisconsin with over 2.4 million acres, yet are often overlooked by grouse hunters, especially those not familiar to the area. Jane Severt, Executive Director of the Wisconsin County Forests Association (WCFA) states, "We are proud of the forest management work being conducted by our member county forest staffs that include the largest acreage of young forest habitat in the state, approximately 887,000 acres. This young forest habitat provides the critical cover and food resources needed for

ruffed grouse and woodcock populations to thrive."

"We appreciate the help and support of the Ruffed Grouse Society and the Wisconsin Department of Tourism working with WCFA to promote these special hunting opportunities. While our member counties routinely handle the difficult job of managing forest habitat, time and funding to inform others of these opportunities has often been limited," Severt added.

Key to this promotional program was the development of a web based interactive map tool that grouse and woodcock hunters can use both in their homes and in the field to plan or conduct hunting excursions.

This tool provides in-depth locations and background information on 18 cooperative ruffed grouse habitat management areas in 17 different Wisconsin County Forests and is housed on the WCFA website at <http://www.wisconsincountyforests.com/grouse>. These areas range in size from 600 to over 25,000 acres providing hunters with their choice of hunting opportunities. Some have more extensive hunter walking trail systems while others are more suited for hunters wanting to get off the beaten tract. Two areas include designated All-Terrain Vehicle Trails systems within their borders providing another means of access to portions of these areas. These sites are located all across northern and western Wisconsin and include much of the state's primary ruffed grouse range. Hunters have the opportunity to travel from area to area or concentrate on one or two management areas in a particular region of the state.

Information provided for each management area includes driving instructions, GPS coordinates for trailheads/parking areas, acreage of units, length of hunter walking trails, nearest towns with food, gas or lodging and local contacts for information about the county forest, chamber of commerce and closest veterinary services. In addition, downloadable maps of the individual grouse management areas are provided for each site. These maps identify the management area boundaries, parking lots, and hunter walking trail systems with many including maps with breakdowns of forest types and aspen age classes that should prove very useful to perspective hunters.

"We encourage grouse and woodcock hunters to utilize the information provided by this promotional program and take the opportunity to enjoy Wisconsin's County Forests this fall," reports Kevin Kleinschmidt, Lincoln County Forest Administrator.

This link includes contact information for each county forest administrator's office whose staff consists of field foresters with a great deal of information about the local county forest they manage.
