### Septic System Inspections and Maintenance-Your Responsibility to Protect our Water!

Our article today comes from our neighbors at the County Zoning Department with respect to State requirements to provide regular inspections for Private Onsite Wastewater Treatments Systems (POWTS), which people commonly recognize as septic systems.

In 2008, the State of Wisconsin, under §145.20(5) established a maintenance program to be administered by governmental units responsible for the regulation of all POWTS. Each governmental unit responsible for the

regulation of private onsite wastewater treatment systems was required to adopt and begin the administration of the program before October 1, 2019. The Forest County Zoning Department is the responsible unit for this regulation. As part of adopting and administering the program the Zoning Department is required, by state, to conduct and maintain an inventory of all the POWTS located within the county. The law also requires verification of inspection of systems once every three (3) years. Landowners should be aware that the law requires visual inspection once every three years. Inspection must be completed by a licensed POWTS inspectors, licensed POWTS installers or licensed septic pumping companies.

POWTS pumping, on the other hand, is required when the anaerobic treatment tank (septic tank) levels of sludge and scum volume equals 1/3 of the tank volume. Pumping is not required on a 3 year schedule, pumping requirements are based upon sludge and scum accumulation within the tank. A common misconception is that the maintenance program requires pumping, which is false. Note that it is sometimes more convenient and cost effective to have inspections and pumping done at the same time.

It is that time of the year again! Zoning has developed a system to provide notice and inspection

The Holt and Balcom Logging Camp Museum staff is busy preparing for its 2019 Summer Season. Camp curator and school tour coordinator Bob Brown reports that five elementary schools (Gillette, St. John Lutheran-Suring, Suring, White Lake, and Wabeno), have already booked visits for May and June.

One of the favorite activities included in the tours is a side-trip to the Cathedral Woods, an historic stand of virgin pine and hemlock located near Lakewood off Highway 32 and Archibald Lake Road. The spectacular historic site was set aside for posterity by W.A. Holt as a gift to his wife, Lucy, who spent summers vacationing on their nearby island in Archibald Lake.

Lucy and her children often rowed across the lake and hiked to the secluded site. Shaded by majestic white pines and hemlock, Lucy considered it the perfect spot for Bible study and prayer. Lumberjacks who observed this ritual took to calling the area a cathedral in the woods. The name stuck. Today the site is officially known as Cathedral Woods, but many locals call it Cathedral Pines.

Though not on staff at Holt & Balcom, Nicole Shutt has been guiding students on a Nature Walk there for several years. A USDA Forest Service biological science technician, Nicole is posted at the Lakewood Ranger

## Two drug arrests and a life saved in Forest County

#### Grants available to promote area events

## legislation for research on CWD Senators Working to Provide Tools to Stop Spread of Fatal,

**Contagious Disease in Deer, Elk Herds** WASHINGTON, D.C. – U.S. Senators Tammy Baldwin (D-WI) and John Hoeven (R-ND) introduced the Chronic Wasting Disease Research Act, bipartisan legislation to establish a Chronic Wasting Disease (CWD) research grant program. CWD, which poses a serious threat to deer populations, is a fatal and contagious neurological disorder that has been documented in both captive and live herds in 26 states across the country, including Wisconsin.

"In Wisconsin, we have a proud, longstanding tradition of hunting and enjoying the great outdoors. But season after season, our sportsmen and women continue to deal with the presence of Chronic Wasting Disease in new areas," said Senator Baldwin. "It's clear we need to invest more federal resources in researching how to stop the spread of this deadly wildlife disease that threatens Wisconsin's hunting traditions and our deer herds. I'm proud to join Senator Hoeven and provide our state and tribal partners the tools they need to take on this disease." The Department of Veterans Affairs will not appeal a January court ruling that ordered it to provide health care and disability benefits for 90,000 veterans who served on Navy ships during the Vietnam War, likely paving the way for "Blue Water Navy" sailors and Marines to receive Agent Orange-related compensation and VA-paid health care benefits.

VA Secretary Robert Wilkie told members of the Senate Veterans Affairs Committee in March 2019 that he will recommend the Justice Department not fight the decision, handing a victory to ill former service members who fought for years to have their diseases recognized as related to exposure to the herbicide Agent Orange.

This new turnaround by the VA could allow service connected compensation to be paid to tens of thousands of veterans who served on Navy ships during the Vietnam War

Veterans and their advocates had argued that the ships' distilling systems used Agent Orange-tainted seawater, exposing sailors on board to concentrated levels of dioxin.

"North Dakota has a rich outdoor heritage with many sportsmen participating in the annual deer hunt. Chronic Wasting Disease threatens deer populations in North Dakota and across the nation, however very little is known about this fatal disease," said Senator Hoeven.

"This legislation provides grants to help bolster research into prevention and management efforts to stop this very contagious disease from impacting not only our sportsmen by protecting deer in the wild, but also our deer farmers."

Specifically, the bill authorizes up to \$15 million annually for CWD research, such as:

· Detection and decontamination of disease in deer;

· Long-term suppression and eradication of CWD; and

· Determining markers for genetic resistance.

Entities eligible for the research grants include universities, state and tribal departments of agriculture, research facilities conducting CWD research, as well as tribal research facilities. The diseases considered presumptive to Agent Orange exposure, according to the VA, are AL amyloidosis, chronic B-cell leukemia, chloracne, Type 2 diabetes, Hodgkin's lymphoma, ischemic heart disease, multiple myeloma, non-Hodgkin lymphoma, Parkinson's disease, early onset peripheral neuropathy, porphyria, prostate cancer, respiratory cancers and soft tissue sarcomas.

There are still many Vietnam veterans who do not know this information. If you are a Vietnam veteran or know one who might have any of the above conditions, please share this information. It's never too late to file a claim for a presumed disability.

If you are a widow of a Vietnam veteran who died of any of the conditions listed above, there may be survivor benefits for you even if the veteran wasn't service connected at the time of his death. If in doubt, please call my office.

citations for failure to comply. Owners that failed to comply with maintenance requirements in 2018 will receive a citation this June if compliance requirements are not met.

Another item to note is that sellers of property should be aware that compliance with the mandatory maintenance program does not exempt you from real estate inspection requirements in the law. The sources of drinking water, both tap water and bottled water, includes rivers, lakes, streams, ponds, reservoirs, springs and wells. As water bravels over the surface of the land or through the ground, it dissolves naturally occurring minerals and, in some cases, radioactive material, and can pick up substances resulting from the presence of animals or from human activity.

Contaminants that may be present in source water include:

 Microbial contaminants, such as viruses and bacteria, which may come from sawage treatment plants, septic systems, agricultural livestock operations and wildlife.

 Inorganic contaminants, such as saits and metals, which can be naturally-occurring or result from urban storm water runoff, industrial or domestic wastewater discharges, oil and gas production, mining or farming. - Pesticides and herbicides, which may come from a variety of sources such as agriculture, urban storm water runoff and residential uses.

## LOTTERY CREDIT STILL AVAILABLE

The Forest County Treasurer's Office is dedicating the week of May 13 to help all Real Property Owners who were eligible, receive the lottery credit on their 2018 tax bill. To qualify for the lottery and gaming credit an owner must be a Wisconsin resident, the owner of the dwelling, and use the dwelling as their primary residence as of the certification date January 1, 2018.

If temporarily absent no longer than six months (hospital, vacation, incarcerated, etc.) to which the owner returns. Principal dwelling means any dwelling used by the owner of the dwelling as his/her primary residence. Business property, rental units, vacant land, garages, or other property that is not the primary residence of the owner cannot claim a lottery credit. Sec.79.10 (1)(dm), (9)(bm), Wis., Stats.

#### WisDOT Secretary: Now is the time to invest in our roads, economy and future

Addressing our growing transportation needs has become a hotly-debated topic at the state and national levels. In Wisconsin, Governor Tony Evers' proposed transportation budget offers a responsible and urgentlyneeded path forward to address an issue that has been studied, debated, avoided and delayed for well over a decade.

One issue that's no longer open for debate is the overall decline in pavement conditions. Anyone who analyzes pavement condition reports or regularly drives Wisconsin roads will come to the same unavoidable conclusion: pavement conditions across our state are worsening. And without prompt action, we can expect that trend to continue.

Finding consensus on a long-term transportation funding solution has proven elusive, sending policymakers down an ill-advised path of least resistance: borrowing. Currently, close to 20 percent of Wisconsin's transportation revenues are used to pay off debt service (compared to about 10 percent in 2006). While bonding has a role in funding larger, long-term projects, it is clearly on an unsustainable trajectory in Wisconsin.

In response to these challenges, Governor Evers has provided a comprehensive strategy to break this decade-long impasse. Many of these same concepts were unanimously endorsed by the state's bi-partisan Transportation Finance and Policy Commission established under Governor Walker back in 2011. Key components of Governor Evers' transportation budget:

\*an 8-cent increase in the state motor fuel tax costing the average Wisconsin driver \$3.30 per month (comparable to a Mocha Frappuccino at a popular coffee venue)

\*\*restarting gas tax indexing to keep pace with inflation increasing heavy truck fees, original and transfer title fees In return, Wisconsin can finally begin making long-overdue investments in its multi-modal transportation system with an emphasis on preserving existing infrastructure in every part of the state:

\*\*\$320 million increase for state highway rehabilitation \$66 million increase in general transportation aids to ease pressure on municipalities

\*\*finishing work on the Zoo Interchange, Wisconsin's largest, most economically-vital interchange

investments in public transit, elderly and disabled transportation services, freight and passenger rail, airports and harbors

For many decades, motor fuel taxes have functioned adequately as a user fee to support transportation needs - and they remain a viable funding source into the foreseeable future. Most importantly, the time to act is now. Adjusting the motor fuel tax involves no administrative or infrastructure costs and can be implemented promptly to address our pressing needs.

Since 2013, 30 states have agreed on funding plans to support needed investments in transportation services and infrastructure. In each of those states - red and blue this involved adjusting motor fuel taxes. Under Governor Evers' leadership and with a willingness from state policymakers, Wisconsin is finally positioned to make a similar investment in our state's transportation network that will support public safety and mobility, economic growth and our quality of life.

## **Overcoming Addiction workshop** May 17 at Nicolet

Leading experts on addiction from across the state will present the first of three workshops in the Overcoming Addiction Together series from 8:30 a.m. to 1 p.m. Friday, May 17, in Northwoods Center 208 at Nicolet College.

The series will launch with the Working Together Towards Understanding Addiction and Facilitating Recovery workshop. Dr. David Mays, a clinical faculty member at the University of Wisconsin-Madison, will give the plenary address and provide closing remarks.

"It is only in the last 20 years that we have had the tools to understand the physical mechanisms by which addiction can change people's brains, distort their personalities and cripple their will power," Dr. Mays wrote describing his presentation. "Although there is still much to learn, what insights we have can lead to novel treatments and increase our compassion for those who suffer from this disease."

During the session the audience will be introduced to the latest medical understanding of addiction including epidemiology, brain mechanisms, social neuroscience insights, and evidence for treatment. Workshop participants will then choose two of three breakout sessions. These will include:

SBIRT (Screening, Brief Intervention, and Referral to Treatment) Training, presented by Laura Saunders, MSSW, with the Great Lakes Addictions, Mental Health and Prevention Technology Centers and State Project Manager for the State of Wisconsin.

Introduction to Motivational Interviewing, with Mia Croyle, MA, a behavioral health specialist with Metastar.

Medication Assisted Treatment (MAT), presented by Michael Larson, Ph.D., a clinical psychologist in pain management with the Marshfield Clinic.

Dr. Mays will then provide closing remarks.

"Addiction is a long-term life threatening illness. Resuscitating an overdose victim is only the beginning step in saving a life," he said. "Treating the causes of addiction and providing the ongoing support for people who are struggling to recover requires the coordinated effort of emergency responders, healthcare providers, service workers, and others in the community Cost is \$20 for one workshop or \$50 for all three. Topics of future workshops include Building Resilient Families and Communities: Moving Beyond Trauma/ACEs and Addiction Friday, July 19, and Taking Care of Ourselves as We Care for Others, Friday, Aug. 16. Professionals working in addiction fields well as members of the general pubic are invited to attend. All workshops will also be held in Wausau a day prior to the workshops at Nicolet.

investigation at the residence and determined the male subject had overdosed after ingesting Fentanyl. Detectives located more fentanyl and drug paraphernalia at the residence.

During the investigation several people were interviewed, there were multiple search warrants executed for cell phone and social media data and reviews of video surveillance footage.

On May 6, 2019 based on all of the evidence gathered Brandon Pridgeon 31 years old of Milwaukee, WI and Shavonn Tuckwab 19 years old of Crandon, WI were both taken into custody for Felony 2nd degree Reckless Endangerment and Felony Delivery of Schedule I Narcotics. Both subjects are currently being held in the Forest County Jail.

The Forest County Sheriff's Office would like to credit the Mole Lake Casino Surveillance and Sokaogon Chippewa Community Members for their assistance with this investigation.

This is an ongoing investigation and more arrests may be forthcoming.

By the GWAAR Legal Services Team (for reprint) Whether or not you receive Supplemental Nutrition Assistance Program (SNAP) benefits through Wisconsin's FoodShare program, we could all use extra tips and reminders for smart food shopping. This article offers suggestions on how to stretch your food dollars by planning ahead, budgeting, making smart food choices, and preparing low-cost recipes.

**BEFORE Shopping** 

• Plan your weekly meals and snacks. Preparing in advance will help you know what you need and also help you put leftovers to good use.

· Use store circulars and go online to look for coupons, sales, and store specials. Only use coupons to buy foods you normally eat. Make sure the coupons give you the best value for your money.

#### VEGETABLES

choosing canned vegetables, look for "low sodium" or "no peas and carrots, bread stick, raspberry lemon bar added salt" on the label.

FRUITS

• Buy fresh fruit in season - it generally costs less. Frozen and canned fruits are available year-round, can save you money, and have similar nutrition values to fresh fruit.

LOW-FAT OR FAT-FREE MILK PRODUCTS

• Buy low-fat or fat-free milk, yogurt, and cheese in the largest size that can be used before spoiling. Typically, larger containers cost less per serving than smaller sizes. Ultra-pasteurized milk found on store shelves has a longer expiration date and won't spoil as fast.

#### MEAT AND BEANS

· Dried beans and peas are a good source of protein and fiber. They can last a year or more without spoiling. Canned tuna packed in water is an inexpensive broccoli, fruit, bread stick, ice cream healthy protein choice. 




