Gov. Evers, DHS announce updated Mass Gatherings Order

Gov. Tony Evers today directed Department of Health Services (DHS) Secretary-designee Andrea Palm to issue updates to the previous order prohibiting mass gatherings of 10 or more people. The updated order maintains the ban on gatherings of 10 or more people and indefinite school closures, but includes some important changes and clarifications.

Gov. Evers Suspends Utility Rules and Allows for Additional Consumer Protections

The governor signed an executive order on Sunday that will suspend numerous rules related to utility service providers. In a news release, Gov. Evers said, "it is critically important to give people flexibility during this emergency, when paychecks might be disrupted, to keep the lights and heat on and water flowing."

The governor's order does the following:

- Stop utility disconnection for nonpayment for all customers, including commercial, industrial, and farm accounts. Previously this applied to residential accounts only;
- Cease assessing late fees to customer accounts;
- Halt the practice of requiring deposits from customers for reconnection of service;
- Allow deferred payment agreements for all customers who request them;
- Remove any administrative barriers for customers establishing or reestablishing utility service; and
- Authorize water utilities to provide budget billing arrangements to customers. Electric and natural gas utilities are allowed to do this under current rules.

Gov. Evers directs DHS to issue Safer at Home Order

On March 24, 2020, Wisconsin Governor Tony Evers directed Department of Health Services (DHS) Secretary-designee Andrea Palm to issue a Safer at Home order that prohibits all nonessential travel, with some exceptions as clarified and defined in the order. The order is effective 8 a.m. on Wednesday, March 25, 2020, and will remain in effect until 8 a.m. Friday, April 24, 2020, or until a superseding order is issued.

"I know the COVID-19 outbreak has been difficult and has disrupted the lives of people across our state. Issuing a Safer at Home order isn't something I thought we'd have to do and it's not something I take lightly, but here's the bottom line: folks need to start taking this seriously," said Gov. Evers. "Each and every one of us has to do our part to help slow the spread of COVID-19 so we can flatten the curve to ensure our doctors, nurses, and healthcare workers have the opportunity to do their important work. Let's all do our part and work together."

Individuals do not need special permission to leave their homes, but they must comply with this order as to when it is permissible to leave home. Similarly, if a business is an Essential Business or Operation as defined in this order, it does not need documentation or certification to continue its work that is done in compliance with this order.

Under this order, Wisconsin residents are able to:

- ** Perform tasks essential to maintain health and safety, such as obtaining medicine or seeing a doctor;
 - ** Get necessary services or supplies for themselves or their family or household members, such as getting food and supplies, pet food, and supplies necessary for staying at home;
 - ** Care for a family member in another household; and
 - ** Care for older adults, minors, dependents, people with disabilities, or other vulnerable persons.
- Businesses allowed to operate under the Safer at Home order include, but are not limited to:
- ** Health care operations, including home health workers;
 - ** Critical infrastructure;
 - ** Businesses that provide food, shelter, and social services, and other necessities of life for economically disadvantaged or otherwise vulnerable individuals;
 - ** Fresh and non-perishable food retailers, including convenience stores, grocery stores, farmers' markets, and food banks;
 - ** Businesses that ship or deliver groceries, food, and goods directly to residences;
 - ** Pharmacies, health care supply stores, and health care facilities;
 - ** Child care facilities, with some limitations;
 - ** Gas stations and auto repair facilities;
 - ** Banks;

To help minimize the impact of COVID-19, we're limiting visitors in our hospitals. Beginning March 21, 2020, in-person visitation has been temporarily stopped. We encourage family members and friends of patients in our care to stay connected with their loved ones by virtual visitation. Our goal is to protect our associates and those we are privileged to serve by limiting possible exposure to COVID-19 and directing people to the right level of care.

There will be some exceptions on a case-by-case basis, including labor and delivery, pediatrics, neonatal intensive care (NICU) and end-of-life care.

We understand that during this time it is important to stay connected to loved ones and remain aware of their status while hospitalized. We encourage any potential visitors to use alternate methods of communication to stay in contact with loved ones, such as calling, video chatting, or texting.

The following apps can be used to help people connect virtually with their loved ones: Facebook Messenger, Facetime, Google hangouts, Google Duo, WhatsApp, Skype, Viber or Signal. These can be downloaded in either the App Store (iPhone) or the Play Store (Android). Both patient and visitor will need to download the same application. Access to guest wi-fi at Ascension Wisconsin facilities is available by connecting to AH-Guest.

I appreciate the opportunity to provide some background on my qualifications to serve as a supervisor on the Forest County Board of Supervisors. I wish to emphasize my leadership experiences and qualifications to serve in this capacity.

I graduated high school from Waverly Central High School in Waverly Tennessee in 1971. Within weeks of graduation I reported to Marine Corps boot camp at MCRD Parris Island, SC. I was initially assigned as a Military Police officer but also served as a Presidential Security officer for President Richard Nixon from 1971-1974. During this time frame I was promoted to the rank of Sergeant (E-5/USMC). In 1974 following the resignation of President Nixon I became an Intelligence Analyst (E-6). From 1974-1978 I served as an Intelligence Analyst for the 3rd Marine Aircraft Wing (HMH-361) at the Marine Corps Air Station- El Toro, CA and 1st Marine Aircraft Wing (ACI) in Okinawa, Japan. From 1978 to 1982 I was assigned as a Counterintelligence Specialist with the 1st Marine Division at Camp Pendleton, CA.

Following nearly 11 years of Marine Corps active service I was selected for a commission in the US Navy as a Surface Warfare Officer (SWO). I graduated from Officer Candidate School in Newport RI in 1982 and was promoted to the rank of Ensign- USN. From 1982 through 1993 I served in numerous leadership positions covering Surface Warfare; Naval Shore Patrol; Communications; Administration and finally as a Combat Systems Officer in Washington DC.

During my 22 years of active military duty I obtained my BA degree in Criminal Justice from Chapman College in California and my MS degree in Forensic Sciences from National University also in California. I completed 18 months of Law School (JD) from National University before having to stop due to military duties. I retired from the US Navy in 1993 at the rank of Lieutenant (O-3E).

Within days of retirement from the Navy I started working as a Criminal Investigator in the Office of the Vilas County District Attorney in Eagle River. I remained in that position from 1993-1998 when I transferred to the Dane County Sheriff's Office in Madison, WI where I was assigned as a deputy sheriff. I remained in this position from 1998-2008 when I retired again.

In November 2008 I commenced working part-time as a deputy sheriff with the Forest County Sheriff's Office. I worked in Forest County until September 2019 when I retired again.

This broad range of experience has allowed me to perform my duties more competently with a greater knowledge and understanding of leadership and management required for a position on the county board.

Vet's Corner

MISSION ACT QUICK REFERENCE GUIDE

Hospital Emergency Room (ER) Visits Please ensure you contact the VA within 72 hours of reporting to an ER if you would like to have VA considered as payee. Mission Act criteria must be met before final approval is made: 1) Report to an in-network ER facility; 2) Services deemed emergent by prudent lay-person; 3) VA received notification within 72 hours of reporting to ER.

Urgent Care To use your urgent care benefits you should call 1-833-4VETNOW (1-833-483-8669) to verify you are eligible for urgent care services. You do not need to contact the VA. You must go to an in-network facility and verify they are in-network at the time you report as these facilities may change daily.

Pharmacy Reimbursement Prescriptions written by a Community Care Provider under VA authorization must be presented to a VA facility for dispensing, or you may fill at an outside pharmacy at your own expense. Prescriptions can be sent to the VA via fax, paper mail, e-prescription or hand carried. The medications prescribed must be related to authorized services and follow the Veterans Health Administration (VHA) Formulary Management Process.

Questions regarding prescriptions or the formulary may be directed to the VA pharmacy at (800) 805-1870. Prescriptions may only be filled by a non-VA pharmacy when the medication is needed promptly to treat an emergent or urgent medical condition; in such instances, You may use a participating community pharmacy to obtain up to a 14-day supply of medication at no charge, or you may fill at any pharmacy and submit for reimbursement. To receive reimbursement you must submit the medication slip with your name, the name of the medication, prescription number and quantity received as well as a copy of the paid receipt. This should be sent to VAMC-Office of Community Care; 325 East H Street; Iron Mountain, MI 49801. When appropriate, Community Care Providers should write two prescriptions for urgently needed medications one for the 14-day supply to be filled at the local pharmacy, and a second prescription for the VA pharmacy.

Primary Care: Authorization for Primary Care covers only services related to Primary Care. Any additional specialty services require a new referral and a separate authorization. Request for additional services needs to be sent to the VA from the Primary Care provider. You must wait for an approved authorization before proceeding with care if you are requesting the VA to cover payment of services.

Copays: If you are being seen through a Mission Act referral and you would normally have a VA co-payment for VA services you may have a copay for each Community visit you attend.

Durable Medical Equipment (DME): Prosthetic/durable medical equipment (DME) items must be issued by the VA Prosthetics Department unless it is an urgent need for an emergency issue. Community Care Providers should submit DME request to the VA to be filled prior to its need.

Authorizations: It is very important that you pay attention to the dates of your authorization. Each authorization has a start date and an expiration date and services received before the start date or after the authorization expires will be at your own expense.

Senior Chatter Handwashing Tips



We are still in the middle of flu season, with the Wisconsin Department of Health & Human services reporting nearly 4,000 positively detected cases as of the beginning of February. In addition, Wisconsin experienced the first confirmed case of the Coronavirus (COVID-19) on February 5, 2020 (although DHS continues to report that the immediate health risk to the general public for contracting this virus is low).

The best thing you can do to prevent infections from viruses is to wash your hands and thoroughly. In 1978, hygiene and health professionals created a map of the most missed areas when washing hands.

A more recent study published in the Journal of Environmental and Public Health in 2008 confirmed that most often, people forget to wash their fingertips.

The Centers for Disease Control and Prevention (CDC) suggests using these five steps to wash hands properly:

1. Wet your hands with clean, running water (warm or cold), turn off the tap, and apply soap.
2. Lather your hands by rubbing them together with the soap. Lather the backs of your hands, between your fingers, and under your nails.
3. Scrub your hands for at least 20 seconds. Need a timer? Hum the "Happy Birthday" song from beginning to end twice.
4. Rinse your hands well under clean, running water.
5. Dry your hands using a clean towel or air dry them.

Washing hands with soap and water is the best way to get rid of germs in most situations. If soap and water are not readily available, you can use an alcohol-based hand sanitizer that contains at least 60% alcohol. You can tell if the sanitizer contains at least 60% alcohol by looking at the product label. Sanitizers can quickly reduce the number of germs on hands in many situations. However, sanitizers do not get rid of all types of germs.

The CDC suggests this three-step approach to using hand sanitizer:

1. Apply the gel product to the palm of one hand (read the label to learn the correct amount).
2. Rub your hands together.
3. Rub the gel over all the surfaces of your hands and fingers until your hands are dry. This should take around 20 seconds.

October 25, 1918

5 Deaths From Flu Since Last Week

Miss Mary Hinzman and Robert Opsahl died Saturday, John Peterson Sunday, Wesley McCauley Wednesday and Thos. Panosh Thursday

This is the headline. What follows in the article are the details of the funeral, surviving family members and ages.

Mary Hinzman was age 22 and had come home from a job elsewhere to care for her parents who were suffering from influenza.

Robert John Opsahl was the infant son of Mr. and Mrs. Anton Opsahl. He was born July 26th of 1918.

John Peterson, son of Mr. and Mrs. Claus Peterson, was age eight.

Wesley John McCauley, son of Mr. and Mrs. W.J. McCauley, was four years and three months old. The family have all been ill with influenza but are on the gain.

Thomas Ponash died at age 76 and seven months. He had been in poor health for some time.

November 1, 1918

Sarah Allie Victim of Influenza

Miss Sarah Allie died at the home of her parents, Mr. and Mrs. Wm Allie, last Friday morning of influenza-pneumonia. She had been ill with the disease six days and had been in poor health from heart disease for several years. The funeral was held Monday morning. She was 24 years of age.

November 1, 1918

Influenza Claims Two Children

Orpha Wolfgram, the four year old daughter of Mr. and Mrs. Chas. Wolfgram died of influenza Wednesday.

The infant daughter of Mr. and Mrs. Walter Steward died Sunday of influenza.

November 15, 1918

Mrs. Oliver Shampo Died Saturday of Influenza

Mrs. Oliver Shampo died at her home here Saturday morning of influenza-pneumonia after a weeks illness. The funeral was held Tuesday morning from St. Ambrose Church, Rev. Buytaert officiating

She is survived by three sons, Ed and John in the Army, and Joe of this village and two daughters, Mrs. Alvina Stroud of this village and Mrs. Robert Egan of Tipler.

Deceased was 63 years old. A daughter, Miss Mamie Shamo, died of the same disease on Nov. 3rd.

November 29, 1918

John Carlson Dies in California of Influenza

John Carlson, who left here about three years ago, died in California of influenza Monday. A message to the family here informing them of his death was received Tuesday. The body will be brought to Wabeno for Burial.

Editor's Note

These are some of the obits from the 1918 Wabeno paper. It is obvious that in many of the cases, there was a health problem before the influenza struck. It wasn't, however, a sickness that society took seriously and took precautions with until a good many people died nationwide. Another lesson from history.

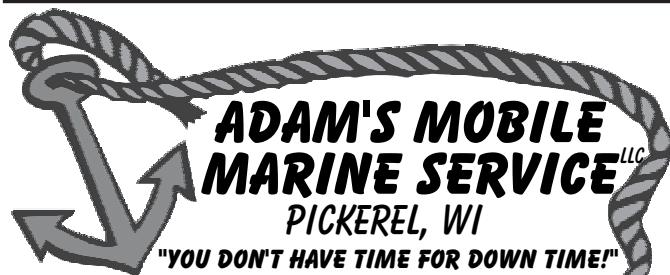

Town of Ross Needs Poll Workers!

Town of Ross Clerk, Heidi Piton is calling on residents of Newald willing to serve as poll workers for the April 7 election to replace poll workers who are unable to serve due to age or health concerns from the Coronavirus COVID-19 pandemic.

Town of Ross has approximately 3 poll workers, known as election inspectors, who serve at polling places. A significant number of them are in their 70s and 80s, and many may have other health conditions.

In Wisconsin, election inspectors are appointed at the municipal level. Anyone who is interested in working should contact the clerk immediately at 715-902-1162.

Wisconsin law also allows people to serve as election inspectors in other municipalities within their county. If you are willing to serve in a municipality outside of your own, let your clerk know and they can alert the county about your availability. You can also contact the county directly and can find contact information for county clerks here: <https://elections.wi.gov/clerks/directory>.

Municipal clerks will provide training for any new election inspectors before the election.

The Wisconsin Elections Commission and the Wisconsin Department of Health Services are working to provide local election officials with guidance for ways to conduct the election safely and securely.

Voter turnout at the polling place is expected to be much lower than normal, but workers are still needed to process a much higher number of absentee ballots than normal.

What are the responsibilities of a poll worker?

Poll workers conduct assigned duties at a polling site on Election Day. Duties can include issuing ballots to registered voters, registering voters, monitoring the voting equipment, explaining how to mark the ballot or use the voting equipment, or counting votes.

Other positions at a polling place include a greeter who assists with answering questions and directing voters to the voting area, an election registration official to a polling place to register voters, and tabulators to assist at the polling place after it closes.

What are the hours of work?

Polling places are open statewide from 7:00 a.m. to 8:00 p.m. Poll workers can work a full day, generally from 6:30 a.m. until approximately 9:00 p.m. or later in the case of November elections. In many municipalities, election inspectors can work a split shift.

Are poll workers (election inspectors) paid or volunteers?

Poll workers are compensated for working at polling places at a rate determined by the appropriate municipal governing body, and, in some municipalities, are also compensated for attending any required training sessions. Poll workers may also choose to volunteer their services by filing a written declination of compensation with the municipal clerk.

What are the training requirements for poll workers?

Municipal clerks are required by state law to provide training. This training provides all of the necessary information and knowledge to be a successful poll worker. (Many municipalities require poll workers to attend a comprehensive training course prior to each Primary election.)

An experienced chief inspector who has been certified by the Wisconsin Elections Commission must be present at each polling place for each election. Chief inspectors must receive six hours of continuing election education training during each two-year period.

What length of commitment will be expected?

Poll workers are usually appointed to two-year terms and are generally asked to make a minimum two-year commitment. However, given the current circumstances volunteers for only the April 7 election are appreciated and should not be expected to meet the full two-year commitment.

What are the qualifications to be a poll worker (election inspector)?

To be a poll worker, a person must:

- ** Be a qualified elector of the county in which the municipality is located (i.e., an adult citizen of the United States who has resided in the election district for 10 consecutive days and is not otherwise disqualified to vote)
- ** Be able to read and write fluently in the English language
- ** NOT be a candidate for any office to be voted on at the polling place at that election.

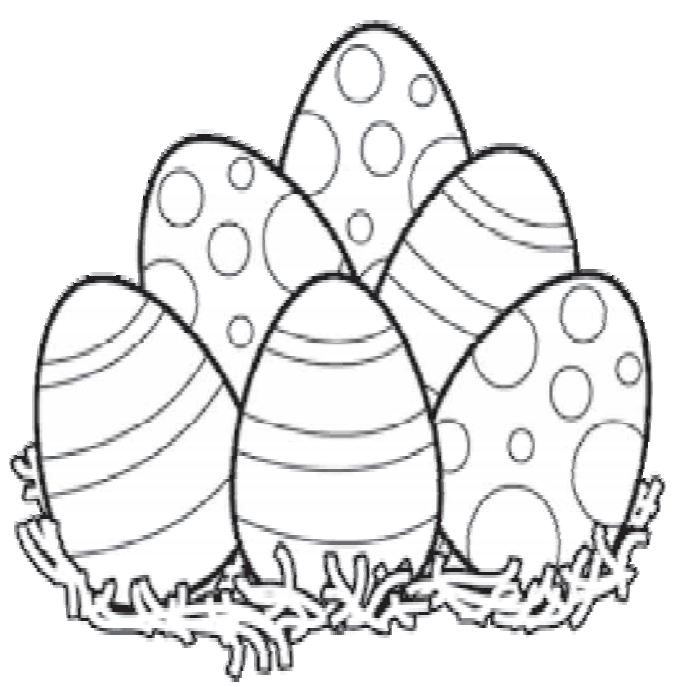

- The order contains detailed information regarding the exemptions provided to certain businesses. If a business is unsure about whether or not they are exempted from this order, please contact the Wisconsin Economic Development Corporation at <https://wedc.org/essentialbusiness/> or 608-210-6700.

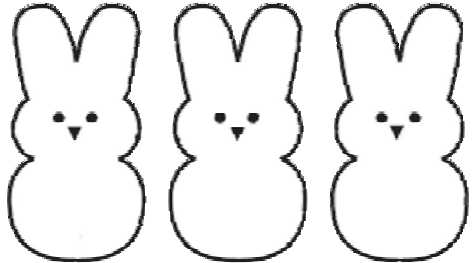

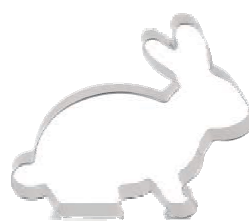

Whereas, On March 11, 2020, the World Health Organization declared a global pandemic of COVID-19 and;

Whereas, the Circuit Court of Forest County is committed to providing open access to the court system while protecting the health and safety of court staff, litigants, attorneys and the public;

NOW THEREFORE, the Court enters the following Temporary Order intended to ensure the continuous performance of the Court's essential functions and operations while at the same time seeking to mitigate the risk of exposure to COVID-19;

TEMPORARY ORDER

- 1.) This order shall be effective March 18, 2020 and continue until May 1, 2020, unless further extended by court order;
- 2.) All Jury trials will be rescheduled until an available time after May 1, 2020;
- 3.) All non-essential court hearings will not be scheduled or will be adjourned until after May 1, 2020;
- 4.) Essential court hearings and those with statutory or constitutional deadlines will continue to be scheduled and held as required. If appropriate, the court may find good cause to adjourn these hearings.

These hearings include, but are not limited to the following:

- a. Juvenile hearings
- b. Emergency Mental Commitments
- c. Temporary Restraining Orders and Injunctions
- d. Bail hearings for defendants in custody
- e. Initial appearances for defendants in custody
- f. Preliminary Hearings if the time limits are not waived.
- g. Guardianship and Protective Placement hearings that can not be adjourned without prejudice to the proposed ward.
- h. Other time sensitive hearings approved by the Judge.

5.) Scheduling of essential court hearings will be done in a manner that avoids a hearing running into subsequent hearings and avoids the accumulation of other litigant, attorneys or the public;

6.) At any essential hearing, the parties, their attorneys and witnesses are allowed and encouraged to appear by phone or video. If personal appearances are required or if any members of the public attend a hearing, a six (6) foot social interaction distance shall be maintained.

7.) The Judicial Assistant and Register of Probate offices will be closed and all work will be performed remotely. Phone calls to each office will be answered by staff. Any documents that need to be filed will be done so electronically or by mail. Mail will be reviewed daily. If a face-to-face meeting is required, an appointment can be scheduled by calling the respective office. The Register in Probate will be present for any required hearings;

8.) The Clerk of Courts office will remain open for limited critical services;

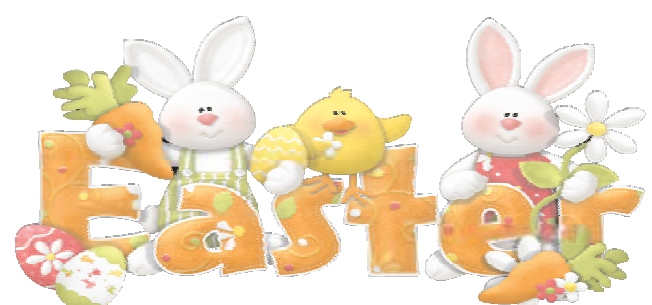

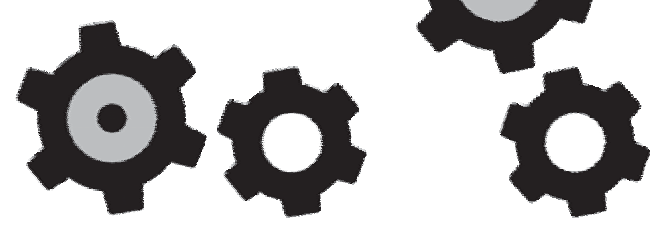

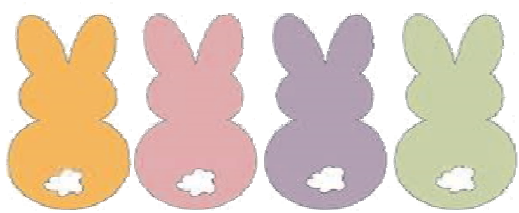

Attorneys running for Circuit Judge should have been recognized as correctly interpreting the law.

- The defendant in case no. 10-CF-84 obtained a dismissal decision from Leon Stenz then filled a federal civil rights lawsuit against the arresting officer, case no 11-C-859. In federal court I disagreed with Leon Stenz's decision: "As an affirmative defense shows the cour the case law at the time of the arrest for speeding was clearly established prolonging a seizure of a motorist after completion of a traffic arrest for less than 78 seconds to inquire about possession of illegal drugs with a K-9 dog immediately available is not a Fourth Amendment violation." US District Judge William C. Griesbach agreed and dismissed the civil rights case.

- After DNR issued a citation G09159 I moved for dismissal "for the reason (there is) no express authority creating the violation of being a party to a crime(s) to a Natural Resources Administrative code." On October 15, 1987 Judge Karch agreed. My challenge was overcome on May 2, 1988 when 1987 Wisconsin Act 379 s2 changed the law.

- I have appealed decisions made by Leon Stenz and other judges and obtained reversals.

If elected, my knowledge and research abilities will be used to go beyond accepting at face value what the rule of law is said to be. I did that with the 1987 DNR citation and will continue to use those abilities as your next Circuit Judge.

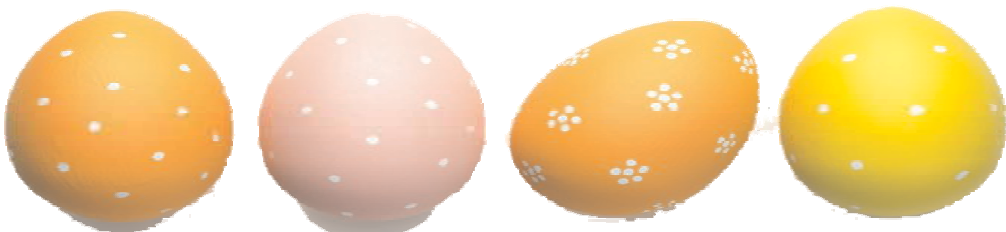

- ❖ I have a reputation for knowing the law. My experience as a private civil attorney, criminal defense attorney, District Attorney and Judge allow me to apply the law fairly, competently and impartially.

- ❖ However, I have imposed significant prison terms when it is necessary to protect the community. Some drug dealers and sex offenders have been sentenced to decades in prison.
- ❖ Records provided by the Forest County Clerk of Court indicate that in the last 2 years, I have sentenced approximately three times more people to prison than Mr. Kennedy did in the 6 years he had the opportunity to prove he was tough on crime.
