Wisconsin's Tornado and Severe Weather Awareness Week April 13-17

MADISON: Gov. Tony Evers has declared April 13-17 Tornado and Severe Weather Awareness Week in Wisconsin, and ReadyWisconsin is encouraging everyone to take time this spring to talk about weather safety with their families. ReadyWisconsin, the National Weather Service and Wisconsin Broadcasters Association also encourage everyone in the state to participate in a Virtual Tornado Drill at 1:45 p.m. on April 16.

"It is essential that people take the time during this important week to ensure everyone living in their home knows what to do when a tornado warning or severe storm is in their area," said Dr. Darrell L. Williams, Wisconsin Emergency Management administrator. "During Thursday's Virtual Tornado Drill, we encourage them to spend a few minutes going over their plans and identifying where to seek shelter."

Wisconsin averages 23 tornadoes annually. During the 2019 season, the NWS confirmed 28 tornadoes touched down in the state of Wisconsin. Of those, 18 occurred during a three-day period in late July, downing countless trees and damaging homes and other buildings across the central portion of the state.

Conservation Corner Conservation Reserve Program (CRP)

CRP is a Land Conservation program administered by FSA in exchange for yearly rental payment to the landowners. Farmers who are enrolled agree to remove environmentally sensitive land from agriculture products and plant species that will improve the environments health and quality. These contracts can be from 10 - 15 years with a long term goal to reestablish valuable land cover to help improve water quality, prevent soil erosion and reduce the loss of wildlife habitat.

CRP was signed into law by Ronald Reagan in 1985, as one of the largest Land Conservation Programs in the United States. Over the years thanks to the VOLUNTARY participation by farmers and land owners, CRP has improved water quality, reduced soil erosion and increased habitat for endangered species. CRP has 22 million acres enrolled and under the 2018 Farm Bill the acreage cap was increased to 27 million. Although the deadline for 2020 enrollment was February 28th farmers and landowners can get their plans in place and apply for the 2021 enrollment.

- This year marking the 35th year anniversary CPR has:
- Prevented over 9 million tons of soil eroding
 - Reducing nitrogen and phosphorus runoff
 - Sequestering annual average of 49 million tons of greenhouse gases
 - Created over 3 million acres of restored wetlands while protecting 175,000 stream miles with riparian forest and grass buffers.
 - Benefiting bees and other pollinators and increased population of ducks, pheasants, turkey, bobwhite quail, prairie chickens, and many other birds.

Stay Safe by Practicing Religion and Spirituality from Home

On March 24, 2020, Governor Evers issued a Safer at Home order, directing Wisconsinites to stay at home in order to slow the spread of COVID-19. This order is in effect until Friday, April 24, 2020, or until a superseding order is issued.

Safer at Home allows individuals to leave their homes for limited essential activities, including shopping for groceries, obtaining medicine, and caring for a family member in another household. Essential businesses and operations are also allowable, though physical distancing and other safety measures are required to keep employees and customers safe.

The order does not allow for gatherings of more than 10 people in a room or confined space at a time. A confined space is not only limited to indoor gatherings, but also includes any defined space, including parking lots and festival grounds. This includes religious gatherings, drive-in services, weddings, and funerals. Any gathering with fewer than 10 people must still adhere to physical distancing requirements by staying at least six feet from others and staying home if you are sick. It is also important to limit gatherings only to people living within the same household to avoid transmitting the virus through social networks.

Physical distancing is our only defense against this virus. Community, faith- and spiritual-based organizations have an important role in slowing the spread of COVID-19, especially among high-risk populations. These organizations often nobly serve [those who are most vulnerable](#), including people with heart disease, lung disease, and diabetes.

FCEDP encourages businesses to explore stimulus options

With the COVID-19 pandemic lingering on, it has significantly impacted Forest County businesses over the past month. Executive Director Mark Ferris, Forest County Economic Development Partnership strongly encourages use of the federal stimulus package options to provide needed relief. "With the initial roll-out, there has been a lot of confusion and questions on how to proceed in getting funds. As of Monday, April 6, there has been a better sense of clarity for applicants. The website is fielding an enormous volume of loan applicants which can understandably slow the process, but please be patient and get through the process."

Ferris suggests any business looking for financial help needs to go to the Small Business Administration website; www.disasterloan.sba.gov to review the options available. In particular there are two programs that would be most commonly used by area businesses. The Paycheck Protection Program is a loan designed to provide a direct incentive for small businesses to keep their workers on the payroll. SBA will forgive loans if all employees are kept on the payroll for eight weeks and the money is used for payroll, rent, mortgage interest, or utilities. You can apply through any existing SBA 7(a) lender or through any federally insured depository institution, federally insured credit union, and Farm Credit System institution that is participating. Other regulated lenders will be available to make these loans once they are approved and enrolled in the program. You should consult with your local lender as to whether it is participating in the program. Lenders may begin processing loan applications as soon as April 3, 2020. The Paycheck Protection Program will be available through June 30, 2020.

The second option is the Economic Injury Disaster Loan Emergency Advance. Small business owners in all U.S. states, Washington D.C., and territories are eligible to apply for an Economic Injury Disaster Loan advance of up to \$10,000. This advance will provide economic relief to businesses that are currently experiencing a temporary loss of revenue. Funds will be made available following a successful application. This loan advance will not have to be repaid. The SBA's Economic Injury Disaster Loan provides vital economic support to small businesses to help overcome the temporary loss of revenue they are experiencing as a result of the COVID-19 pandemic. This program is for any small business with less than 500 employees (including sole proprietorships, independent contractors and self-employed persons), private non-profit organization or 501(c)(19) veterans organizations affected by COVID-19.

As a result of the pandemic concerns, the Forest County Chamber and FCEDP offices have been closed to visitors, but are still available by phone to provide assistance and answer questions. Contact Mark Ferris at 715.902.0244.



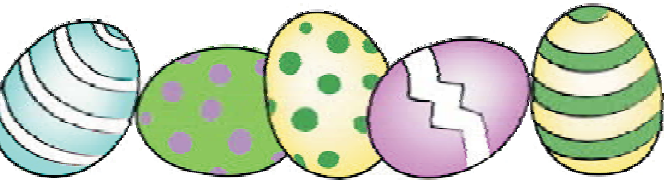

In defense of the ducks, however, they do not have a good access to the media.

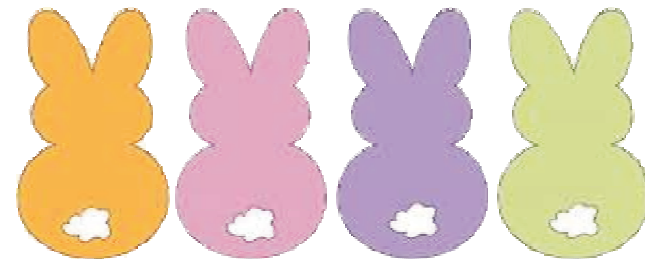
Social Security Recipients Will Automatically Receive Economic Impact Payments

The U.S. Department of the Treasury and the Internal Revenue Service announced that Social Security beneficiaries who are not typically required to file tax returns will not need to file an abbreviated tax return to receive an Economic Impact Payment. Instead, payments will be automatically deposited into their bank accounts.

"Social Security recipients who are not typically required to file a tax return do not need to take an action, and will receive their payment directly to their bank account," said Secretary Steven T. Mnuchin.

The IRS will use the information on the Form SSA-1099 and Form RRB-1099 to generate \$1,200 Economic Impact Payments to Social Security recipients who did not file tax returns in 2018 or 2019. Recipients will receive these payments as a direct deposit or by paper check, just as they would normally receive their benefits.

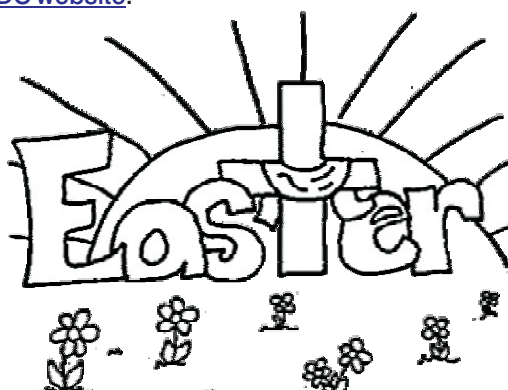

Septic systems and Covid-19

From Forest County Zoning

The EPA has issued information regarding COVID-19 in a septic system: While POWTS (private onsite waste treatment systems) do not disinfect, the EPA expects a properly managed system to treat COVID-19 the same way it safely manages other viruses found in wastewater.

If your septic system and well were properly installed, the system is located at a distance to avoid impacting your water supply.

The above being said, self-isolation and safer at home policies can stress septic systems. People will be spending more time at home, the schools are closed the kids are home, people are working from home. This means more meals are being prepared at home, more dishes are being done, and more water is generally being used. This extra water usage can increase the stress on your sanitary system.

Your septic tank is full of living organisms that make the system work. Many people are using more disinfectants like bleach and other cleaning supplies. These chemicals are toxic to the microbiology and treatment in the septic tank. If too much of these chemicals are used and going down the drains it will result in poor quality effluent going out to the absorption area and possibly clogging it.

Following are some guidelines to reduce the stress on your sanitary system:

- ** NEVER flush disinfecting wipes or personal wipes down the toilet. The toilet should not be used as a garbage can. You should also never flush coffee grounds, dental floss, kitty litter, sanitary napkins or tampons, cigarette butts, paper towels or any unwanted medications.
- ** MINIMIZE the amount of bleach and disinfectants used during the day.
- ** Use soap for hand washing, there is no need to use anti-bacterial soaps that are toxic to the microbes in your system.
- ** Fix leaky fixtures, especially toilet flappers that can allow hundreds of gallons of extra water to leak into your system.
- ** If you have chemical products in your toilet tank (like those chemical disinfection pucks which turn the water blue) stop using them.

Septic systems that are beginning to fail have early warning signs. Some signs to watch for are:

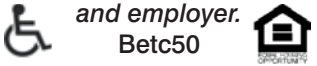
- ** An increasing level of water standing in the drainfield vent or observation pipe.
- ** Water backing up into your home
- ** Water draining too slowly
- ** Settling of soil over the septic tank could indicate a tank problem.

Nothing can take the place of careful use, regular inspection, and maintenance.

Forest County will be sending the 3-year maintenance notices as usual. Please watch your mail for these and do not throw them away. We expect to have them out in May.

The state has already experienced its first tornado this year, when a storm in late March produced an EF-1 tornado that touched down in Grant County. The tornado did not cause any injuries, but it did damage a home and barn. It's a reminder that, while spring and summer are the most active times for tornadoes in Wisconsin, they can happen at any time of year.

While most of Wisconsin has become familiar with the annual statewide tornado drill, the ongoing response to COVID-19 in the state means a break from tradition this year. Due to technical limitations, there will be no live test of the Emergency Alert System (EAS) that triggers NOAA weather radios and messages on broadcast stations. Communities should rest assured that these systems are still regularly tested. This departure simply means there will be no coordinated statewide test this year.

While some communities may still choose to test their outdoor warning sirens on April 16, it is expected many will not be doing so. In place of those alerts, you can expect to see messages from ReadyWisconsin and its partners across social media, encouraging everyone to take the time to go over their plans and practice them during this virtual drill.

Passionate about deer hunting? The DNR wants to hear from you

Public Meetings For 2020 Deer Season Planning Start March 30.

At CDAC meetings participants will review the 2019 deer season results and develop recommendations for the 2020 deer season.

MADISON, Wis. - Wisconsin's hunting heritage runs deep. If you're passionate about deer hunting and management in Wisconsin, the Wisconsin Department of Natural Resources invites hunters, farmers, foresters and anyone interested in deer management in Wisconsin to the upcoming first-round of County Deer Advisory Council (CDAC) meetings across the state March 30 through April 6.

Every county in Wisconsin has a County Deer Advisory Council (CDAC). Councils give the people of Wisconsin greater input into local deer management. These meetings are important for shaping the 2020 deer hunting seasons and annual antlerless harvest quotas.

Additionally, County Deer Advisory Councils provide input and recommendations to the DNR on deer management within their county. Councils work with local DNR staff to:

- **Schedule meetings;
- **Provide community outreach and an opportunity for public input;
- **Review population data and deer impacts on forests and agriculture;
- **Develop three-year recommendations on county population objectives; and
- **Create annual antlerless harvest quotas.

Council members will review the 2019 deer season results and develop recommendations for the 2020 deer season to help each county reach its deer population objective of increasing, decreasing or maintaining the population. Options under discussion include the antlerless deer harvest quota and various season framework options such as offering the Holiday Hunt or extended archery/crossbow seasons.

A schedule of each county's meeting and their location can be found on the DNR website. Those interested can also look up their meeting time and location by county. Visit the CDAC webpage for more info.

Anyone wishing to provide feedback for their county but unable to attend a council meeting can review and comment on preliminary recommendations through an online survey. The survey will be available on the DNR website April 16-28.

The second-round of meetings will take place in May, during which council members will review public comment and make final recommendations for the 2020 deer season.

All council meetings are open to the public and include an opportunity to provide feedback as each council develops its preliminary recommendations. The DNR's staff will review County Deer Advisory Council recommendations following the May meetings and provide recommendations to the Natural Resources Board for approval in June. Following Natural Resources Board approval, final recommendations will be in effect for the 2020 deer seasons.

Fraud surrounding COVID-19 is on the rise

As the number of people and communities affected by the COVID-19 pandemic grows, so do the scams associated with it. Scammers use public health emergencies as opportunities for new fraud schemes. And because older adults are at greater risk for serious illness from this virus, they are at increased risk of being targets.

During this medical crisis facing our nation, it is important to have the facts surrounding COVID-19, to be aware of the potential for scams, and to know what you can do to protect yourself.

Currently there is no FDA-approved vaccine for COVID-19 and although there may be treatments for symptoms, there is no "cure". However, scammers often use fear-based tactics to convince people that a vaccine or cure is now being offered.

Key Points

Beware of anyone contacting you in person, on the computer or by phone, claiming to have a cure or vaccine.

- Do not give your Medicare number, Social Security number, or any personal information in response to unsolicited calls, text, email, or home visits.
- Hang up (or shut the door) on anyone who claims they have a test kit for the virus.
- Be suspicious of anyone offering anything related to COVID-19 such as testing kits, any supplies, or treatments.
- Don't succumb to fear-based tactics of scammers. Cut off those who make you afraid and contact familiar sources instead.

Also, remember that although the Centers for Disease Control and Prevention (CDC) and other public health officials may contact you, they will not ask for your Medicare number, Social Security number, insurance number or financial information.

If you, or someone you are in contact with, have been the victim of a COVID-19 Medicare scam, please contact the Wisconsin Senior Medicare Patrol to report this suspected fraud. SMP can be reached toll-free, (888) 818-2611 or by email, smp-wi@gwaar.org.

Ascension Medical Group launching drive-through COVID-19 testing in central and northern Wisconsin

(Wausau, WI) - Ascension Medical Group Wisconsin is launching its next wave of drive-through testing locations for COVID-19.

Starting Thursday, March 26, drive-through testing sites will be available in Plover, Rhinelander and Crandon. Additional sites are currently in development.

Individuals who wish to be tested at drive-through locations must first be pre-screened by an Ascension Medical Group provider by appointment, phone, or virtually using Ascension Online Care. Those interested in this option for testing should contact their physician office.

This screening involves a series of questions about symptoms, travel history and any potential contact with COVID-19 patients. Patients who meet the criteria, which is based on guidance from the Centers for Disease Control and Prevention and the Wisconsin Department of Health Services, will schedule an appointment for drive-through testing at the appropriate site.

The initial drive-through testing sites going into operation in central and northern Wisconsin are:

Ascension St. Michael's - Plover, 2401 Plover Road, 8:30 a.m. - 4:30 p.m., participants who have been screened and scheduled for drive-through testing should use entrance B in Plover.

Ascension St. Mary's - Kabel Avenue, Rhinelander, 1044 Kabel Avenue. 8 a.m. - 2 p.m.

Ascension St. Mary's - Crandon, 400 West Glen Street, Crandon. Hours: 9 a.m. - Noon

All of these drive-through testing locations will be in operation Monday - Friday.

At the testing site, patients will remain in their vehicle at all times. An Ascension associate will look up the patient's information in the electronic health record to confirm that they have been screened and require testing. Insurance information will be collected for follow-up purposes, if it's not already entered into the electronic health record. An Ascension associate will confirm that the patient has an established Ascension provider. There is no upfront charge for the testing.

A throat culture and nasal swab samples will be collected and sent to a state-approved laboratory for analysis. Patients will be provided this information at the time of testing. The specimens collected at Ascension Wisconsin's mobile testing sites are currently being sent to Quest and LabCorp. In-house labs at Ascension Wisconsin facilities are in development. This additional testing capacity will allow COVID-19 testing for a wider group of patients. Ascension Medical Group Wisconsin will contact patients with results and positive results will be alerted to the Wisconsin Department of Health.

"We continue to collaborate closely with local and state health officials to ensure that community members experiencing symptoms of COVID-19 can be tested for the virus, while limiting exposure to keep the health and safety of our patients, associates and visitors a top priority," said Dr. Stewart Watson, Clinical Vice President of Ascension Medical Group Wisconsin's North Region.

According to the CDC, symptoms of COVID-19 can range from mild to severe and may appear 2-14 days after being exposed to the virus. Symptoms seen with the infection with COVID-19 are not specific, with cold-like symptoms in mild cases. Symptoms could include a fever, along with cough and shortness of breath. If someone is elderly or has other medical conditions, such as heart or lung disease, diabetes or cancer, they may get sicker from the virus and develop pneumonia or other lung problems. 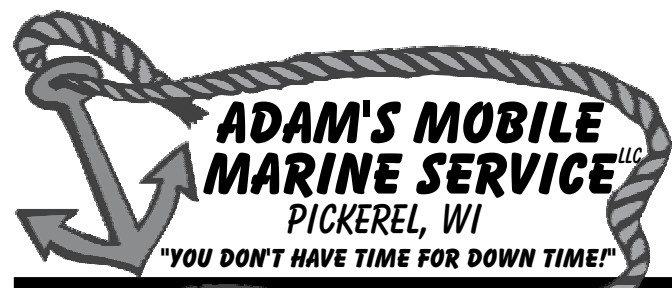

Spring Turkey Season Begins April 15 All Regulations Remain In Effect Under Safer At Home Order

MADISON, Wis. - Gov. Evers' Safer at Home order recognizes outdoor activity as an essential activity. As such, the 2020 Spring Turkey Season will proceed without changes to the season dates or management zones under the Safer at Home order.

Due to COVID-19, distance is critical. Social distancing - the practice of always staying 6 feet away from others outside of household members - is vital to help slow the spread of COVID-19.

Turkey hunting in Wisconsin is designed to minimize hunter contact and is usually a solitary outdoor activity. The purpose of permitting by time period spreads people out in different by time and the purpose of zones spreads people out spatially, resulting in a high-quality hunt.

All current regulations for the season apply. Licensed hunters should hunt the zone and period stated on their harvest authorization.

"Hunting and fishing provides us an opportunity in interact with nature. Hunting and fishing traditions run deep in Wisconsin," said DNR Secretary Preston D. Cole. "It's these traditions that allow us to have a moment of normalcy during this extraordinary time. Remember to be more than safe."

There are still turkey hunting permits available at this time in five of the seven management zones covering most of the state. This provides opportunities for people to select new zones to reduce travel distances and stay closer to home. Permits are available online.

The remaining permits are generally for later in the season, which is an excellent opportunity to spend time in the woods during the spring season when the hunting can also be very good. All sales directly benefit critical conservation efforts including developing, managing, preserving, restoring, and maintaining the wild turkey population in Wisconsin.

Hunting with household family members is still allowed under the emergency order. Social distancing applies to mentored hunts. Because mentors must be within arm's reach of their mentee, the need for social distancing prohibits hunters from mentoring someone outside of their household.

We encourage all spring turkey hunters to adhere to the Safer at Home order's guidelines regarding social distancing. If you encounter a fellow hunter or any other individuals while out hunting, provide at least six feet of space to pass.

Spring turkey periods run for seven days each

SBA offers disaster assistance to Wisconsin small businesses economically impacted by the Coronavirus (COVID-19)

"SBA is strongly committed to providing the most effective and customer-focused response possible to assist Wisconsin small businesses with federal disaster loans. We will be swift in our efforts to help these small businesses recover from the financial impacts of the Coronavirus (COVID-19)," said Administrator Carranza.

SBA Customer Service Representatives will be available to answer questions about SBA's Economic Injury Disaster Loan program and explain the application process.

"Small businesses, private non-profit organizations of any size, small agricultural cooperatives and small aquaculture enterprises that have been financially impacted as a direct result of the Coronavirus (COVID-19) since Jan. 31, 2020, may qualify for Economic Injury Disaster Loans of up to \$2 million to help meet financial obligations and operating expenses which could have been met had the disaster not occurred," said Carranza.

"These loans may be used to pay fixed debts, payroll, accounts payable and other bills that can't be paid because of the disaster's impact. Disaster loans can provide vital economic assistance to small businesses to help overcome the temporary loss of revenue they are experiencing," Carranza added.

Eligibility for Economic Injury Disaster Loans is based on the financial impact of the Coronavirus (COVID-19). The interest rate is 3.75 percent for small businesses. The interest rate for private non-profit organizations is 2.75 percent. SBA offers loans with long-term repayments in order to keep payments affordable, up to a maximum of 30 years and are available to entities without the financial ability to offset the adverse impact without hardship.

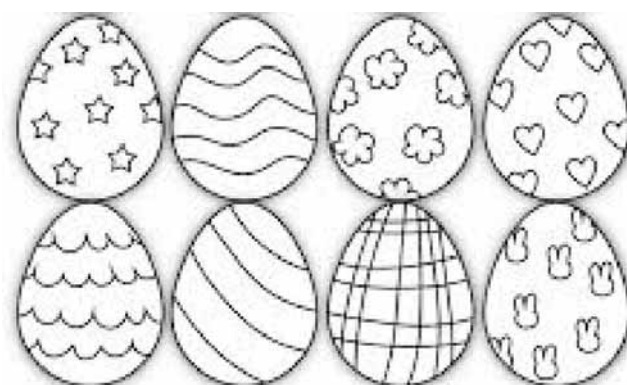

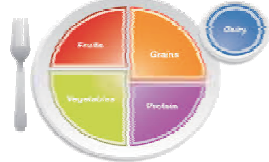
