611 Cases Of Covid-19 (89 Active) In Forest County

Forest County Public Health officials have confirmed additional persons have been diagnosed with novel coronavirus infection (COVID-19) for a total of 516 cases in Forest County. County health officials and local partners are contacting others with whom the individuals who tested positive had close contact with. As of today, Forest County has 3,223 negative test results. There are currently 89 active cases in isolation, 507 released from isolation, 4 hospitalized, and 11 deaths.

The Forest County Health Department encourages community members to minimize their contact with others by staying home when possible, practice physical distancing and good personal hygiene, wear a mask or cloth face covering, and stay alert for symptoms of COVID-19. If you are experiencing any symptoms or have been exposed to someone with COVID-19, please contact your health care provider and ask to be tested.

In an effort to keep our community members up to date on COVID-19, the Forest County Health Department will continue to update our Facebook page daily and local newspapers weekly with current COVID-19 case counts. This will include the number of negative and positive cases in Forest County. Please call our office at 715-478-3371 with any questions or concerns.

Conservation Corner Top 10 hunting violations during firearm deer season

As we gear up for the 2020 firearm deer season, DNR officials are expecting that this year's higher hunting license sales will mean more new and experienced hunters in the woods. Here's a list of the 10 most common hunting violations that conservation officers encounter every firearm season.

#1 - Using the wrong tag or improperly filling out a tag
 Conservation officers often see the wrong kill tag on game - such as fish or turkey licenses on a deer. Often, this is a simple mistake made in the dark and can easily be corrected by re-tagging the deer as soon as you notice the error.

Solution: Before field-dressing or moving the deer, kill tags should be filled out (including the month and date the deer was taken and the deer's gender and number of antler points) and properly placed on the deer.

#2 - Not wearing orange
 Some hunters remove their orange clothing once they get into deer stands or blinds. In the excitement of getting a deer, hunters may forget to put their orange clothing back on.

Solution: Commit to wearing hunter orange to keep yourself and others safe. Hunters are required by law to wear hunter orange as the outermost layer of clothing at all times.

#3 - Being unfamiliar with a firearm and how it functions
 Semi-automatic, lever, bolt and pump-action firearms are common choices among hunters, but each firearm functions very differently.

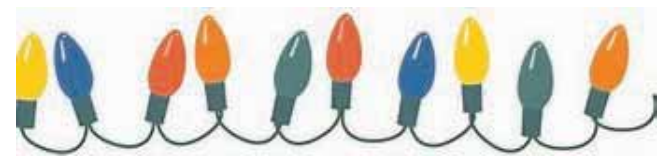

Conference Champions in the MONLPC West 8-Player Football Conference. The team played 6 games, winning 5 of those and losing only one to Three Lakes. With the shortened season this year, they still came through with great stats among the team and had the #1 ranked Defense overall. This team has some extremely athletic and hard-working young men and their perseverance and dedication has really paid off. The entire team played well together and became very adapt to changing positions or covering for someone if the need arose.

With smaller numbers in players, most of the team played both sides of the ball covering both offense and defense. There is always good support among the players and they helped each other dig-in and get it done even when they were cold and tired! The team has six Seniors, Seth Lempel, Michael Stamper, Clayton Janesch, Jackson Smith, Evan Townsend, and Robert Kitchell.

Michael Stamper's sticky hands caught the ball time and again earning him 455 yards receiving with 8 touchdowns. Michael came in 4th overall in the State for yards and 2nd for touchdowns.

Robert Kitchell was a tough offensive guard making the openings the running backs needed.

Sophomore, Adam Seeber, had a great year with three receiving touchdowns.

Let's not forget the #1 Defense in the State! These tough men were not a group the opposing offense wanted to see across the line from them. Evan Townsend, led the State in tackles for loss with 19 and came in 2nd in the State for sacks with 8.5.

The Crandon Cardinal Football team traveled to Tomahawk on Friday October 30th to take on the Hatchets. The first quarter was littered by Cardinal drives stopping short with fumbles. The Cardinals put the ball to the turf three times in the quarter resulting in 20 points for the Hatchets in the opening quarter. After the initial blitz which featured some huge gains by Tomahawk taking advantage of the Cardinals over aggressiveness on defense both teams settled in and went scoreless in the second going into half.

The Cardinals came out red hot in the third quarter. Jacob McIntosh sparked the Cards taking the second half kickoff 80 yards to the house to cut the deficit 6-20 2pt. conversion failed. DMV gives new extension for drivers over age 60

Online prep speeds driver license renewal process, reduces time in DMV

The Wisconsin Department of Transportation's Division of Motor Vehicles (DMV) recognizes the elevated health risk to drivers over age 60 during this pandemic and has granted them an extension until January 21, 2021 to visit a DMV to renew their driver license with no late fee.

While drivers over age 65 are required to renew in person, a DMV visit need not take long. DMV offers these tips to reduce the time it takes to renew a driver license:

- Use the Driver License Guide to fill in the form and submit it electronically
 - Make an appointment through the Driver License Guide
- Tell your concerns to the DMV Customer Service Representative when you check in

"For those not qualified to renew their driver license online, we've developed robust online tools to help reduce the amount of time of their visit," DMV Administrator Kristina Boardman said. "We're continually gauging the health risks of vulnerable populations and challenging our staff to find new ways to safely and efficiently serve customers."

Here are other steps DMV has taken to protect the health of customers and employees:

- Made the decision to restrict all in-person transactions. DMV Customer Service Centers are open only for the issuance of Wisconsin driver licenses and identification cards.
- Allow qualified drivers ages 18 to 64 to renew their license online (wisconsindmv.gov/renewDL)
- Allow parents to verify teen eligibility and complete a road test waiver so fewer people in DMVs
- Limit the number of customers within the DMV
- Allow space in the lobby for social distancing
- Require staff to wear protective gear and installed protective plastic barriers
- Sanitize facilities regularly

Drivers who no longer want to use their driving privilege but want identification can easily exchange their license for an ID online and a new ID card will be mailed. Details and other resources for aging drivers are available at wisconsindmv.gov/olderdrivers.

By limiting the number of people within DMVs, providing electronic submission of paperwork and appointments, and extending the deadline, Wisconsin DMV has taken measures to safely manage customers' needs through this health crisis.



Nicolet College Trustees begin search for next college president

The Nicolet College Board of Trustees has started the search for a new president to lead the college following the recent announcement that current president Richard Nelson plans to retire this coming summer.

At its October meeting, the board voted to form a four-member committee to guide the transition process.

"Dr. Nelson and the Executive Leadership Team he has assembled have done a tremendous job in advancing higher education at Nicolet College while practicing responsible fiscal management," said Sharon Nielsen, chair of the Nicolet College Board of Trustees.

"Our goal now is to keep that momentum going and select the next president of Nicolet College who can provide the high level of visionary advancement and impeccable leadership the college has enjoyed under Dr. Nelson over the past five-plus years."

After considering a variety of search strategies, the board voted to open the search at the moment to internal candidates only.

Nielsen explained the reasoning for this was that the board was pleased with the direction current leadership is taking the college, that it wanted to maintain the continuity of the collective leadership currently in place to continue advancing the college, and the desire to promote from within the employee pool whenever possible.

An added factor was the disruption the COVID-19 pandemic is having across the nation on many levels, including executive searches.

"The hiring of the college president is one of the most important duties the board is charged with," she said. "And after substantial discussion about multiple options for a presidential search, we determined that this is the best course."

Nielsen also stressed that if the internal search did not yield a suitable and viable candidate, the board was ready to move swiftly and launch a national search.

The board anticipates concluding the process in January, 2021.

The board will also follow traditional and accepted executive-level vetting and selection practices, including the opportunity for members of the general public and Nicolet staff to meet with candidates in an open forum.

More information about the search and application process will be posted on the Nicolet website in the near future.

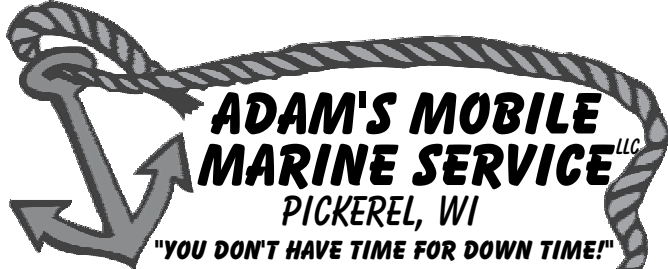

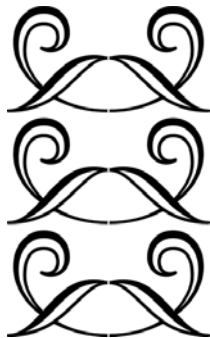

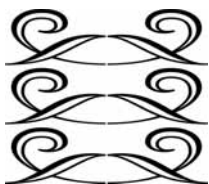

Nicolet College Trustees begin search for next college president

The Nicolet College Board of Trustees has started the search for a new president to lead the college following the recent announcement that current president Richard Nelson plans to retire this coming summer.

At its October meeting, the board voted to form a four-member committee to guide the transition process.

"Dr. Nelson and the Executive Leadership Team he has assembled have done a tremendous job in advancing higher education at Nicolet College while practicing responsible fiscal management," said Sharon Nielsen, chair of the Nicolet College Board of Trustees.

"Our goal now is to keep that momentum going and select the next president of Nicolet College who can provide the high level of visionary advancement and impeccable leadership the college has enjoyed under Dr. Nelson over the past five-plus years."

After considering a variety of search strategies, the board voted to open the search at the moment to internal candidates only.

Nielsen explained the reasoning for this was that the board was pleased with the direction current leadership is taking the college, that it wanted to maintain the continuity of the collective leadership currently in place to continue advancing the college, and the desire to promote from within the employee pool whenever possible.

An added factor was the disruption the COVID-19 pandemic is having across the nation on many levels, including executive searches.

"The hiring of the college president is one of the most important duties the board is charged with," she said. "And after substantial discussion about multiple options for a presidential search, we determined that this is the best course."

Nielsen also stressed that if the internal search did not yield a suitable and viable candidate, the board was ready to move swiftly and launch a national search.

The board anticipates concluding the process in January, 2021.

The board will also follow traditional and accepted executive-level vetting and selection practices, including the opportunity for members of the general public and Nicolet staff to meet with candidates in an open forum.

More information about the search and application process will be posted on the Nicolet website in the near future.

Forest County Emergency Management would like to let everyone know that November 9-13 is Winter Awareness Week in Wisconsin

MADISON, Wis. — Wisconsin winters can bring beautiful snowfalls and great opportunities for outdoor recreation. They can also result in dangerously cold temperatures and icy conditions. To help encourage everyone to be prepared for the months ahead, Gov. Tony Evers has declared Nov. 9-13 Winter Awareness Week in Wisconsin.

"While Wisconsin typically experiences most of its winter weather from late November through April, this season got off to an early start with several parts of the state receiving a late-October blast of snow," said Dr. Darrell L. Williams, Wisconsin Emergency Management administrator. "It's an important reminder that winter weather can be unpredictable, so you need to be prepared early on for what Mother Nature may throw at us."

During Winter Awareness Week, ReadyWisconsin encourages everyone to learn about risks common to winter months. Be prepared for snow and icy conditions that could impact travel on roadways, make sure you have emergency kits in your vehicle and at home, and ensure your home and vehicle are prepared for the extreme cold temperatures the state often experiences.

"Take time during Winter Awareness Week to make sure your emergency kits have fresh supplies, schedule a tune-up for your furnace, and winterize your vehicle," Williams advised. "Don't wait until dangerous winter weather is in the forecast to get you and your family ready."

Winter emergency kits should include items such as food, water, a flashlight and batteries, and blankets. In your vehicle, include a snow shovel, extra gloves and hats, face masks, and kitty litter or sand to help give your wheels traction on icy roads in case you get stuck.

According to the National Weather Service, Wisconsin experiences an average of three to six winter storms during the season. Last winter, the city of Bayfield in Bayfield County received the highest one-day snowfall of 25.0 inches on Dec. 1, 2019. Upson in Iron County recorded 143.2 inches of snow last winter, giving it the highest seasonal snowfall total in the state. The coldest temperature recorded in Wisconsin was -39 degrees Fahrenheit on Feb. 15, 2020 in Mather, located in Jackson County.

Winter driving can be extremely hazardous. Between 2015-2019, the Wisconsin Department of Transportation says an average of 43 people were killed and 4,138 were injured each year in crashes on icy or snow-covered roads in the state. On average, there are about 18,000 vehicle crashes in the state each year caused by poor winter driving conditions.

"During the winter months, it's important to check current road conditions before you head out," Williams said. "Consider cancelling travel plans, if you don't need to be on the roads. If you can't avoid driving, make sure you have an emergency kit in your vehicle, slow down, and make sure someone knows where you're going and that you have arrived safely."

You can check travel conditions for most major roadways in the state by using 511 Wisconsin, a state Department of Transportation service updated regularly with the latest traffic and road conditions on major routes throughout the state. This information, along with live traffic cameras and traffic alerts, can be accessed through the free 511 Wisconsin mobile app, @511WI on Twitter, or the mobile-friendly site www.511wi.gov. You may also find updates through local government websites and social media accounts.

Solution: Take the time to familiarize yourself with your firearm and make sure it is properly sighted and functioning before you go hunting. Being able to safely handle your firearm is an important part of being a responsible hunter.

#4 – Committing safety zone violations

Each year conservation officers investigate property damage caused by firearms.

Solution: Rifle rounds travel long distances – hunters are responsible for where their bullets end up. No one may hunt with a firearm within 450 feet of an occupied structure (including buildings, dwellings, homes, residences, cabins, barns or structures used for farm operations) unless they have permission from the landowner.

#5 – Trespassing

If a deer runs onto private property, the hunter cannot retrieve it without the landowner's permission.

Solution: Respect landowner rights and posted trespassing signs. If you'll be hunting near someone else's property, contact the landowner ahead of time; don't wait until you're tracking game.

#6 – Staking claims to public land hunting blinds

Confrontations over hunting spots, or the illegal posting (trespassing or hunting signs) of state-managed public land, happen every year.

Solution: Hunters should research and scout the land they plan to hunt – before hunting day. Brush, constructed blinds and tree stands on public land are just that – public. Regardless of who constructed, purchased or tends to these blinds, when they're on state-managed public land, they are available on a first come, first served basis.

#7 – Littering

Leaving propane bottles, hand warmer wrappers, food wrappers, bottles and other trash causes problems for animals and people.

Solution: Practice the "leave no trace" ethic. Whatever is brought into the woods should be taken back out. It is the responsibility of all hunters to be environmental stewards and clean up after themselves.

#8 – Baiting/attracting deer

Conservation officers stay busy responding to calls about illegal baiting.

Solution: Know the law. Baiting wild animals for hunting purposes is prohibited.

9 – Hunting out of hours or off-season

One of the most common complaints to the DNR's Report All Poaching Hotline is about shots fired after dark. Often, these complaints are reported days later.

Solution: A hunter may legally shoot game 30 minutes before sunrise or until 30 minutes after sunset. Anyone who witnesses or suspects hunting outside of legal hours should immediately call or text the DNR's Report All Poaching hotline at 800-847-9367.

#10 – Harassing hunters

Conservation officers investigate acts of hunter harassment – which is when a person or organization intentionally sabotages another hunter's quality opportunity to take game. Examples include spraying repellent around a hunter's blind, creating loud noises and/or barriers that prevent or deter a hunter or game from accessing an area, or destroying other hunters' equipment such as trail cameras and blinds.

Solution: Respect the law. Wisconsin law prohibits anyone obstructing or interfering with the lawful taking of animals. Hunter harassment is a misdemeanor offense.
