### What Causes Buds to Open in Spring?

Spring has finally sprung! Not only are crocuses, day lilies and daffodils starting to show up in our gardens, but many trees are also budding. It is a wonderful sight, giving us hope for longer and warmer days to come. Did you ever stop and think what causes trees to bud in the spring? Many think it is the length of day or the warmer temperatures, but the most important environmental cue for spring bud break is actually cool temperatures!

Dormancy (not growing or not active) is important for all tree species. It allows them to avoid the harsher conditions of winter. There are two stages in dormancy: endo-dormancy and eco-dormancy. During endo-dormancy, plants will not grow, even during warm conditions, due to factors inside the plant that inhibit or stop growth. This stage starts when winter begins and prevents trees from budding during an unseasonably warm stretch during the winter. During endo-dormancy, trees start to track the time spent above freezing, called chilling units. Temperatures between 40 - 50 degrees Fahrenheit are most effective. The duration of exposure needed to break dormancy varies by species and location, ranging from 500 - 1,500+ hours.

Once the chilling period is completed, usually in January in the Mid-West, eco-dormancy begins. This is when the conditions are not quite right, usually too cold, but the tree is ready to grow. When the temperature reaches the mid-40's or warmer, growth begins and the buds start to break. These buds were formed the previous summer and spent the winter dormant and protected under bud scales. Now the young shoots break through and begin unfurling the leaves for this summer!

The new tissues coming out in the spring are very susceptible to disease, such as fungi, bacteria, phytoplasmas, and other pathogens. Spring bud break is the perfect time to treat your plants that have had problems with disease in the past. A pathogen from last year will probably be there again this year. The most threatening diseases in spring are:

- Anthracnose on ash, maple, and oak
- Apple scab
- Fire blight on hawthorn, pear, crabapple
- Needle casts on pine, Douglas fir, and spruce

Spring is also a good time to look for things that might have occurred over the winter. There are many kinds of winter injury that may have effected your trees. Temperature fluctuation, extreme low temperatures, wind, and animals can all cause damage. Here are some damages to look for:

- Frost Cracks - deep longitudinal cracks from cold temperatures
- Winterburn on Evergreens - browning or scorched leaf tip from wind
- Spring Freezes - new leaves become flaccid and wither after a sudden hard frost
- Salt Damage - browning of evergreens, leaf scorch, and branch die back
- Girdling by Animals - mice and rabbits feed on young tree bark in the winter

## COVID-19 Vaccine Update

The Forest County Health Department continues to receive weekly allocations from the State of Wisconsin of the Pfizer vaccine to aid in the response to the current pandemic. As of April 16th, 2021 there have been 3,888,870 vaccines administered across the State of Wisconsin. In Forest County, 36.3% (3,269) of our residents have received at least one dose of the vaccine and 29% (2,612) have completed the vaccine series. As of April 5th all persons over the age of 16 are eligible for the COVID-19 vaccine. Currently, Pfizer is the only vaccine that persons 16-17 years old are eligible to receive. We ask that you call the Forest County Health Department if you are interested in having your 16-17 year-old vaccinated.

In Forest County, there are many options available to get vaccinated including local and tribal health departments, community-based vaccination clinics and healthcare providers. To find a local vaccine provider visit the COVID vaccine provider map or visit <https://vaccinefinder.org>.

With the spread of variants of COVID occurring in our neighboring counties and states, it is very important to get vaccinated. Hospitals in larger cities are reporting that more infections are being seen in younger people. Please call today and set up an appointment to receive the COVID vaccine at 715-478-3371.

To continue to keep residents of Forest County safe and healthy, please continue using good infection control habits such as washing your hands, wearing a mask in public, avoiding large crowds, and staying home if you are sick and getting tested.

## 947 cases of covid-19 (4 active) confirmed in Forest County

Forest County Public Health officials have confirmed additional persons have been diagnosed with novel coronavirus infection (COVID-19) for a total of 947 cases in Forest County. County health officials and local partners are contacting others with whom the individuals who tested positive had close contact with. As of Friday, April 16th, Forest County has 4,690 negative test results. There are currently 4 active cases in isolation, 920 released from isolation, 0 hospitalized, and 26 deaths related to COVID-19.

The Forest County Health Department encourages community members to minimize their contact with others by staying home when possible, practice physical distancing and good personal hygiene, wear a mask or cloth face covering, and stay alert for symptoms of COVID-19. If you are experiencing any symptoms or have been exposed to someone with COVID-19, please contact your health care provider and ask to be tested.

In an effort to keep our community members up to date on COVID-19, the Forest County Health Department will continue to update our Facebook page and local newspapers weekly on Friday's with current COVID-19 case counts. This will include the number of negative and positive cases in Forest County. Every Monday there will be an updated vaccine report on our Facebook page to update residents on the progress being made on vaccinating community members. ## Wisconsin DHS pauses use of Johnson & Johnson COVID-19 vaccine Vaccinators instructed to stop administering Johnson & Johnson vaccine

The Wisconsin Department of Health Services (DHS) is instructing Wisconsin vaccine providers to stop administering the Johnson & Johnson COVID-19 vaccine due to a federal review of adverse side effects reported. The Centers for Disease Control (CDC) and U.S. Food and Drug Administration (FDA) issued a statement saying six cases of a rare and severe type of blood clot called cerebral venous sinus thrombosis have been reported in the U.S. out of 6.8 million Johnson & Johnson vaccine doses given.

"We are pausing administration of the Johnson & Johnson vaccine out of an abundance of caution. At this time, these adverse events appear to be extremely rare," said DHS Secretary-designee Karen Timberlake. "Vaccine providers should not administer the Johnson &

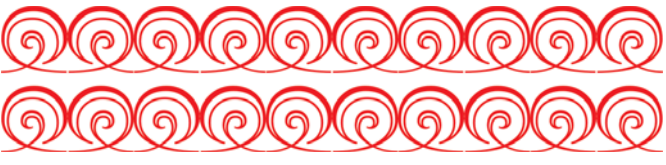

## Increase in Opioid overdoses

The Wisconsin Department of Health Services (DHS), along with the Forest County Health Department have received a higher number of suspected opioid overdose alerts recently. An alert is triggered whenever the suspected number of overdoses in emergency departments is statistically higher than usual in a specific area. A statistical increase is determined by looking at the trend from the previous 10 weeks. An alert is issued when the observed number of cases rises above this level of expected overdoses by a significant amount over a seven-day period.

An opioid overdose is a medical emergency. If you think someone has overdosed, call 911. Opioid overdoses are caused by people taking an opioid to get high, taking an extra dose of a prescription opioid by accident or on purpose, mixing opioids with other medicines, illegal drugs or alcohol and taking an opioid that was prescribed for someone else.

Who is at risk for an opioid overdose? People who abuse opioids or take more than prescribed, people who mix opioids with other medicines or alcohol, and people who have asthma, sleep apnea, or reduced kidney or liver function.

The signs of an opioid overdose are clammy skin, extremely pale face, small pinpoint pupils, gurgling noises with breathing, limp body, purple or blue colored fingernails or lips, slow or stopped breathing or heartbeat, unable to awaken from sleep, person may be unable to speak and may be vomiting.

If you suspect that someone is experiencing an opioid overdose you should take these steps: Call 911, tell the operator if the person has stopped breathing or has slowed breathing, if available, give naloxone, remove any objects from the mouth of the person, start rescue breathing, give one breath every five seconds for 30 seconds. You should give naloxone again after 2-3 minutes if there is still no response. More than one dose is sometimes needed. Lay the person on their side to prevent choking and stay until help arrives.

The Forest County Health Department wants to raise awareness of the opioid crisis in our area, and make sure that our community is safe. 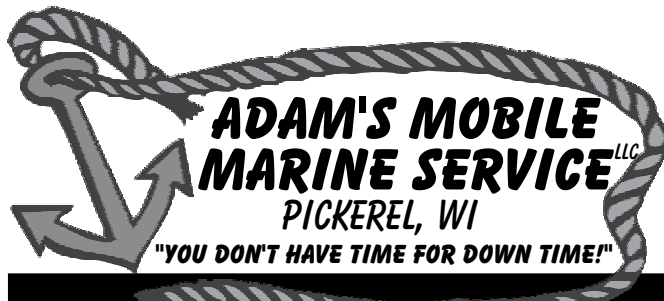

### Marketplace Changes Under the American Rescue Plan

In addition to providing for a third round of stimulus checks, the American Rescue Plan (ARP) Act will make marketplace health plans more affordable. These changes affect people who are already enrolled in marketplace coverage as well as people who sign up this year.

• **Increased Marketplace Premium Subsidies**

The ARP increases premium tax credits, or subsidies, for everyone enrolled in a marketplace plan. In the past, everyone with a marketplace plan had to pay some amount of premiums. Under the ARP, people with incomes under 150% FPL may be able to choose a premium-free silver plan with a small deductible.

In addition, people with incomes above 400% of the federal poverty level (FPL) may be eligible for premium subsidies. Before the ARP, people with incomes above 400% FPL were not eligible for any premium subsidies. Now people may be eligible for premium subsidies if they would be required to contribute more than 8.5% of their household income toward their plan's premium, depending on the plan. This is even true for people with incomes above 400% FPL.

The increased premium subsidies will be in effect during 2021 and 2022. The Department of Health and Human Services announced that the subsidies will be available on HealthCare.gov beginning April 1, and the subsidies for current enrollees will be retroactive to January 2021. It is unclear whether these changes will be automatic for current enrollees. Beginning April 1, consumers should update their HealthCare.gov applications and reselect their current plan to receive the tax credits this year. If they do not take any action after April 1, they can claim the increased subsidies as tax refunds when they file their 2021 tax return next year.

Under the current COVID-19 special enrollment period, people have until August 15 to sign up for coverage or change plans to take advantage of the additional subsidies.

• **Increased Subsidies for People Receiving Unemployment Benefits**

When people receiving unemployment benefits apply for a marketplace plan in 2021, their income over 133% FPL will be disregarded for purposes of determining eligibility for premium and cost-sharing subsidies.

As a result, people who receive unemployment benefits at any time in 2021 may be able to choose a premium-free silver plan with a small deductible. This rule will only be in effect during 2021. In addition, people receiving unemployment benefits must meet the other requirements to be eligible for marketplace subsidies. For example, if they have access to job-based health insurance that meets the Affordable Care Act's standards for affordability and minimum value, they will be ineligible for any marketplace premium subsidies.

• **Premium Tax Credit Repayment Forgiveness for 2020**

People who apply for marketplace premium subsidies must provide an estimate of their income for that tax year. When they file federal tax returns for that year, they must determine whether they received the correct amount of premium tax credit. Individuals who overestimated their income will receive an additional premium tax credit. On the other hand, individuals who underestimated their income must repay any excess premium tax credit. Individuals with income above 400% FPL must repay the entire amount of excess premium tax credit they received that year. There is a limit to how much a person with lower incomes must repay.

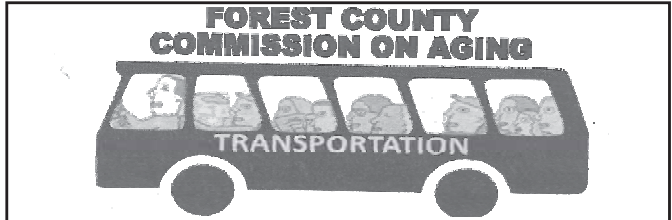
Because the COVID-19 pandemic caused significant income uncertainty last year, the ARP waives repayment of any excess premium tax credit received by marketplace enrollees in 2020. This will protect people at any income level, including those with income over 400% FPL. Because the 2020 tax forms were finalized before the ARP was passed, the Internal Revenue Service is expected to release additional guidance. Individuals with questions should consult a tax professional.

People who would like help enrolling in marketplace coverage should go to <https://localhelp.healthcare.gov/#/> to find local assistance in their area. People who are enrolled in Medicare should not attempt to enroll in marketplace coverage.

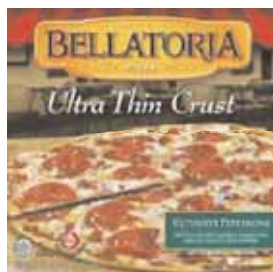

Johnson vaccine at this time, and should hold on to the vaccine until federal review has been completed.”

Vaccine providers should continue to hold the vaccine at proper storage and continue timely reporting of any adverse events to the Vaccine Adverse Events Reporting System (VAERS). This pause will allow CDC to determine if there are any further cases of this clotting disorder and to provide health care providers with guidance on how to treat this rare condition.

“There is still a lot to learn about how the vaccine might cause the problems that occurred in the six patients, which included blood clots around the brain and low platelets, but they do appear to be very rare,” said Dr. Ryan Westergaard, Chief Medical Officer for DHS. “For residents who have received the Johnson & Johnson vaccine, be in contact with your health care provider if you have a severe headache or new vision problems during the first two weeks after receiving the vaccine.”

People who received the Johnson & Johnson vaccine should monitor for the following symptoms three weeks after their vaccination: severe headache, abdominal pain, leg pain, or shortness of breath. Symptoms associated with these severe events have occurred six to 13 days after vaccine receipt. Contact your health care provider and use the v-safe program to report your symptoms.

The Pfizer and Moderna COVID-19 vaccines continue to remain extremely safe vaccines. DHS encourages everyone eligible to get the vaccine to continue with their vaccination, especially in light of variants. Wisconsin continues to have a good supply of these vaccines; 96% of the doses administered in the state have been Pfizer and Moderna.

“So far, there have been no reports of cerebral venous sinus thrombosis with low platelets in anyone who has received one of the mRNA (Pfizer and Moderna) vaccines,” said Dr. Westergaard. “The FDA, CDC, and DHS continue to recommend the use of the Pfizer and Moderna vaccines at this time, while the adverse events related to the Johnson & Johnson vaccine continue to be investigated.”
