This year's firearms deer season looks to be another good one, if early archery and crossbow successes are any indication.

This year, the gun season will open a day earlier than last year. The full moon on Nov. 19 should spur some deer movement for the opener on Saturday, Nov. 20, but if the weather remains unseasonably warm for the next few weeks, that activity might occur mainly at night.

Again this year, hunting regulations for all species are combined in one booklet, available online and at license vendors and DNR offices. Here's a quick look at regulations changes for this season:

- This year, 38 counties will offer the antlerless-only holiday hunt, Dec. 24 through Jan. 1, 2022;
- Baiting and feeding restrictions continue to change as CWD is detected in additional counties. Updates are posted on the DNR website as they occur.

Hunters may buy licenses and antlerless approvals (tags) online via the DNR's GoWild system, as well as in person, at numerous license vendors throughout the state.

Anyone who has not purchased a firearms deer license in the past 10 years may buy one for just \$5. Hunters who recruit three new hunters in one year may buy next year's license for half price. If you buy a conservation patron license, the cost will be \$105 instead of \$165. Details are posted on the DNR website.

While hunting, you must carry proof of your license and harvest authorizations. Acceptable forms of

1,422 cases of covid-19 (18 active) confirmed in Forest County

Forest County Public Health officials have confirmed 129 additional persons have been diagnosed with novel coronavirus infection (COVID-19) in October as of October 29th, for a total of 1,422 cases in Forest County. There have been 8 probable cases, this month, as well. County health officials and local partners are contacting others with whom the individuals who tested positive had close contact with. As of Friday, October 22nd, Forest County has 6,338 negative test results. There are currently 18 active cases in isolation, 1,373 released from isolation, 3 hospitalized, and 28 deaths related to COVID-19. This is a snapshot of numbers, but they are continuously changing throughout the day.

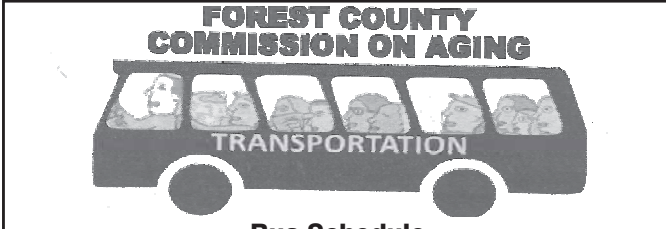

Cutting your National Forest Christmas Tree

The Chequamegon-Nicolet National Forest is offering personal use Christmas tree permits through Recreation.gov at <https://www.recreation.gov/tree-permits/cnrf>. Permits cost \$5 per tree, with a maximum of five permits per household. Visitors must have their permit(s) with them when harvesting.

Fourth grade students are eligible for a free Christmas tree permit through the Every Kid Outdoors initiative. Every Kid Outdoors encourages fourth graders and their families to discover the Nation's natural resources and history for free.

Students, teachers and parents should follow links to "get your pass," print a pass from the Every Kid Outdoors website at <https://everykidoutdoors.gov>, and then present their valid Every Kid Outdoors pass at the Ranger Station to obtain their free Christmas tree permit.

If obtaining the permit online, enter the student's pass number during checkout. All online purchases, including those for free permits, will incur a \$2.50 processing fee.

Visitors can also purchase permits by mail or through no-contact delivery at a forest office by calling any office location below.

Visitors should plan their tree harvest. Measure the display location to compare against the transport vehicle space. Bring ropes or tie downs to fasten the tree for transport home. Forest visitors should wear bright clothing and plan midday visits for better visibility. Cell service may be limited or unavailable on the forest, so consider bringing a map and be sure to let someone know where you will be on the forest.

The forest recommends against tree harvesting during gun deer hunting season, Nov. 21-29. The Wisconsin Department of Natural Resources lists all hunting season dates on its website at <https://dnr.wisconsin.gov/topic/hunt/dates>.

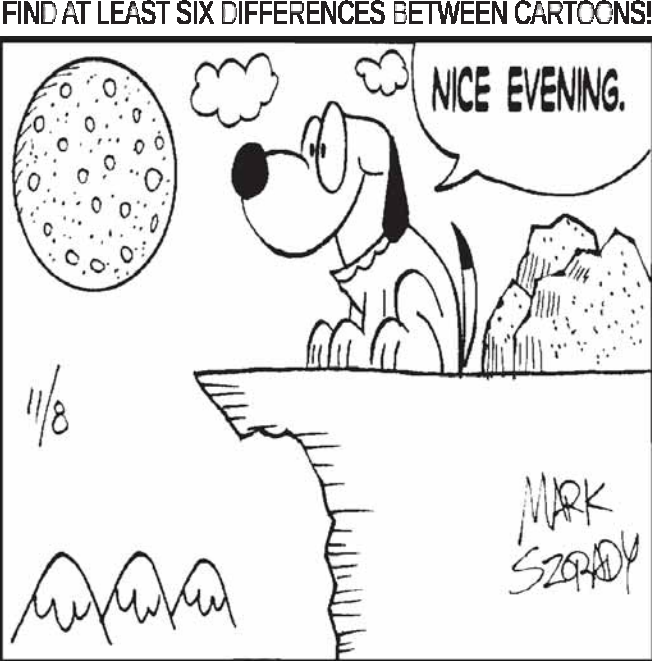
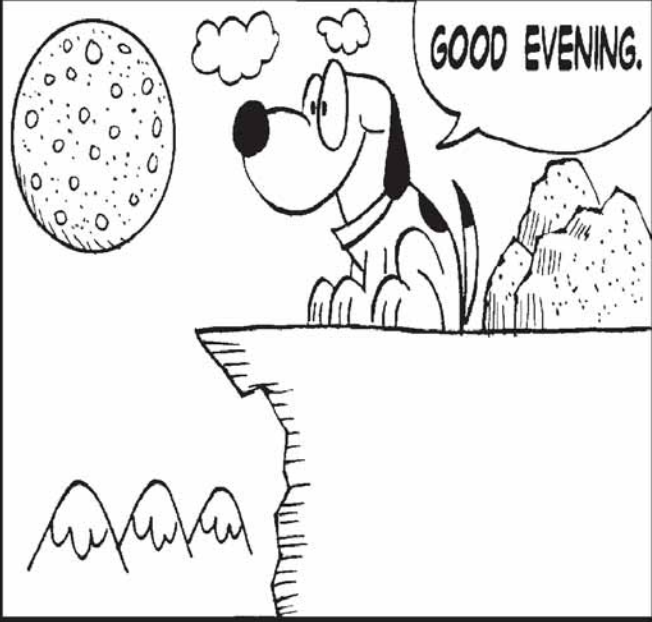

'Steer It, Clear It' law keeps drivers, first responders safe after a crash

The Wisconsin Department of Transportation is asking drivers to take simple steps that will provide the safest conditions for everyone on the roads after a crash.

Wisconsin State Patrol's November Law of the Month is a reminder of the state's "Steer It, Clear It" law. The law requires drivers to move vehicles involved in a crash out of traffic if no one is hurt and the vehicles can be moved safely. If someone is hurt or the vehicle is disabled, drivers should not risk injury by trying to push the vehicle out of traffic.

This simple action, moving out of the lane of traffic, provides safer conditions for law enforcement and other responders. It also helps crews more easily clear vehicles, crash debris, spilled materials, and other obstructions from the road.

"Our officers and first responders put themselves at risk to help those who get into trouble on the highways. If you find yourself in a crash, help us keep everyone safe and move out of the path of traffic," Superintendent Anthony Burrell said.

Across Wisconsin, there were 115,694 crashes in 2020. 703 were secondary crashes, happening after an initial incident. Secondary crashes put those involved and the responders who show up to help in danger. Last year, 69 workers were hurt and two were killed while responding to an emergency in Wisconsin.

This month, WisDOT is also marking Crash Responder Safety Week from November 8-14, 2021. The initiative highlights the crucial role of first responders and the importance of protecting them on the roads by moving over and slowing down to keep them safe while they work. More information on Wisconsin's Move Over law is available here.

Drivers involved in a crash should do the following:

1. Check for injuries. Call 911 if anyone is hurt. Provide accurate information about the location of the incident, severity of injuries, and number of lanes blocked.
2. Stay safe and calm. Watch for traffic, stay inside the vehicle with a seat belt on while waiting for help.
3. If you can steer it, clear it. Move out of traffic if the vehicle is not disabled.
4. Turn hazard lights on or raise the hood of the vehicle to warn other drivers of the incident and avoid secondary crashes.

"Steer It, Clear It" became law in Wisconsin in 1998 and grants immunity from civil damages to anyone who clears the crash scene at the direction of law enforcement.

Drivers should also be aware of what to do when an emergency vehicle approaches on the roads. State law requires drivers to yield the right of way and pull over when an authorized emergency vehicle has its lights or sirens activated. Stay parallel to the right curb or right edge of the shoulder, clear of any intersection, until the emergency crews pass through the area.

Duke spoke no English but was thrown into a new environment in Winnetka Public Schools. After graduating from New Trier High School and then Knox College, Duke began a 55 year career in the investment business. He started with Hornblower & Weeks in Chicago, then spent the last 37 years of his career at William Blair & Co. as an investment advisor, rising to become a partner.

Duke was active in the Captive-Nations Committee efforts to free his native country from totalitarian Soviet rule during the Cold War. After the fall of communism in 1989, Duke returned to the newly-freed Prague. Inspired by that visit he took an active role in fostering close relations between America and Czechoslovakia. He was asked in 2003 to become Chairman of the Prague-Chicago Sister Cities organization and served as Chairman for 15 years. Fall back safely as daylight saving time ends

MADISON, Wis. – Fall has fully arrived in Wisconsin and with it comes the end of daylight saving time. As you change the clocks back an hour this weekend, ReadyWisconsin encourages you to use some of your extra time to check the carbon monoxide detectors and smoke alarms in your home, while also making sure your home emergency kit is ready for the upcoming winter. Daylight saving time ends Sunday, Nov. 7 at 2 a.m.

“Carbon monoxide detectors and smoke alarms provide a critical early warning to a potentially life-threatening situations in your home,” said Wisconsin Emergency Management Acting Administrator Greg Engle. “Spending just a few minutes this weekend to make sure those devices are working properly and have fresh batteries could end up saving the life of you and your loved ones.”

As the winter months approach, carbon monoxide detectors are an especially critical tool to have in your home. According to the Wisconsin Department of Health Services, Wisconsin averaged 20 deaths each year between 2015-19 due to carbon monoxide poisoning. In 2020, the state reported 321 emergency department visits and 28 hospitalizations due to carbon monoxide poisoning.

Carbon monoxide detectors can help your family know they need to leave and get to safety if a furnace or other device leaks this deadly gas inside your home. The batteries in them should be changed annually, while the devices should be tested monthly and replaced completely every five years.

Smoke alarms are also a critical early warning tool that can help alert you to a fire in your home. According to the National Fire Protection Association, three out of every five home fire deaths occurred when smoke detectors were either not present or were not working properly. Smoke alarms should be tested monthly and the batteries should be replaced at least once a year. The device itself should be replaced every 10 years.

If you have an emergency kit at home, this weekend is also a great time to check for expired products or items that may have been borrowed for other purposes and need to be replaced. Pay attention in particular to the expiration dates on batteries, first aid supplies and food.

“Having a well-stocked kit is important, in the event you lose power or are unable to leave home during a winter storm,” Engle said.

Staff advised that the vial was obtained by the 8-year-old child during the Wabeno Elementary School's Trunk or Treat. The vial was identified by markings XN-L Check, which the manufacturer Sysmex Nordic advised was a synthetic blood used to test XN-Series hematology system's. This substance is to be considered a Biohazard and is not supposed to leave a medical laboratory setting.

proof are a GoWild conservation card, an authenticated driver's license, and printed or digital copies of your documents.

You must have the unique harvest authorization number to register your deer. All deer must be registered by 5 p.m. the day after the deer is recovered. This may be done by phone, from a computer or other mobile device, or at one of several hundred businesses that still act as registration stations. If you choose this last option, the business will let you use a smartphone or computer to register your deer.

Again this season, CWD sampling will be available to all hunters through a combination of in-person, self-service and on-request sampling locations. Exact sampling locations are listed on the DNR website. This year, the DNR will increase its sampling effort in northern and northeastern Wisconsin as part of a multi-year statewide rotation. Sampling will also continue around wild and farm-raised positive CWD detections.

Baiting and feeding of deer is prohibited in all counties where a CWD positive wild or farm-raised deer was found and in counties within 10 miles of a wild or farm-raised CWD positive deer in an adjacent county. Baiting and feeding bans will renew with each new wild or captive positive CWD or tuberculosis result. Bans expire if 36 months have passed since any confirmed positive test for either disease within the county, and if 24 months have passed since any confirmed positives within a 10-mile radius of the county.

This list is updated regularly, so hunters are advised to check the DNR website.

Thanks to a mild winter last year and below-average harvests over the last two years, there should be more opportunities to harvest deer throughout most areas of Wisconsin this year. Although more deer will be shot on private land, Wisconsin's seven million acres of combined public land types offer hunters a great variety of habitats and good to excellent hunting. There are no buck-only units this season, and all units offer at least some antlerless deer hunting opportunities, although bonus antlerless tags for public lands in most northern and central forest zone counties will be sold out before gun season.

Hunters should find excellent hunting opportunities in the state's farmland units, although deer abundance varies greatly depending on habitat. Those hunting farmland units should be especially familiar with property boundaries to avoid trespassing and to ensure that they have the appropriate tags for the area they are hunting. Many farmland units have multiple antlerless harvest authorizations included with each deer hunting license and offer an antlerless-only holiday hunt.

Northern District

Northern Wisconsin provides a wide range of deer hunting experiences. Hunters may choose to use treestands in small forest lots surrounded by farmland or stillhunt large blocks of remote woods.

Many areas of the north did not have deep snow all winter and saw only a few days of bitter cold weather. Despite enough snow and cold in the snow-belt counties of Iron, Ashland, Bayfield, and Douglas to kick them into the moderate severity category, overall the winter was a reprieve from the previous two harsher winters.

Most of the northern units had an increase in buck kill last year from 2019, and the mild winter and warm, early spring set the stage for good fawn production. Scouting will help hunters locate productive habitat and avoid surprises come opening morning. Thanks to the severe windstorms of 2019, there are still a lot of downed and damaged trees in some areas that can make moving through the woods difficult and even dangerous in some areas.

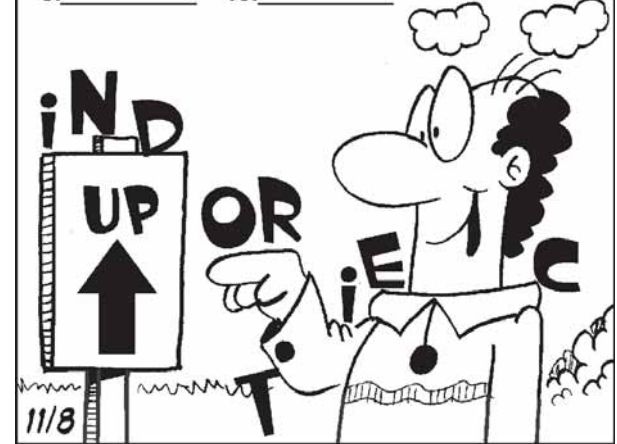

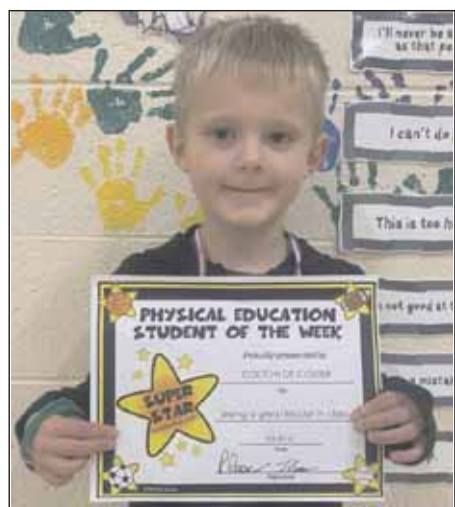
