1,439 cases of covid-19 (19 active) confirmed in forest county

Forest County Public Health officials have confirmed 17 persons have been diagnosed with novel coronavirus infection (COVID-19) in November as of November 1st, for a total of 1,439 cases in Forest County. County health officials and local partners are contacting others with whom the individuals who tested positive had close contact with. As of Monday, November 1st, Forest County has 6,392 negative test results. There are currently 19 active cases in isolation, 1,389 released from isolation, 3 hospitalized, and 28 deaths related to COVID-19. This is a snapshot of numbers, but they are continuously changing throughout the day. If you are experiencing any symptoms or have been exposed to someone with COVID-19, please contact your health care provider and ask to be tested. If you are interested in a COVID-19 vaccine, please call our office or your primary care provider. In an effort to keep our community members up to date on COVID-19, the Forest County Health Department will continue to update our Facebook page and local newspapers every two weeks with current COVID-19 case counts. This will include the number of negative and positive cases in Forest County. Please call our office at 715-478-3371 with any questions or concerns.

You probably don't think about it when you unwrap a cough drop and pop it in your mouth, but people in the paper industry have given that wrapper a great deal of thought. It's an example of what the industry calls a specialty paper – a paper developed for a specific purpose and to exacting specifications. In this case, the papermakers have built in a special property called "twistiness" that helps it stay tightly around the cough drop once a machine wraps it. The paper is also specially coated to preserve freshness and to avoid sticking to the cough drop when it is unwrapped by the consumer.

This cough drop paper is just one of thousands of unique paper products made in Wisconsin. Rather than making commodity papers such as newsprint (none is made in Wisconsin), mills create a variety of paper for different applications and converters modify that paper in myriad ways for myriad end uses.

Understanding the future of Wisconsin's paper industry requires some understanding of specialty papers because, unlike the shrinking markets in some commodity papers, the industry sees growth opportunities in specialty applications, particularly where paper may supplant plastic. Consumers are looking for sustainable products and paper increasingly is seen as a more sustainable alternative. Improvements in coating technology, for example, are opening opportunities in paper-based food packaging to replace plastic.

While specialty papers are frequently pointed to as a sustaining force in Wisconsin's paper industry, the term specialty paper is not well-defined even within the industry. Nevertheless, manufacturers and converters provided some examples of Wisconsin specialty grades to illustrate this important sector.

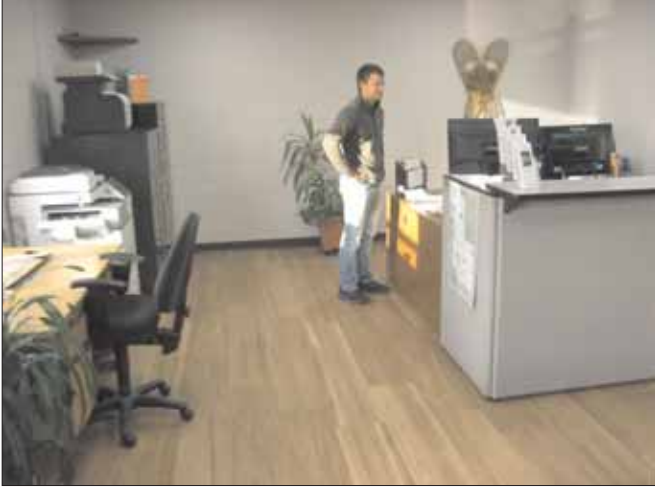

The DNR deer donation program

The Wisconsin Department of Natural Resources (DNR) encourages hunters to donate Wisconsin-harvested deer to the department's Deer Donation Program to help stock food pantries this holiday season and support residents in need throughout the state.

Since the program began in 2000, hunters have donated over 94,000 deer, totaling more than 3.8 million pounds of venison distributed to Wisconsin food pantries.

Through the Deer Donation Program, the DNR works with partnering meat processors to distribute thousands of pounds of donated venison to Wisconsin food pantries.

"Whether by harvesting an extra deer or donating the only deer they shoot, Wisconsin hunters have the chance to support their communities during the holiday season," said Sarah Wyrick, DNR Wildlife Damage Program Assistant. "We thank all deer hunters, meat processing and nonprofit partners who help make this program a success for those in need."

Those looking to support the Deer Donation Program can also do so through a monetary donation when purchasing a hunting or fishing license or a Wisconsin State Park pass.

Food Insecurity In Wisconsin

Approximately one in 12 Wisconsin households did not have enough food before the COVID-19 pandemic began in early 2020, and research shows this number continues to rise, according to the University of Wisconsin's Food Security Project.

Additionally, the Wisconsin Food Security Projects reports that food insecurity makes it harder for children to thrive in and out of school, increases the risk of health problems for children and adults, makes it more difficult to manage chronic conditions, and contributes to short-term and long-term stress for children and families.

How To Donate Wisconsin-Harvested Deer

Hunters interested in donating a Wisconsin-harvested deer to the DNR's Deer Donation Program can follow these steps:

1. Field dress your deer. Handle the carcass with care.
2. Register your deer through Game Reg. Make a note of your registration confirmation number and keep it on hand when dropping off your deer.
3. Test your deer for CWD if harvested from a CWD-affected county that requires testing before taking the deer to a processor. To find a CWD sampling location near you to submit samples from Wisconsin-harvested deer free of charge, visit the DNR's "Sampling For Chronic Wasting Disease" webpage. Test results are usually available from the DNR within two weeks.
4. Call ahead! Contact one of the participating processors before dropping off your deer to make sure they have space to accept it. More processors may be added later in the season, so check back if you don't see one currently in your area.
5. Drop off your deer at a participating processor.

Use Caution on Pickerel, Little Pickerel, & Smoke Lakes this winter

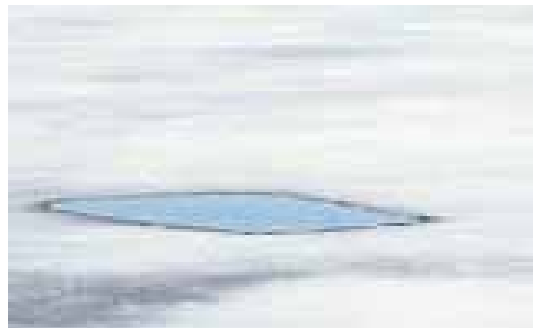
The Pickerel Chain Lake Association will again be operating aeration systems this coming winter season on Pickerel, Little Pickerel, and Smoke Lakes, all located just north of Townsend in Oconto County. Extreme caution should be used on these lakes this winter as the aeration systems will create a large area of open water in each of the lakes.

The Pickerel Chain Lake Association operates and maintains the aerations systems under authority of DNR permits and as a means to help prevent fish kills from occurring on the lakes.

An open water warning system consisting of posts and rope will be placed surrounding each of the open water areas by the lake association after ice on the lakes is considered safe for foot travel. Caution signs warning of the open water areas will also be placed at the Pickerel Lake boat landing and at other locations where fishermen, snowmobilers, and other lake users typically access the lakes.

The Pickerel Lake aerator is located off the north shore and across the lake from the boat landing at Townsend's Oughton Park. The Little Pickerel Lake aerator is located on the north end of that lake, and the Smoke Lake aerator will be located in the northeast quadrant of that lake.

The size of the open water areas created by the aeration will vary depending on wind and temperature, and thin ice conditions can extend out beyond the edges of the open water. The lake association reminds all lake users not to assume the ice is safe at the post and rope warning system location, and to always check ice conditions prior to travel near the aeration systems or elsewhere on the lakes.



Federal COVID-19 vaccine mandate details announced

The federal government today released the details of two COVID-19 vaccine rules.

The rule from the Department of Labor's Occupational Safety and Health Administration (OSHA) applies to employers with 100 or more employees. A rule from the Centers for Medicare & Medicaid Services (CMS) applies to all health care workers at facilities participating in Medicare and Medicaid.

Businesses impacted by the new OSHA rules will be required to ensure each of their workers is fully vaccinated or begins testing on a weekly basis by January 4, 2022. There are additional requirements in the rule related to reporting, record keeping and masking.

The CMS rule that applies to health care organizations across the country requires health care workers to be fully vaccinated against COVID-19 by January 4, 2022, with very limited exemptions.

Aspirus Health has been preparing for months for the CMS mandate and will comply. Health care organizations that do not comply risk losing Medicare and Medicaid reimbursement from the government.

Aspirus Health has had a robust COVID-19 vaccination, education and testing program in place for several months and has encouraged vaccination for its employees and community members since the vaccines became available. COVID-19 vaccinations and booster doses are widely available to Aspirus employees and community members.

Anyone interested in receiving a first, second, third or booster dose through Aspirus can schedule appointments via the MyAspirus mobile app or the online patient portal at myaspirus.org. Appointments also can be made at Aspirus locations throughout Wisconsin and Michigan's Upper Peninsula by calling 1-844-568-0707 or 715-843-1454.

Large-scale emergency training exercise at Nicolet College

In an emergency, several professions often must work together quickly and efficiently in order to provide the services necessary to ensure the safety and positive outcome for all involved.

That was the goal of a recent real-world simulation exercise at Nicolet College and funded by the Wisconsin Northern Highland Area Health Education Center that brought together students from the Law Enforcement, Emergency Medical Services, and Nursing programs along with representatives from the Human Services field.

"These students don't really get to interact that much when they are on campus, so we wanted to create an exercise where they all had to work together in a professional capacity," said Nicolet Nursing Instructor Dilya St. Louis, who led the coordination of the simulation.

"After these students graduate and start their careers, it will be common for them to work with others from different professions. We wanted to give them that experience, to interact with each other and for all of them to practice the specialized skills they've learned in Nicolet labs and classrooms."

The first-of-its-kind training scenario for the college started with a staged 911 call to alert authorities of a man acting strangely out in the Field on campus.

Law Enforcement students responded to the scene to assess the situation, make initial contact with the individual in distress, and to ensure conditions were safe and secure for EMS students to arrive on-scene.

But there was a twist.

Nicolet Law Enforcement student Jeremy Irish was first to arrive.

"When I got on there and walked up to him, I could see the individual had a knife, which really surprised me," Irish said. "I wasn't prepared for that."

But then his Nicolet training kicked in and he was able to deescalate the situation and make it safe for EMS students to practice their skills.

Determining the individual was suicidal and highly intoxicated on alcohol and prescription drugs, the EMS students decided he needed a higher level of care. After stabilizing the now patient, they transported him by ambulance to "Nicolet Hospital," otherwise known as the Nursing Lab.

Once there, Nicolet Nursing students took over providing care. The simulation ended after substance abuse crisis professionals did their evaluation and determined a long-term care plan.

"At each stage of care the students from one academic program had to coordinate and communicate with students from a different program each time the patient went to the next stage of the scenario," St. Louis said.

"Over the years we've noticed that while the students have solid technical skills, there can be a skills gap in effective communication with others. We wanted to put them in a situation where they had to communicate with people outside of their profession, and I have to say they all did great. It got them out of their comfort zone and they learned new skills."

The drill also gave students the opportunity to gain experience treating a suicidal individual.

"Dealing with people with mental illness is very challenging and students commonly receive little if any training in this area," said St. Louis, who previously worked as an emergency room nurse in Rhinelander.

"Almost daily we had someone who was suicidal in the emergency room. It's much more common than many people think. It's a real problem and something that these students are going to have to respond to and deal with."

Law Enforcement student Irish said the multi-disciplinary aspect of the simulation was a "great" learning experience.

"It was the first time that I've had a scenario that we were able to bring in all the different parties here at Nicolet College," said Irish. "They really made it seem like we were all responding to a real emergency, which was invaluable."

According to Gail Kell, the executive director of Wisconsin Northern Highland Area Health Education Center, the organization is working on plans to fund another simulation in the spring of 2021.

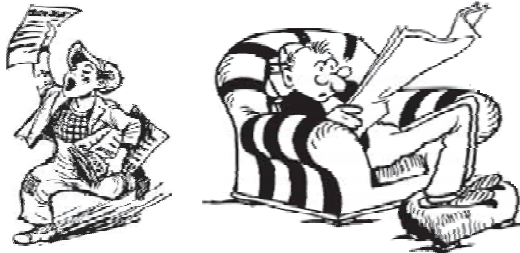

Baldwin urges tax relief for the auto industry

WASHINGTON, D.C. - U.S. Senator Tammy Baldwin has joined a group of her colleagues in a letter to U.S. Department of Treasury Secretary Janet Yellen, urging her to provide tax relief to auto dealers experiencing inventory shortages due to global supply chain issues. Pandemic-related supply chain disruptions have impacted businesses and consumers, with slow-downs and factory closures, particularly with semiconductors, leaving businesses with drastically lower inventories. These disruptions could leave auto dealers in Wisconsin and across the country with unexpected tax liability if not addressed.

"The pandemic and related supply chain interruptions have hit the auto industry particularly hard. Making matters worse, many businesses that use the last in, first-out (LIFO) inventory method will face significant unforeseen tax liabilities due to their inability to replace vehicle inventory. There has been a major disruption of the global supply chain with slow-downs and factory closures, particularly with semiconductors, leaving businesses with drastically lower inventories. We are writing to ask for your assistance to grant temporary LIFO relief to businesses that have severe inventory shortages because of the pandemic," wrote the senators.

Felzkowski Bill on School Spending Transparency Signed Into Law

Governor Evers will be signing SB 373, authored by Sen. Felzkowski (R-Tomahawk), into law. This bill will provide Wisconsin with access to information and details regarding how their school district is spending their taxpayer dollars.

"I am thrilled that this bill is being signed into law today. Over the last several years, I have worked with stakeholders throughout the education community to forge a consensus on making school district spending information accessible to the public. I want to thank my partners, Senator Darling, Representative Magnafici, and Representative Wittke for all their hard work on this."

The aim of this legislation is to make it easier for the public to track exactly how their school district is spending the funding they receive. The end will be an easy-to-access school expenditure portal that the Department of Public Instruction shall maintain on their website. Any member of the public, parent, or teacher can look up their school district and see what funding their school is receiving and where the money is going. This bill will create an advisory committee comprised of individuals selected by the Governor, Assembly, and Senate who will make recommendations on categories DPI must include in the school expenditure portal.

"At its core- our bill is about transparency and access, and about every taxpayer, parent, teacher, reporter, and school board member who has at one point or another found our school funding data difficult to comprehend. Every member of the public should have the opportunity for an informed discussion about school spending with their school's leadership."

SB 373 will be signed into law as 2021 Act 89.

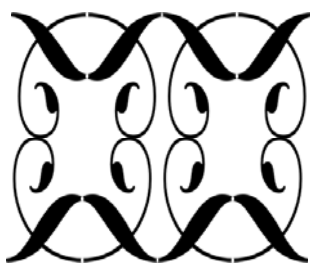

Large-scale emergency training exercise at Nicolet College

In an emergency, several professions often must work together quickly and efficiently in order to provide the services necessary to ensure the safety and positive outcome for all involved.

That was the goal of a recent real-world simulation exercise at Nicolet College and funded by the Wisconsin Northern Highland Area Health Education Center that brought together students from the Law Enforcement, Emergency Medical Services, and Nursing programs along with representatives from the Human Services field.

"These students don't really get to interact that much when they are on campus, so we wanted to create an exercise where they all had to work together in a professional capacity," said Nicolet Nursing Instructor Dilya St. Louis, who led the coordination of the simulation.

"After these students graduate and start their careers, it will be common for them to work with others from different professions. We wanted to give them that experience, to interact with each other and for all of them to practice the specialized skills they've learned in Nicolet labs and classrooms."

The first-of-its-kind training scenario for the college started with a staged 911 call to alert authorities of a man acting strangely out in the Field on campus.

Law Enforcement students responded to the scene to assess the situation, make initial contact with the individual in distress, and to ensure conditions were safe and secure for EMS students to arrive on-scene.

But there was a twist.

Nicolet Law Enforcement student Jeremy Irish was first to arrive.

"When I got on there and walked up to him, I could see the individual had a knife, which really surprised me," Irish said. "I wasn't prepared for that."

But then his Nicolet training kicked in and he was able to deescalate the situation and make it safe for EMS students to practice their skills.

Determining the individual was suicidal and highly intoxicated on alcohol and prescription drugs, the EMS students decided he needed a higher level of care. After stabilizing the now patient, they transported him by ambulance to "Nicolet Hospital," otherwise known as the Nursing Lab.

Once there, Nicolet Nursing students took over providing care. The simulation ended after substance abuse crisis professionals did their evaluation and determined a long-term care plan.

"At each stage of care the students from one academic program had to coordinate and communicate with students from a different program each time the patient went to the next stage of the scenario," St. Louis said.

"Over the years we've noticed that while the students have solid technical skills, there can be a skills gap in effective communication with others. We wanted to put them in a situation where they had to communicate with people outside of their profession, and I have to say they all did great. It got them out of their comfort zone and they learned new skills."

The drill also gave students the opportunity to gain

experience treating a suicidal individual.

"Dealing with people with mental illness is very challenging and students commonly receive little if any training in this area," said St. Louis, who previously worked as an emergency room nurse in Rhinelander.

"Almost daily we had someone who was suicidal in the emergency room. It's much more common than many people think. It's a real problem and something that these students are going to have to respond to and deal with."

Law Enforcement student Irish said the multi-disciplinary aspect of the simulation was a "great" learning experience.

"It was the first time that I've had a scenario that we were able to bring in all the different parties here at Nicolet College," said Irish. "They really made it seem like we were all responding to a real emergency, which was invaluable."

According to Gail Kell, the executive director of Wisconsin Northern Highland Area Health Education Center, the organization is working on plans to fund another simulation in the spring of 2021.

Food papers Ahlstrom-Munksjö, which operates four paper mills in Wisconsin, makes a wide range of specialty papers including food wrapping papers. Its website touts the performance of its "sweets, chocolate and snack wrapping paper":

"High performance twisting, wrapping and folding papers specially developed for sustainable sweets, chocolate and snack packaging... Our Rocalonde™ grades run trouble-free on high-speed twisting machines. They resist the extreme constraints that are exerted and they have supreme twist retention so that sweets always open easily when you want them to – with no annoying rustle!"

Food wrapping paper is a significant chunk of business for Wisconsin paper manufacturers and converters, ranging from paper sleeves (interleaves) between slices of cheese or deli meat, to grease-resistant papers, baking papers and more. Domtar and Verso, like Ahlstrom-Munksjö and others, make a variety of specialty papers aimed at the food wrap market, and converters throughout Wisconsin create thousands of products for different end-uses.

Labels and release liners

Labels are also a big part of Wisconsin specialty paper production. Labels require a face stock, on which the graphics are applied; a release liner, which protects the label adhesive until the label is to be applied to a product; the adhesive; and a top coat to protect the graphics.
