Conservation Corner

In an article I did back in June, I reported the possession limit for most fish species in Wisconsin is three times the daily bag limit. The possession limit is the maximum number of a species that you can control, transport, etc., at any time. It is twice the total daily bag limit.

The Disappearance of Bats in Wisconsin Due to White-Nose Syndrome

Last weekend at a family reunion, I noticed the absence of bats as we sat and reminisced around the fire. Bats, once a common and vital component of Wisconsin's ecosystem, are facing a dire threat: White-Nose Syndrome (WNS). This devastating disease, caused by the fungus *Pseudogymnoascus destructans* (Pd), has been spreading rapidly across North America, including Wisconsin. As the state's bat population declines at an alarming rate, it is crucial to understand the impact of WNS and the measures being taken to mitigate its effects on these invaluable creatures.

White-Nose Syndrome: A Silent Killer

White-Nose Syndrome earned its name from the distinctive white fungal growth that appears on the muzzles and wings of infected bats. It primarily affects hibernating bats during the winter months when they are in a state of torpor in caves and mines. The fungus irritates the bats, causing them to wake up frequently during hibernation. These frequent arousals lead to a rapid depletion of their energy reserves, ultimately resulting in death from starvation or freezing.

First identified in Wisconsin in 2014, WNS has since spread rapidly throughout the state. The disease is thought to have been introduced to North America from Europe, where European bats have developed some resistance to the fungus. Unfortunately, North American bats, including those in Wisconsin, have little to no immunity to this deadly pathogen.

Impact on Wisconsin's Bats and Ecosystem

The impact of WNS on Wisconsin's bat populations has been devastating. The once-thriving bat populations have been decimated, with several species now facing the threat of extinction. Among the most affected species are the little brown bat (*Myotis lucifugus*), the northern long-eared bat (*Myotis septentrionalis*), and the tricolored bat (*Perimyotis subflavus*).

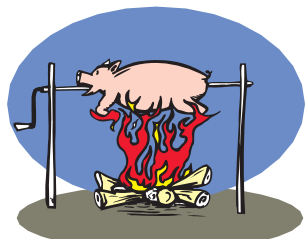

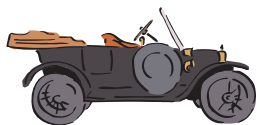

Bats play an essential role in the ecosystem by controlling insect populations, including pests that damage crops. With the significant decline in bat populations, there is a potential for an increase in insect populations, leading to negative consequences for agriculture and the environment.

Research and Conservation Efforts

In response to the alarming decline of bats due to WNS, Wisconsin's wildlife authorities and conservation organizations have initiated several research and conservation efforts.

a. Monitoring and Surveillance: Researchers actively monitor bat populations in caves and mines throughout the state to track the spread of WNS and understand its effects on different bat species.

b. Public Awareness and Education: Public awareness campaigns have been launched to educate communities about the importance of bats and the threats they face. This includes promoting the proper decontamination of clothing and equipment used in caves to prevent the spread of the fungus.

c. Cave Restrictions: Some caves and mines in Wisconsin have been closed to the public to limit the transmission of the fungus from one location to another.

d. Research on Treatment: Scientists are working to find ways to combat the spread of WNS, including researching potential treatments or vaccines that could offer protection to bats.

The disappearance of bats in Wisconsin due to White-Nose Syndrome is a concerning ecological crisis that demands immediate attention. As bat populations continue to decline, the repercussions on Wisconsin's ecosystem and agricultural sector become more apparent.

By promoting public awareness, conducting research, and implementing conservation measures, there is hope for preserving these incredible flying mammals and the invaluable ecological services they provide. Only through a concerted effort by all stakeholders can we hope to mitigate the impact of WNS and secure a brighter future for Wisconsin's bats.

For Old Times Sake

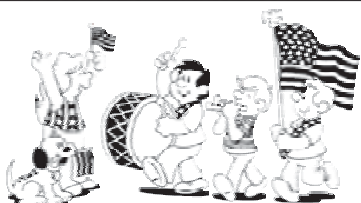


The threshing machine was a big technological breakthrough for farmers. Crops like oats didn't have to be harvested slowly by hand. The grain went in one place and the straw in another.

No Suntan is a Safe Tan

A little sunlight is good for you. Your body uses it to make vitamin D, which keeps bones strong. But it doesn't take long for the sun's ultraviolet (UV) rays to start causing damage. That damage can lead to premature wrinkles, age spots and even skin cancer, the most common type of cancer in the United States.

"Many people go into summer with the goal of getting a suntan, not realizing how incredibly damaging it is to their skin," says Nikole Larkin, Nurse Practitioner at Aspirus Plastic Surgery & Aesthetics. "In fact, there's no such thing as a safe tan and we should be doing what we can to protect our skin from getting one."

According to the U.S. Food and Drug Administration (FDA), when the sun's UV rays beat down, your skin tries to protect itself by kicking production of a pigment called melanin into high gear. The added melanin provides a sun protection factor (SPF) of about 2 to 4—far below the minimum 30 SPF that the American Cancer Society (ACS) recommends for sun protection. It's the added melanin that causes your skin to darken and that tan signals that you were out in the sun too long.

Reduce sun exposure and skin cancer risk with these top tips from the ACS and the American Academy of Dermatology (AAD):
SEEK SHADE

Don't stay out in direct sunlight for too long. The sun's rays are strongest between 10 a.m. and 4 p.m. That's the time to stay in the shade. A good rule of thumb: If your shadow is shorter than you are, seek shade.
PUT ON A HAT

A hat with a 2- to 3-inch brim all around is a good choice, as is a shade cap (a baseball cap with fabric down the sides and back). Baseball caps and straw hats offer less protection.
WEAR SUNGLASSES

Melanoma can develop in the eyes, so choose glasses that block 99% to 100% of UV rays and wear them every day. Darker glasses don't necessarily mean more protection—check the label to be sure.
WEAR PROTECTIVE CLOTHING

Cover as much of your skin as possible. Dark colors and tightly woven fabrics offer the most protection. To get an idea of how protective clothing is, hold it up to bright light. If light comes through, the sun's rays can get through too.
USE SUNSCREEN

Choose a broad-spectrum, water-resistant sunscreen with a sun protection factor (SPF) of 30 or more. Apply it generously to all exposed skin before you go outside. Reapply at least every 2 hours and after swimming or sweating. You should follow these rules even when it's cloudy.

USE LIP BALM

Protect your lips by wearing lip balm that contains sunscreen.

"Taking extra precautions now can give long-term benefits down the road, such as maintaining a more youthful appearance and decreasing your risk of skin cancers," says Larkin.

2023 Wolf Management Plan is now available

PLAN WILL BE PRESENTED TO NRB IN OCTOBER

MADISON, Wis. – The Wisconsin Department of Natural Resources (DNR) today released a revised draft of the 2023 Wolf Management Plan. The plan will go to the Natural Resource Board (NRB) during their meeting on Oct. 25, 2023.

The DNR began developing this updated draft plan in early 2021 to align its wolf management strategies with the current state of the wolf population and the desires of a diverse public. The DNR recognizes the biologically recovered status of wolves in Wisconsin, and this plan turns its attention from wolf recovery to long-term stewardship and sustainable management of wolves in the state.

The draft plan aims to guide the department's management efforts for the coming years and expresses the state's dual commitments of maintaining a sustainable and ecologically functional wolf population while also being responsive in addressing wolf-related conflicts and concerns. Both commitments are explicitly represented in the plan's overarching goal:

Ensure a healthy and sustainable wolf population that fulfills the numerous ecological, cultural, and recreational benefits of wolves, while being responsive in addressing and preventing wolf-related conflicts and recognizing the diverse values and perspectives of all residents in Wisconsin.

Extensive public input was collected and considered when developing this draft plan. Prior to releasing the first draft plan in November 2022, the DNR created and collaborated with a Wolf Management Plan Committee consisting of 29 stakeholder, tribal and external agency representatives. The DNR also consulted with Wisconsin's Tribal Nations and the Great Lakes Indian Fish and Wildlife Commission (GLIFWC), reviewed scientific literature and studied current public attitudes toward wolves in Wisconsin. Then, the DNR held a 3.5-month public review and comment period where over 3,500 comments were collected. All comments were reviewed and considered in revising the draft 2023 Wolf Management Plan.

"The public's interest and passion towards wolves and wolf management showed in the comments the DNR received," said DNR Secretary Adam N. Payne. "This plan comes from years of dedicated effort and careful consideration, is flexible, actionable, and, most importantly, outlines a path toward responsible and sustainable wolf management. I am thankful to everyone who contributed, reviewed the plan or submitted a comment."

How Does The Revised Draft Plan Compare To November's Draft Plan?

Many parts of November's initial draft plan received predominately positive feedback. Based on this feedback, the revised draft plan retains strong commitments to maintaining a healthy wolf population in the state, being responsive in assisting those who are negatively affected by interactions with wolves and relying on scientific research and data to inform management decisions. The revised version also maintains an emphasis on ongoing wolf population monitoring and collaboration with other agencies, Tribal Nations, stakeholder groups and the public. Additionally, the revised draft plan continues to recognize the ecological benefits and cultural importance of wolves to the people of Wisconsin.

Based on the public's feedback, the revised draft maintains its recommendations intended to improve wolf harvest season implementation, such as a shortened harvest registration time and issuing zone-specific licenses. It also better describes how future wolf harvest quotas are recommended to be developed and allocated across management zones. This revision also preserved the updated wolf management zones and subzones, with one boundary modification made.

Other aspects of November's draft plan have been strengthened in the revised draft plan through the public's feedback. A common area of concern centered around expectations and uncertainty of future wolf population sizes when there is no numeric population goal. The plan continues to recommend an adaptive management framework instead of a numeric population goal. However, the updated plan provides greater clarity on a projected population range based on the current management objectives. The revised draft plan also discusses how under this plan, natural wolf population dynamics and future wolf harvest levels are expected to maintain statewide wolf abundance at levels comparable to recent years (overwinter estimates of approximately 800 to 1,200 wolves), while also allowing for fluctuations in local wolf densities as necessary to achieve management objectives.

Other additions in the revised draft plan are intended to strengthen transparency and clarify misconceptions evident in the comments, including the clearer goal statement (reflected above), an improved executive summary to provide a concise description of the plan's vision and actions, and more specific metrics developed to help gauge the success of management actions.

A draft copy of the full revised 2023 Wolf Management Plan is available on the DNR's Wolf Management Plan webpage. The DNR recommends that the public read the executive summary for a more concise overview of the revised draft plan before reading the rest of the plan.

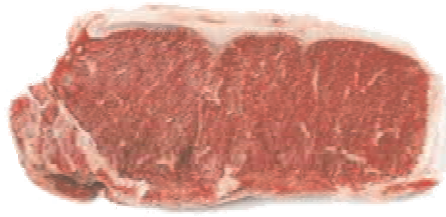

DNR asks public for help doing surveys of deer and game birds

MADISON, Wis. – The Wisconsin Department of Natural Resources (DNR) is seeking the public's help in collecting crucial deer and game bird management data. The data will be collected starting Aug. 1 through the Operation Deer Watch Survey and the Game Bird Brood Observations Survey.

These surveys are designed to measure the reproductive status of deer and game birds. Data from public observations is used to collect crucial deer and game bird management data, including a fawn-to-doe ratio for deer and a poult-to-hen ratio for game birds. These ratios are then compared to data from previous years to estimate how productive this year's deer herd/game birds are.

"Whenever you are out and about in Wisconsin, you can share observations of deer and game birds through the Survey123 submission tool," said Jes Rees Lohr, Assistant DNR Surveys Coordinator. "Every submission increases our dataset and helps Wisconsin have a clearer picture of how wildlife is doing. Everyone interested in wildlife, from hunters and trappers to outdoor enthusiasts, is encouraged to participate. It's an easy way to be involved in wildlife management in our state."

The deadline to submit bird observations for the Game Bird Brood Survey is Aug. 31. The deadline to submit deer observations for the Operation Deer Watch Survey is Sept. 30.

Participation in both surveys is simple. It doesn't require registration and can be done using a mobile device. If in a vehicle, participants should only record sightings when their vehicle is stopped, not while driving.

For Operation Deer Watch, the public should report the location, deer type (buck, doe or fawn) and the number of deer seen. This information helps to determine the fawn-to-doe ratio and, ultimately, deer population estimates. More information is available on the Operation Deer Watch webpage.

For Game Bird Brood Observations, the DNR needs to know the bird species (turkey, ruffed grouse or pheasant), the type (adult or poult) and the number observed of each type. This information is a basis for monitoring the reproduction of game birds for that breeding year. More information is available on the Game Bird Brood Observations webpage.

ACCESS TO PUBLIC RECORDS

The Board of the School District of Wabeno Area shall allow persons to have access to school district records in accordance with this policy and implementing procedures and in accordance with the law.

The District Administrator is designated as the legal custodian of records. The legal custodian shall safely keep and preserve records of the authority and shall have full legal power to render decisions and carry out duties related to those records maintained by any school district authority. The legal custodian may deny access to records only in accordance with the law.

Public records may be inspected, copied and/or abstracted at any time during the established District Office hours, which are from 8:00 A.M. to 4:00 P.M., Monday through Friday. The legal custodian may establish fees for services in accordance with the law. A list of fees is available at the District Office.

STUDENT RECORDS

Student records are maintained to assist students, parents, guardians, and the school in achieving the student's educational goals. Such records are accumulated, maintained, released, transferred, and eventually destroyed by the building principal or his/her designee in accordance with state and federal law. Only those individuals or agencies specifically authorized by state and federal law shall be granted access to a student's records.

The School District does forward records to other schools that have requested the records and in which the student seeks or intends to enroll, or is already enrolled, as long as the disclosure is for purposes related to the student's enrollment or transfer.

An adult student or the parent/guardian of a minor student may inspect the student's records in accordance with administrative policy and established procedures and may challenge the content if he/she believes the records are inaccurate or misleading. Such a complaint would be filed with the building principal. If not satisfied with the decision, an appeal avenue is available through the Family Policy and Regulations Office of the U.S. Department of Education.

TEACHER LICENCE

Federal law requires that we share with you the qualifications of the teachers in the School District of Wabeno Area. SCHOOL DISTRICT OF WABENO AREA CONFIDENTIALITY OF PERSONALLY IDENTIFIABLE INFORMATION OBTAINED THROUGH CHILD FIND ACTIVITIES

The process of locating, identifying, and evaluating children with disabilities is known as Child Find. This agency conducts the following child find activities each year during Early Childhood Developmental Days. This notice informs parents of the records the school district will develop and maintain as part of its child find activities. This notice also informs parents of their rights regarding any records developed.

The school district gathers personally identifiable information on any child who participates in child find activities. Parents, teachers, and other professionals provide information to the school related to the child's academic performance, behavior, and health. This information is used to determine whether the child needs special education services. Personally identifiable information directly related to a child and maintained by the school is a pupil record. Pupil records include records maintained in any way including, but not limited to, computer storage media, video and audiotape, film, microfilm, and microfiche. Records maintained for personal use by a teacher and not available to others and records available only to persons involved in the psychological treatment of a child are pupil records.

The school district maintains several classes of pupil records

- "Progress records" include grades, courses the child has taken, the child's attendance record, immunization records, required lead screening records, and records of school extra-curricular activities. Progress records must be maintained for at least five years after the child ceases to be enrolled.

- "Behavioral records" include such records as psychological tests, personality evaluations, records of conversations, written statements relating specifically to the pupil's behavior, tests relating specifically to achievement or measurement of ability, physical health records other than immunization and lead screening records, law enforcement officers' records, and other pupil records that are not "progress records." Law enforcement officers' records are maintained separately from other pupil records. Behavioral records may be maintained for no longer than one year after the child graduates or otherwise ceases to be enrolled, unless the parent specifies in writing that the records may be maintained for a longer period of time. The school district informs parents when pupil records are no longer needed to provide special education. At the request of the child's parents, the school district destroys the information that is no longer needed.

- "Directory data" includes the student's name, address, telephone listing, date and place of birth, major field of study, participation in officially recognized activities and sports, weight and height of members of athletic teams, dates of attendance, photographs, degrees and awards received, and the name of the school most recently attended by the student.

- "Pupil physical health records" include basic health information about a pupil, including the pupil's immunization records, an emergency medical card, a log of first aid and medicine administered to the pupil, an athletic permit card, a record concerning the pupil's ability to participate in an education program, any required lead screening records, the results of any routine screening test, such as for hearing, vision or scoliosis, and any follow-up to the test, and any other basic health information, as determined by the state superintendent. Any pupil record relating to a pupil's physical health that is not a pupil physical health record is treated as a patient health care record under sections 146.81 to 146.84, Wisconsin Statutes. Any pupil record concerning HIV testing is treated as provided under section 252.15, Wisconsin Statutes.

The Family Educational Rights and Privacy Act (FERPA), the Individuals with Disabilities Education Act (IDEA), and section 118.125, Wisconsin Statutes, afford parents and students over 18 years of age ("eligible students") the following rights with respect to education records:

The right to inspect and review the student's education records within 45 days of receipt of the request.

Parents or eligible students should submit to the school principal [or appropriate school official] a written request that identifies the records(s) they wish to inspect. The principal will make arrangements for access and notify the parent or eligible student of the time and place where the records may be inspected. The school district will comply with the request without unnecessary delay and before any meeting about an individualized education program, or any due process hearing, and in no case more than 45 days after the request has been made. If any record includes information on more than one child, the parents of those children have the right to inspect and review only the information about their child or to be informed of that specific information. Upon request, the school district will give a parent or eligible student a copy of the progress records and a copy of the behavioral records. Upon request, the school district will give the parent or eligible student a list of the types and locations of education records collected, maintained, or used by the district for special education. The school district will respond to reasonable requests for explanations and interpretations of the records. A representative of the parent may inspect and review the records.

-The right to request the amendment of the student's education records that the parent or eligible student believes is inaccurate or misleading.

Parents or eligible students may ask the School District of Wabeno Area to amend a record that they believe is inaccurate or misleading. They should write the school principal, clearly identify the part of the record they want changed, and specify why it is inaccurate or misleading. If the district decides not to amend the record, the district will notify the parent or eligible student of the decision and the right to a hearing regarding the request for amendment. Additional information regarding the hearing procedures will be provided to the parent or eligible student when notified of the right to a hearing.

-The right to consent to disclosures of personally identifiable information in the student's education records, except to the extent that federal and state law authorize disclosure without consent. The exceptions are stated in 34 CFR 99.31, Family Educational Rights and Privacy Act regulations; Sec. 9528, PL107-110, Every Student Succeeds Act (ESSA); and section 118.125(2)(a) to (m) and sub. (2m), Wisconsin Statutes. One exception that permits disclosure without consent is disclosures to school officials with legitimate educational interests. A school official is a person employed by the district as an administrator, supervisor, instructor, or support staff member (including health or medical staff and law enforcement unit personnel); a person serving on the school board; a person or company with whom the district has contracted to perform a special task (such as an attorney, auditor, medical consultant, or therapist); or a parent or student serving on an official committee, such as a disciplinary or grievance committee, or assisting another school official in performing his or her tasks. A school official has a legitimate educational interest if the official needs to review an education record in order to fulfill his or her professional responsibility. Upon request, the district discloses education records without consent to officials of another school district in which a student seeks or intends to enroll. Also the district discloses "directory data" without consent, unless the parent notifies the district that it may not be released without prior parental consent.

The McKinney-Vento Act defines children and youth who are homeless (twenty-one years of age and younger) as:

- Children and youth who lack a fixed, regular, and adequate nighttime residence, and includes children and youth who are:
 - sharing the housing of other persons due to loss of housing, economic hardship, or a similar reason (sometimes referred to as double-up);
 - living in motels, hotels, trailer parks, or camping grounds due to lack of alternative adequate accommodations;
 - living emergency or transitional shelters;
 - abandoned in hospitals;
 - awaiting foster care placement;
- Children and youth who have a primary nighttime residence that is a public or private place not designated for, or ordinarily used as, a regular sleeping accommodation for human beings.
- Children and youth who are living in cars, parks, public spaces, abandoned buildings, substandard housing, bus or train stations, or similar settings.
- Migratory children who qualify as homeless because they are living in circumstances described above.

- Written explanation of a child or youth's school placement, other than school of origin or the school requested by the parent, with the right to appeal within the local dispute resolution process.
- Meaningful opportunities for parents to participate in the education of their children. These shall include: special notices of events, parent-teacher conferences, newsletters, and access to student records.

SCHOOL DISTRICT OF WABENO AREA ANNUAL NOTICE OF SPECIAL EDUCATION REFERRAL AND EVALUATION PROCEDURES

Upon request, the School District of Wabeno Area is required to evaluate a child for eligibility for special education services. A request for evaluation is known as a referral. When the district receives a referral, the district will appoint an Individualized Education Program (IEP) team to determine if the child has a disability, and if the child needs special education services. The district locates, identifies, and evaluates all children with disabilities who are enrolled by their parents in private (including religious) schools, elementary schools and secondary schools located in the school district.

A physician, nurse, psychologist, social worker, or administrator of a social agency who reasonably believes a child brought to him or her for services is a child with a disability has a legal duty to refer the child, including a homeless child, to the school district in which the child resides. Before referring the child, the person making the referral must inform the child's parent that the referral will be made.

Others, including parents, who reasonably believe a child is a child with a disability, may also refer the child, including a homeless child, to the school district in which the child resides.

Referrals must be in writing and include the reason why the person believes the child is a child with a disability. A referral may be made by contacting Shelly Dotson, Director of Pupil Services, School District of Wabeno Area, at 715.473.5122, ext. 1212, or by writing her at P.O. Box 460, Wabeno, WI 54566.

NOTICE OF SPECIAL NEEDS SCHOLARSHIP PROGRAM

This notice serves to inform parents and guardians of students with disabilities that the State of Wisconsin has established the Special Needs Scholarship Program. Under this scholarship program and as further specified in state law, a child with a disability who has been denied the opportunity to attend a nonresident school district under the full-time open enrollment program may be eligible to receive a scholarship from the Department of Public Instruction (DPI) that allows the child to attend an eligible private school that is participating in the Special Needs Scholarship Program.

This is a state-administered program. A parent or guardian who is interested in the Special Needs Scholarship Program should independently verify the participating private schools and the specific terms, eligibility criteria, and application procedures of the scholarship program with the DPI.

The Special Needs Scholarship Program is further defined under section 115.7915 of the state statutes. However, special eligibility requirements not found in that statute exist for program scholarships that are awarded for private school attendance that initially begins in the 2023-2024 school year. 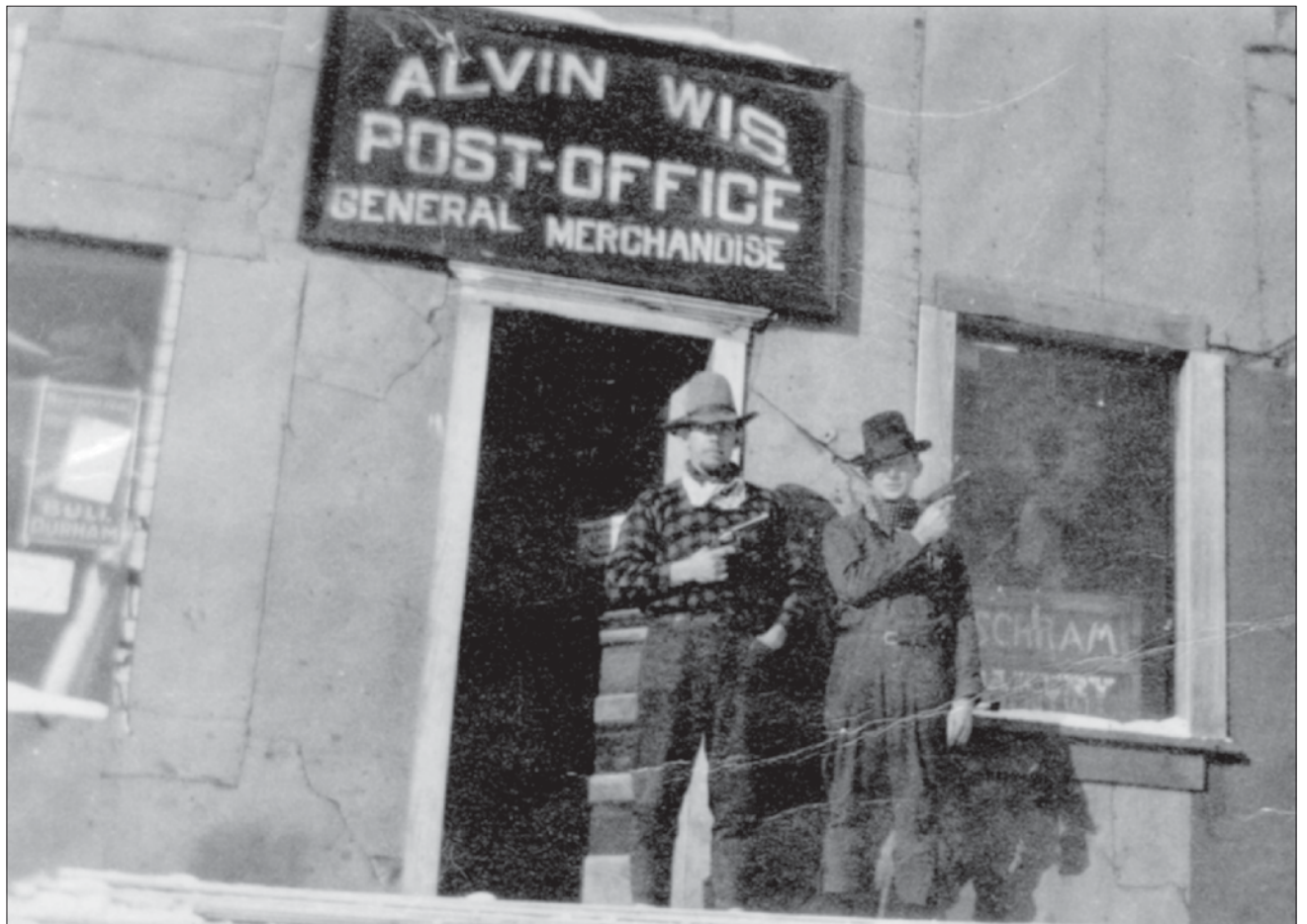
